Madam Speaker, it is with great admiration and gratitude that I recognize Gene Moy on being awarded the Congressional Gold Medal and honor all Chinese American veterans for their distinguished service to our country during World War II.

Ms. HAALAND. Madam Speaker, it is with great pride and deep sadness that I rise to honor my dear friend and former Governor of the Pueblo of Laguna, Roland Johnson. I join his family and our shared Laguna Pueblo community in honoring his memory and life's work, which he always dedicated to helping others.

Throughout his career in public service, Roland led by example, always doing the most to elevate the Laguna Pueblo culture and traditions that he cherished. At age 22, he was elected Secretary of the Pueblo and was the youngest person yet elected to office. In the years that followed, he went on to join the Federal Service, serving the Southwest Bureau of Indian Affairs region intermittently for 30 years. In between this service, Roland led his people as Governor for three terms (1975 through 1977, 1995 through 1998, and 2003 through 2006).

While in office, Governor Roland Johnson bolstered Laguna's economic standing and supported job creation by opening an electronics component manufacturing plant. Roland also worked diligently to preserve Laguna traditions through his fluency of our Native Keres language. Governor Johnson incorporated this gift into the work he did with outside partnerships so that the tribe's interests were always at the center of decision-making processes.

A born leader, Roland Johnson has left a lasting impression on our Laguna Pueblo and has inspired a long and growing list of current and future tribal leaders. This is thanks not only to his ability to make respectful and practical decisions, but also to his use of traditional values to guide his professional career.

His legacy is rooted in the importance of education: by cultivating a solid foundation in the Pueblo tradition, he dedicated his career to both preserving Pueblo culture and creating opportunities for the Laguna people close to home. Additionally while in office, Governor Johnson responded to the need for graduate education support by implementing the Laguna Graduate Scholarship Program.

He will be remembered as an historical visionary—someone who always looked to the past to guide his plans for the future. I send my deepest condolences to Roland Johnson's family and friends.

Each awardee receives a certificate signed by the President, a \$10,000 award from NSF, and a trip to Washington, DC.

Because of his wealth of knowledge, Dr. Lemma was designated as a Distinguished Professor through Savannah State University in 2011.

In 2013, he received the prestigious title of Georgia Professor of the Year and recently became one of the most awarded professors in the state of Georgia.

Ms. Heberle has also excelled at teaching science and coordinated the scientific research program at Islands High School for six years.

Currently, she teaches Scientific Research and Zoology to 9th through 12th grade students. STEM fields are critical to our nation's health and prosperity, so it is imperative to have leaders like Dr. Lemma and Ms. Heberle guiding and supporting our leaders of tomorrow.

They both have made an everlasting impact on countless students, and I know they will continue to inspire many more. I am thankful for Dr. Lemma and Ms. Heberle's steadfast commitment to their students.

He lived a life deeply caring for others, and was generous in caring for orphans and widows—and he did it humbly.

Everyone who knew him will miss his sense of humor, eccentric ways, colorful stories, passion for learning, and encouragement.

He will be greatly missed, but his legacy will continue for countless years to come.

IN RECOGNITION OF THE INTERNATIONAL ASSOCIATION OF DRILLING CONTRACTORS

Mr. CUELLAR. Madam Speaker, I rise today to commend the International Association of Drilling Contractors on its 80th anniversary as a trade association.

In 1940, the International Association of Drilling Contractors, commonly known as IADC, was formed to address the need for a collective voice advocating for the interests of the oil and natural gas contract drilling industry. Since then, IADC has been the world's leader in developing drilling safety protocol and standard operating procedures.

Over the past 80 years, IADC has been instrumental in shaping the upstream oil and gas industry. In 1947, IADC began sponsoring industry training for college students, and by 1962 had developed the Incidents Statistics Program (ISP), an industry-leading safety incident reporting program that is still in operation today. In 1968, IADC led the publication of the Accident Prevention Manual and standardized the color-coding of oilfield servicing equipment. In 1983, IADC held the first joint Society of Petroleum Engineers/IADC Drilling Technology Conference, which persists today as an annual event, and in 1994 introduced the RigPass program to help service companies assure their field personnel are properly grounded in the basics of rig operations and safety. IADC also introduced the industry's Competence Assurance Accreditation (CAA) program, circa 2004, which assures field personnel possess the necessary knowledge, skills and abilities required to function safely in the oilfield. These are just a few examples of the initiatives IADC has undertaken to make the oil field a safe and prosperous place to operate.
