Ms. SPEIER. Madam Speaker, I rise today to recognize Rachel Meyer, Executive Director Emeritus of CuriOdyssey, a science playground and zoo for children ages 1 to 100. Rachel was executive director for 13 years, 2007 to 2020. She recently departed to find new challenges, but she leaves a legacy of love and educational achievement.

CuriOdyssey is nestled under the eucalyptus trees at Coyote Point in San Mateo. It's a spectacular setting for a science facility because the natural splendor of Coyote Point is itself something to behold.

During her tenure, Rachel really put CuriOdyssey on the map. It went from being the Coyote Point Science Museum to being the place on the Peninsula to bring small children, and those a bit older, to learn about physics, math, animals and much, much more.

CuriOdyssey is all about experience.

Rachel Meyer brought exhibits to CuriOdyssey that challenged children to immerse themselves in science. Under Rachel, exhibits reflected how children learn—through touching, listening, drawing, reading, jumping, grabbing. Many museums are static with thick glass separating patrons and the exhibits. At CuriOdyssey, it was sometimes necessary to put a warning sign discretely on the exhibit so that smaller children wouldn't overwhelm the display by trying to physically engage with whatever was moving, popping, clanging, flashing, howling or flying.

Rachel was a great fundraiser and under her leadership both attendance and donations soared. She invited the community to donate to an expanded CuriOdyssey and they responded with gusto. Her team of co-workers were talented and dedicated. They raised enough money that a new facility will open this decade, dedicated to the belief that you can't shut down curiosity even during a pandemic.

Science education is embedded in the DNA of the San Francisco Peninsula, home to some of Silicon Valley's greatest companies and to the faculty of many great universities, such as Stanford, the University of California, Berkeley or the University of California, San Francisco. These parents know quality science when they see it, and they came by the tens of thousands to witness the displays, and to teach their children, because of Rachel Meyer's energy and imagination.

Rachel did not arise from a vacuum. She was the Executive Director of the Palo Alto Junior Museum and Zoo for 11 years before her 13 years at CuriOdyssey. She learned

about science education through studying under a master, Dr. Frank Oppenheimer of the Exploratorium in San Francisco.

CuriOdyssey is a zoo as well as museum. The facility is home to animals injured and unable to return safely to the wild as well as those born in captivity. Rachel was an outstanding mother to them all even though, if asked, the porcupine might not concede the point.

It takes a special kind of educator to lead an all-hands-on-deck institution like a children's experiential museum. Rachel was an outstanding choice. She never let a good deed by staff or board go unmentioned, never left a fundraising dime hidden beneath the cushions on the couch, and always used her love of learning through fun to guide CuriOdyssey.

She is now on a new path in life but it's really the same path: Education and science. She will consult and stay close to CuriOdyssey. Indeed, the burrowing owls might otherwise wonder where their mentor has gone. So good was she at burrowing into the fabric of our lives that we can scarcely believe she left her station at Coyote Point. Good news for us all: The bald eagle will keep us apprised of the sightings, and comings and goings, of Rachel. Undoubtedly this noble bird will report that Rachel is up to great good in the years ahead.

During his tenure, he guided Olathe through a time of unprecedented growth and pioneered several programs to improve the city. One of these initiatives, a children's literacy program called "I Read with Mayor Mike," reached thousands of kids in Olathe and was recognized by First Lady Laura Bush, who visited Olathe in 2008 to celebrate the program.

Not only did Mayor Copeland dedicate his life to public service, he also devoted his time to charity work. He created the Olathe Mayor's Christmas Tree Fund, which raised more than \$1.5 million for children's charities since 2007. He received numerous accolades, including the Martin Luther King, Jr. Legacy Award given by the Olathe Branch of the NAACP, the Olathe Chamber of Commerce's Citizen of the Year Award, and the Daily Points of Light Award.

Mayor Copeland leaves behind a legacy that has touched the lives of many in the Olathe community. During his 20 years of service, he added 18 parks and 29 miles of trails, opened the new Olathe Community Center and new Indian Creek Library, and completed the Santa Fe railroad grade separation—among many other notable accomplishments.

Personally, I will miss Mayor Copeland's wise counsel. I very much enjoyed each one of our many conversations since I took office. He was always generous with his time and knowledge, willing and eager to represent the people of Olathe.

Madam Speaker, I offer my deepest condolences to Mayor Copeland's family and friends, and all of those who will miss his kindness and leadership.

Already this year, Congress has given USPS additional access to \$10 billion worth of funding to cover operating expenses of which the Post Office has yet to use. Simply delivering another \$25 billion—at substantial taxpayer cost—without operational changes is bad policy. Congress must stem the Postal Service's recurrent losses, which have totaled \$83.1 billion since 2006, and reduce its unfunded pension and healthcare liabilities, which total more than \$120 billion. Another government bailout for an agency that has a long history of fiscal mismanagement is not the right answer. The

systemic challenges of USPS pose no threat to the November presidential election, however. The Postmaster General has assured Americans that “the Postal Service is ready today to handle whatever volume of election mail it receives this fall.” There is no obstacle to state Secretaries of State from sending ballots to voters who request them with enough time for them to be returned and counted. Rather than playing political games, we should work together to achieve what we all want, which is to count every vote and build a Postal Service that works for the 21st century.

creatures. After 39 years as the premiere volunteer at San Mateo County's science playground and zoo, CuriOdyssey, Linda is passing the reigns to a new generation of leaders. If you listen carefully, you may hear the Barn Owls screech as they learn that their most ardent friend and promoter will be leaving.

The homes of these creatures and dozens more were constructed in the 1980's because Linda, working with other members of the Board of Directors, led an exceptionally successful fundraising effort. This began the pattern: Linda would set a fundraising objective and relentlessly pursue it. Simply put, it wasn't easy to tell Linda "no."

Having raised funds, she then supervised construction of the animal habitats. Today, in a peaceful setting amidst the eucalyptus trees, children from throughout the region view falcons, hawks, frogs, snakes, guinea pigs, otters, tortoises, tarantulas, and dozens of other creatures which are at home at CuriOdyssey typically because they were saved after being injured or abandoned. All are attended to by a loving staff who communicate that love to the legions of young people wide-eyed at the chance to see Mother Nature up close.

CuriOdyssey exists in a community dedicated to science and the environment. Linda's credibility is so highly respected that she was able to rescue CuriOdyssey from a near-death experience. In 2006 the museum fell on hard times and was in danger of closing. Linda and

a small team secured \$600,000 in six weeks and a matching contribution that rescued the museum.

In more recent years, Linda and her co-chair raised \$27 million for an inspiring building that will be a landmark on the San Francisco Peninsula. All of this passion arises from her 20+ hours of volunteer work performed at CuriOdyssey since 1981. Linda has more roles than simply that of fundraiser, because CuriOdyssey also provides science education to hundreds of students, annually, and offers summer camps and special events to educate the public. Linda is an important influence on the offerings of this amazing facility.

Linda Lanier didn't start at CuriOdyssey. She was President of the Junior League of San Francisco in 1984/5 and did community volunteer work from 1974 to 1985. She is President of the Atkinson Foundation which invests \$1 million a year into thriving nonprofits in San Mateo County. As you can see, she has an eagle eye for philanthropic opportunities.

Linda has done all of this and also been a remarkable wife, mother and grandmother. Her husband is Sterling Sidney Lanier IV, and they have two married children, both of whom live in Menlo Park. They are Leslie Lanier Trigg, [Mike] and sons Cole and Chase, as well as Sterling Sidney Lanier V, [Jessica] and their son Dylan and daughter Bailey. I suspect

that all have donated a fair number of hours to CuriOdyssey as volunteers.

Madam Speaker and members, I regularly took my small children to CuriOdyssey and remember the wonder they experienced when they saw the beehive, ran along the hallways towards an exhibit or just listened to the sound of airplanes landing at the nearby airport. Sparking wonder in the mind of a child is sparking our nation's future. CuriOdyssey has had many staff, board members and other volunteers over the decades, but I think it's fair to say that it is also a house that Linda built. She would say otherwise, and you can't blame her for her modesty. After all, some may wonder, what about the role of the gray fox or the raccoon or the blue-tongued skink? Doesn't their charm also count in the success of this science center? Particularly that skink. After all, how much cuter does it get than a reptile with a blue tongue?

Indeed, it all counts, but the key point is that Linda Lanier counts as a visionary, a fundraiser, and a mother to all bright minds within her gaze. Linda's house is a house of joyful squeals, gasps of amazement, and the occasional squeak of a creature no doubt responding, "Thanks for coming little human. Be well, my friend."

So now from us all in the House of Representatives, let us rise and say, farewell Linda. I thank Linda for her leadership and vision. Be well, our friend.
