By Mr. SABLAN:

H.R. 8116.

Congress has the power to enact this legislation pursuant to the following:

Under Article I, Section 8 of the Constitution.

By Mr. BANKS:

H.R. 8117.

Congress has the power to enact this legislation pursuant to the following:

The constitutional authority of Congress to enact this legislation is provided by Article I, section 8 of the United States Constitution, specifically clause 18 (relating to the power to make all laws necessary and proper for carrying out the powers vested in Congress).

By Ms. BASS:

H.R. 8118.

Congress has the power to enact this legislation pursuant to the following:

Ms. ROYBAL-ALLARD. Mr. Speaker, I am proud to support H.R. 8015, the Delivering for

America Act. This legislation is an important first step to ensure our Postal Service is not undermined by the reckless and political actions undertaken by President Trump's hand-picked postmaster general.

The United States Postal Service is enshrined in our Constitution and is a critical thread of the fabric of American life.

Our postal workers and letter carriers work six days a week and often long hours to support business and provide Americans with essential services that keep us connected to our family, friends, and the world at large.

We celebrate our heritage and accomplishments through designs on postage stamps. Young men enroll in our Selective Service at the post office. For example, millions of seniors depend on the USPS for their Social Security check, for the delivery of their essential medications, for their ability to vote, and to stay connected to their family and the world.

For many seniors, a Social Security check is their only source of income. It pays for their food, their rent, and other essential needs, including paying for their life-saving medications.

Twenty percent of Americans over forty with a chronic disease receive their medications through mail order, and over half are over the age of sixty-five. Fifty-four percent of this group take more than four types of medications. For these Americans, including millions of veterans, the collapse of our USPS would be literally a matter of life or death.

Currently, with our nation and the world in the midst of a deadly pandemic, without the postal service, it would be impossible to live our lives as we would normally. We must have safe and secure ways to continue to participate in community life, which includes the ability to exercise our most fundamental right as American citizens: the right to vote.

More than ever, with the approaching national election, it is critical for Americans to be able to trust their mail-in ballots will be safely delivered in time to be counted.

It is unconscionable that instead of expanding and securing our mail-in voting, President Trump's postmaster general is deliberately trying to undermine and destroy trust in our postal service.

Mr. Speaker, I share the concern and outrage expressed by my constituents about delays in their mail, reduced accessibility to postal services, and efforts to weaken or destroy the USPS.

H.R. 8015 will prevent the president, and his postmaster general, from weakening or destroying our U.S. Postal Service and the essential services it provides to the American people.

I am proud to vote for the Delivering for America Act to protect the millions of Americans whose very lives depend upon the Postal Service, and to stop the president's insidious plan to sabotage it.

Upon graduation from Truman University in Kirksville, Missouri with a B.S. in Industrial Science, Mr. Leavitt worked for the cities of Kirksville, Missouri and Denton, Texas. In 2000, Leavitt moved to the City of Highland Village, first serving as the public works director followed by his appointed as City Manager in 2003.

A true advocate for public safety and fiscal responsibility, Leavitt spearheaded the transformation from a volunteer fire department to a full-time professional department. Under his leadership as City Manager, the ad valorem tax rate was reduced, and tax exemptions increased by fifty per-cent for those with a disability and those over the age of 65. Through his capable direction, sales tax revenue has grown from just over \$400,000 in 2003 to \$4 million in 2020, accomplishing a goal set by the City Council to increase funding available for city improvement. This tremendous growth was spurred by the construction and development of premier dining and shopping districts: The Marketplace at Highland Village and The Shops at Highland Village.

The quality of life for Highland Village residents has been raised during his tenure as City Manager. Leavitt has overseen extensive improvements to the City's recreation infrastructure with the addition and growth of the City's biking and walking trails and the purchase and development of the City's principal park, Doubletree Ranch Park. While local in nature, many of these projects also involved federal interests where I was honored to work with Mr. Leavitt and the City. Among these included the continuation and expansion of FM 2499 and the widening of I-35 East, a priority project I worked with Mr. Leavitt, local leaders and Deputy Secretary of Transportation Thomas Barrett to highlight during a media day from Highland Village's Copperas Branch Park. A couple of years later in 2010, I worked with Mr. Leavitt and the Highland Village Police Department to secure 707 Highland Village Road. Ultimately deeded to the City as an outcome of an IRS seizure involving federal

charges of racketeering, obscenity, fraud and income tax evasion, it allowed City Manager Leavitt the opportunity to replace a home that had attracted criminal activity to this beautiful lakeside community with its first lakeside park. Only a couple of years later, the Double Tree Ranch, another city park improved in large part through Mr. Leavitt's coordinated efforts with myself and local officials, was the appropriate site in 2017 to finally celebrate the Phase 1 completion of the I-35E project.

Michael Leavitt has been an outstanding public servant to the residents and businesses of Highland Village. His professional leadership, innovative vision, and passion for excellent customer service will be missed throughout his community and all of North Texas. On behalf of the 26th District, I wish him the best in his next stage of life.

Ms. MOORE. Mr. Speaker, I rise in strong support of H.R. 8015, legislation that is sorely needed to help protect the integrity of our Postal Service.

Our communities depend on a reliable Postal Service. The hardworking men and women of the Postal Service every day help ensure that critical mail reaches every part of this country, even in the middle of a pandemic. These essential workers make sure that this essential public service is carried out.

Despite the challenges of moving mail in a country as large as ours and longstanding fiscal challenges, it is no wonder the Postal Service continues to score high in public opinion polls. It is after all, the public service that touches most Americans almost every day.

The Postal Service is not a business. Nor is degrading its level of service a viable business plan. Doing so would only hurt the Postal Service, its workers, and the American public, including those in rural areas. Yet, that is unfortunately the direction that the Postal Service's leadership.

I have heard from so many of my constituents who are concerned about the damaging recent changes to Postal Service operations under the leadership of the new Postmaster General, changes which are already being felt in our communities through reports of delays in getting critical mail.

While the recent announcement that these changes would be suspended for a short time is a step forward, that is not enough.

Additionally, besides the changes being made by new Postmaster General, the ongoing COVID-19 pandemic that has befuddled this Administration also poses a clear threat to the short-term and long-term fiscal health of the Postal Service. I am pleased that the bill before us today includes needed funding to address mail volume declines to support the Postal Service and its workers through these trying times.

We need to protect and maintain a strong Postal Service which is what this bill does. I support this legislation and urge my colleagues to do the same.

#### INSULAR AREA LIQUIDITY ACT

### HON. GREGORIO KILILI CAMACHO SABLAN

OF THE NORTHERN MARIANA ISLANDS

Mr. SABLAN. Madam Speaker, today, I introduce the Insular Area Liquidity Act, which requires any department or agency of the federal government, awarding a grant to any of the four smaller insular areas, to provide at least 50 percent of the award amount up front in an advance payment as defined in 2 CFR 200.3. My bill will also require the awarding department or agency to provide enhanced grant management assistance and technical assistance to the recipients to assure the advanced funds are properly used.

Unlike most states, the insular areas have limited cash flow. Our districts generally rely heavily on a single economy, tourism, that is highly sensitive to natural disasters and the economic fallout that follows. When that happens, and even in the best of times, insular government have little or no fiscal cushion.

Of course, I am very grateful for the many grants the Marianas receives to shore up the limited resources of our islands and, of course, especially now to help respond to the coronavirus crisis. But many grants awarded require that the awardee spend their own capital up front to be reimbursed later.

One result is that federal funds are slow to be spent and the projects and programs those funds are intended to support wait to be implemented. The legislation I am introducing today addresses this problem by providing an advanced payment of at least 50 percent of any grant awarded. Projects and programs would be less subject to delay.

This advance award is not a new concept. Some federal grant programs already provide for an advance payment to recipients. The FEMA Public Assistance Grant program, to name one, under section 428 of the Robert T. Stafford Act, P.L. 93-288 provides a 100 percent advance on project cost estimates, thereby removing the burden of capital availability from the awardee.

In the Marianas, we are still recovering from the devastation caused by 2018 Super Typhoon Yutu. And now we have the coronavirus pandemic, which has ground our tourism reliant economy to a halt and left our government short of funds. But capital limitations are not unique to the Marianas—it is a challenge shared by all of the insular areas. That is why I introduce this bill today, alongside my colleagues Mr. SAN NICOLAS, Ms. PLASKETT, and Mrs. RADEWAGEN. I urge all my

colleagues to support this bipartisan legislation.
