Dr. Hobert's life changed when he became confined to a wheelchair in 1983, but it never deterred him—he found ways to continue practicing medicine in his pursuit to help others.

Beyond his career, Dr. Hobert adored his family and was committed to the happiness of his loved ones. He cherished family vacations and used his time wood working to make gifts for family and items to be donated for auctions to various organizations that he supported.

Sadly, Dr. Hobert passed away this year. He is survived by his wife, three children, four grandchildren, sister, and stepmother. He will be remembered for his compassion, generosity, and determination. Please join me in honoring Dr. Hobert for his many contributions to our community.
