Her work with Congress, and particularly with the Diabetes Caucus, has been invaluable, and her unwavering commitment is an example for all those who continue her work. NATIONAL APPRENTICESHIP ACT OF 2020

Mr. CROW. Mr. Speaker, I rise today in support of my amendment.

The registered apprenticeship system is our nation's most successful federal workforce program and has created a pathway for millions of Americans to achieve the American Dream since its creation more than 80 years

With more than 600,000 apprenticeships nationwide, including more than 6,000 in my home state of Colorado, apprenticeships provide workers with paid, on-the-job training, and more than 94 percent are employed upon completion.

However, while this time-proven apprenticeship model is successful, we can and must do more to expand and equip it to meet the demands of our changing workforce.

The National Apprenticeship Act of 2020 would do that by greatly expanding upon the apprenticeship system and investing more than \$3.5 billion to create nearly 1 million new apprenticeship opportunities over the next five years in nontraditional industries.

And my amendment will ensure that the education sector is included in this expansion.

Across the United States, there is a growing demand for qualified teachers. Schools—particularly low income schools—are struggling to hire and retain qualified teachers, which further perpetuates a cycle of inequality that harms students, teachers, and the public education system as a whole.

Including the education sector in the expansion of the registered apprenticeship system would address this crisis and help build a pipeline of qualified teachers that are prepared to teach on day one. As a product of public schools, I know the lasting impact teachers can have on students. Improving American education by investing in our teachers should be a top priority.

I urge my colleagues to support this amendment.

Mr. BISHOP of Georgia. Madam Speaker, it is with a heavy heart and solemn remembrance that I rise today to pay tribute to an outstanding educator, man of God, and dear friend of longstanding, Dr. Joseph Donnell Carley, Jr. Sadly, Dr. Carley passed away on Sunday, November 22, 2020. A home-going celebration was held graveside on Sunday, November 29, 2020, at 2pm in Thomasville, Georgia at Peaceful Rest Cemetery.

Dr. Joseph Donnell Carley Jr. was born on November 11, 1955, in Thomasville, Georgia, as the fourth of seven children to the late Mr. Joseph Eugene Carley, Sr. and Mrs. Rosamond Louise "Colvin" Carley. He grew up in the Tockwotten community and went on to earn an Associate's degree in Biology and Early Childhood Education from Birdwood Junior College (now Thomas University); a Bachelor's degree in Psychology from Valdosta State University (then Valdosta State College); and a Master's in Early Childhood Education from Valdosta State University. In addition to receiving an honorary Doctorate degree in Early Childhood Education from the University of America, an affiliate of New York University, he also attended Continuing Education training for Early Childhood Education for Child Care leaders with the National Early Childhood Program Accreditation's National Administrators Credential (NECPA-NAC) and at University of Georgia, Albany State University, Bainbridge College, and Georgia State University.

Dr. Carley had an immense passion for knowledge and bettering the lives of others through teaching. During his professional career as an educator, he taught at every level of education. He was the owner of Mu-Dear Child Care Center and Preparatory Preschool, where he served in a number of roles for 39 years. He taught in the Thomas County School System, the Thomasville City School System, and the Bainbridge State Hospital Special Education Department, also serving as an Adjunct Professor at Albany State University and Thomas University. In addition to his extensive career in Education and Administration, he was also a Consultant, Gospel Announcer, Gospel Recording Artist, Motivational Speaker, Counselor, Mentor, School Board Member, and a National Instructor for the NECPA-NAC.

Dr. George Washington Carver once said, "No individual has any right to come into the world and go out of it without leaving behind distinct and legitimate reasons for having passed through it." We are so blessed that Dr. Joseph Donnell Carley, Jr. passed this way and shared with us his legacy of service that will stand the test of time. Surely, the pearls of wisdom that Dr. Carley has given to all those whose lives he has touched will forever resonate in their hearts and spirits.

On a personal note, Donnell Carley wowed me as a dynamic choral director of soul stirring capacity. His body drama in directing a gospel choir drove countless congregations to stand on their feet and wave their hands during worship and concert renditions. His passion for excellence and his God-given talents made a joyful noise of praise to God from whom all blessings flow.

Donnell's zeal for Early Childhood Education, his years of dedication to Mu-Dear's Child Care Center, and his effective service on the Thomasville City Board of Education resulted in numerous phone calls, letters, and visits to my Congressional Office in Washington, DC. in support of improving education in America. Over the 28 years that I have known Dr. Carley, he has given me sage advice and counsel. He was direct and always told me not what he thought I wanted to hear, but what he thought I needed to hear.

Dr. Carley was preceded in death by his parents and his sister, Armogene, but his legacy lives on through his siblings Barbara, Susan, Gail, Rosamond, and Eugene; and a host of family and friends, who will miss him dearly.

Madam Speaker, I ask my colleagues to join my wife, Vivian, and me, along with the more than 730,000 residents of Georgia's Second Congressional District, in honoring the life and legacy of Dr. Joseph Donnell Carley, Jr. and in extending our deepest sympathies to his family, friends, and loved ones during this difficult time of bereavement. Mr. HUFFMAN. Madam Speaker, I rise today in memory of Tom Untermann who passed away on October 27, 2020, at the age of 73 after a lifetime of exemplary public service to his community.

Born in 1947 to Anne and Karl Untermann, Tom followed in his family's footsteps in developing deep roots in the community through the family business. His great uncle, Richard Lohrmann, emigrated from Germany in 1909 to San Rafael in pursuit of the American dream. Upon arrival, he purchased a small plot of land and opened a neighborhood nursery. In 1954, having inherited the family green thumb, Tom's father purchased the nursery. Today, West End Nursery celebrates 110 years as a valued business of San Rafael.

In his youth, Tom excelled as an athlete both at San Rafael High School and the University of California, Davis, where he won two conference championships as a power forward for the basketball team. It was at UC Davis that Tom met his wife, Merrie, and the two returned to San Rafael to raise their sons, Chris and Kurt. Once back in San Rafael, Tom inherited West End Nursery from his father, becoming a third generation family owner.

Working closely with his son Chris, Tom fostered a welcoming environment at the nursery, sharing his vast knowledge of plants with all customers, from experienced green thumbs to first time gardeners. Every December, with the support of Merrie and his daughter-in-law Barbara, Tom would construct a beautiful Christmas display within the nursery inviting community members to visit and marvel in the holiday spirit.

Tom's positive impact on the community extended beyond the nursery. He spent many years coaching San Rafael High School athletics and played a lead role in the construction of the high school's new baseball field, investing many years and his personal funds into the project. In honor of his tireless dedication to community athletics, Tom was awarded a special recognition by the Marin Athletic Foundation Hall of Fame in 2007.

Tom was a well-respected community leader who will be remembered for his generosity of spirit and enduring commitment to public service. He is survived by wife, Merrie; sons, Chris and Kurt; daughters-in-law, Barbara and Elizabeth; grandchildren, Walker, Wade, Waylen, Tanner, Hudson, and Emilia; and siblings, Richard, Dennis and Jeanne. Madam Speaker, while Tom Untermann will be greatly missed, his legacy will live on through the indelible positive impact he had on his many friends, family and the community at large. Jill Techel grew up in Grand Forks, North Dakota and earned a Bachelor's degree in social work from the University of North Dakota. She moved to Napa in 1971, where she began her public service career as a member of the Napa Parks and Recreation Commission and the Napa Valley Unified School District Board, eventually serving as the leader of both organizations, all while raising her two children. In 1996, she was appointed to the Napa City Council, where she was reelected twice before being elected Mayor in 2005.

One of Mayor Techel 's most important achievements during her tenure was championing the Napa River and Napa Creek Flood Protection Project, which rerouted the Napa River to prevent devastating floods in downtown Napa, a consistent problem in the city before her efforts. Without Mayor Techel's persistence in advocating for funding in Washington on behalf of Napa, this project would not have been realized.

Mayor Techel's legacy extends far beyond her commitment to flood prevention. She has helped build up Napa 's world-class reputation by cultivating a vibrant arts scene through the creation of the Rail Arts District, BottleRock Festival, and the Napa Art Walk. She has also supported arts education, collaborating with the school district to allow students to display their art at the Napa Lighted Art Festival, Napa 's newest public art efforts. Through her calming presence, Mayor Techel has led the city through multiple crises, including the 2005 flood, the 2014 earthquake, the 2017 fires, and the coronavirus pandemic.

Throughout her time as mayor, Mayor Techel has been recognized countless times for leadership and dedication to her community. In 2004, she received the Preceptor Award for Outstanding Leadership Professionals from the National Community Leadership Association. Following the 2014 South Napa Earthquake, Mayor Techel was named the Napa Chamber Citizen of the Year for demonstrating immense leadership in her fight for resources to assist in Napa's recovery.

Madam Speaker, I join Napa in wishing Mayor Techel well as she goes from caring for her city to caring for her grandchildren in retirement. Ms. SEWELL of Alabama. Madam Speaker, I rise today to honor the extraordinary life and legacy of long-serving Alabama State Representative Alvin Holmes of Montgomery. Rep. Holmes dutifully served as a member of the Alabama House of Representatives for 44 years. Rep. Holmes passed away at home at the age of 81. Rep. Holmes was a dedicated public servant and community leader. Rep. Holmes led with dignity and a strong sense of justice throughout his career. He is remembered by colleagues and the community as an individual who knew and acted on what was right, no matter the challenge. He is survived by his daughter, Veronica Holmes.

Born in Montgomery on October 26, 1939 to John H. Holmes and Willie Ann Holmes, he was born and raised in Montgomery, AL. Rep. Holmes attended Rochester Business Institute, Alabama State University, Atlanta University, the University of Pennsylvania, the University of Alabama, and Jones School of Law. He held a Bachelor of Science degree, Master of Education degree, Master of Arts degree, and a Doctor of Law degree. Rep. Holmes marched with Dr. Martin Luther King, Jr. as a student and fought for the equal treatment of all Americans in every role he served.

Rep. Holmes was a proud member of Kappa Alpha Psi Fraternity, the NAACP, Montgomery Improvement Association, a member of the State Democratic Executive Committee, and was a member of the Hutchinson Missionary Baptist Church.

After graduating from Alabama State University, Rep. Holmes was an Alabama delegate to the historic 1968 Democratic National Convention. He was a member of the Southern Christian Leadership Conference, where he helped lead civil rights demonstrations in between his studies. Rep. Holmes served once more as an Alabama delegate to the 1996 Democratic National Convention.

In 1974, Alvin Holmes was elected to the Alabama House of Representatives. During the four decades of his service, Rep. Holmes gave a voice to the voiceless—a champion for equal rights and justice for all citizens. He led multiple efforts to deconstruct the remnants of segregation and to remove racist language from the State Constitution. One of his proudest accomplishments was establishing Martin Luther King Day as a state holiday and encouraging the hiring of African Americans for professional position at the Alabama Legislature. Rep. Holmes spearheaded the annual parade that is held on the Martin Luther King Jr. holiday.

In 1993, Rep. Holmes successfully led the effort to remove the confederate flag from Alabama's State Capitol building. In addition, he sponsored a constitutional amendment to remove an interracial marriage ban from the Alabama Constitution and fought for years to
