

**AMENDMENT TO THE AMENDMENT IN THE
NATURE OF A SUBSTITUTE TO H.R. 2
OFFERED BY MR. CRAWFORD OF ARKANSAS**

At the end of subtitle F of title I of division B, add the following:

1 SEC. ____. CERTIFICATION REQUIREMENTS.

2 (a) LIMITATION OF TREATMENT OF DOMESTIC OR
3 U.S. ORIGIN.—Notwithstanding any other provision of
4 any law or any rule, regulation or policy of the Adminis-
5 tration, including Part 661 of the Administration’s regula-
6 tions, no article, material, or supply, shall be treated as
7 a component of “U.S. origin” for purposes of section
8 661.5 of the Administration’s regulations or a component
9 or subcomponent of domestic origin for purposes of section
10 661.11 of such part if—

11 (1) it contains any material inputs manufac-
12 tured or supplied by entities that—

13 (A) are subject to relief authorized under
14 the fair trade laws of the United States, includ-
15 ing section 731 et seq. of the Tariff Act of
16 1930 (19 U.S.C. 1673 et seq.) and section 701
17 et seq. of the Tariff Act of 1930 (19 U.S.C.
18 1671 et seq.);

1 (B) are owned or controlled by entities
2 subject to United States sanctions; or

3 (C) are entities owned by a foreign govern-
4 ment, closely linked to or in partnership with a
5 foreign government or whose directors or orga-
6 nizational and board leadership include any per-
7 son serving in any capacity in the defense appa-
8 ratus of another nation;

9 (2) it contains or uses covered telecommuni-
10 cations equipment or services as that term is defined
11 by section 889 of the John S. McCain National De-
12 fense Authorization Act for Fiscal Year 2019 (Pub-
13 lic Law 115–232);

14 (3) it is of a class or category of products and
15 was produced by a manufacturer or an affiliate of
16 such a manufacturer found to have violated United
17 States intellectual property laws, including trade se-
18 cret theft under section 1832(a)(5) of title 18,
19 United States Code, found to have committed eco-
20 nomic espionage under section 183J(a)(5) of such
21 title, or deemed to have infringed the intellectual
22 property rights of any person in the United States.

23 (b) CERTIFICATION.—If buses or other rolling stock
24 are being procured, the Administrator shall require as a
25 condition of responsiveness that each bidder certify that

1 no component, subcomponent, article, material or supply
2 described in subparagraphs (A) through (C) in subsection
3 (a)(1) of this section is incorporated in or used by the
4 rolling stock that is offered by the bidder.
