## JOINT RESOLUTION

Proposing an amendment to the Constitution of the United States providing that the rights extended by the Constitution are the rights of natural persons only.

- 1       *Resolved by the Senate and House of Representatives*
- 2       *of the United States of America in Congress assembled*
- 3       *(two-thirds of each House concurring therein), That he fol-*

1 lowing article is proposed as an amendment to the Con-  
2 stitution of the United States, which shall be valid to all  
3 intents and purposes as part of the Constitution when  
4 ratified by the legislatures of three-fourths of the several  
5 States:

6                   “ARTICLE —

7         “SECTION 1. The rights protected by the Constitution  
8 of the United States are the rights of natural persons only.  
9 Artificial entities, such as corporations, limited liability  
10 companies, and other entities, established by the laws of  
11 any State, the United States, or any foreign state shall  
12 have no rights under this Constitution and are subject to  
13 regulation by the People, through Federal, State, or local  
14 law. The privileges of artificial entities shall be determined  
15 by the People, through Federal, State, or local law, and  
16 shall not be construed to be inherent or inalienable.

17         “SECTION 2. Federal, State, and local government  
18 shall regulate, limit, or prohibit contributions and expendi-  
19 tures, including a candidate’s own contributions and ex-  
20 penditures, to ensure that all citizens, regardless of their  
21 economic status, have access to the political process, and  
22 that no person gains, as a result of that person’s money,  
23 substantially more access or ability to influence in any way  
24 the election of any candidate for public office or any ballot  
25 measure. Federal, State, and local governments shall re-

1 quire that any permissible contributions and expenditures  
2 be publicly disclosed. The judiciary shall not construe the  
3 spending of money to influence elections to be speech  
4 under the First Amendment.

5 "SECTION 3. Nothing contained in this amendment  
6 shall be construed to abridge the freedom of the press.".
