A BILL

To amend the Robert T. Stafford Disaster Relief and Emergency Assistance Act to provide flexibility with the cost share for fire management assistance, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Wildfire Recovery Act”.*

5 **SEC. 2. FIRE MANAGEMENT ASSISTANCE COST SHARE.**

6 *Section 420 of the Robert T. Stafford Disaster Relief*
7 *and Emergency Assistance Act is amended—*

8 *(1) by redesignating subsection (e) as subsection*
9 *(f); and*

10 *(2) by inserting after subsection (d) the fol-*
11 *lowing:*

12 *“(e) FEDERAL SHARE.—The Federal share of assist-*
13 *ance under this section shall be not less than 75 percent*
14 *of the eligible cost of such assistance.”.*

15 **SEC. 3. RULEMAKING.**

16 *Not later than 3 years after the date of enactment of*
17 *this Act, the President, acting through the Administrator*
18 *of the Federal Emergency Management Agency, shall con-*
19 *duct and complete a rulemaking to provide criteria for the*
20 *circumstances under which the Administrator may rec-*
21 *ommend the President increase the Federal cost share for*
22 *section 420 of the Robert T. Stafford Disaster Relief and*
23 *Emergency Assistance Act (42 U.S.C. 5187). Such criteria*
24 *shall include a threshold metric that assesses the financial*
25 *impact to a State or local government from responding to*

- 1 *a fire for which fire management assistance is being pro-*
- 2 *vided.*
