To amend the Public Health Service Act to provide for a public awareness campaign with respect to human papillomavirus, and for other purposes.

#### 1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "Promoting Resources
3	to Expand Vaccination, Education, and New Treatments
4	for HPV Cancers Act of 2021" or the "PREVENT HPV
5	Cancers Act of 2021".
6	SEC. 2. PREVENTING HPV AND HPV-ASSOCIATED CANCERS
7	REAUTHORIZING JOHANNA'S LAW.
8	Section 317P of the Public Health Service Act (42
9	U.S.C. 247b–17) is amended—
10	(1) in subsection $(c)(1)$ —
11	(A) in subparagraph (B), by striking "cer-
12	vical";
13	(B) in subparagraph (C), by striking
14	"and" at the end;
15	(C) in subparagraph (D) by striking
16	"other" and all that follows through "cancer."
17	and inserting "recommended diagnostics for
18	early intervention for, and prevention of, HPV-
19	associated cancers; and"; and
20	(D) by adding at the end the following:
21	"(E) the importance of recommended vac-
22	cines for prevention of HPV and HPV-associ-
23	ated cancers, including for males;"; and
24	(2) by amending subsection (d) to read as fol-
25	lows:
26	"(d) Johanna's Law.—

1	"(1) National public awareness cam-
2	PAIGN.—
3	"(A) IN GENERAL.—The Secretary shall
4	carry out a national campaign to increase the
5	awareness and knowledge of health care pro-
6	viders and individuals with respect to
7	gynecologic cancers, HPV, and HPV-associated
8	cancers, and the importance of HPV vaccines in
9	preventing HPV and HPV-associated cancers.
10	"(B) Written materials.—Activities
11	under the national campaign under subpara-
12	graph (A) shall include—
13	"(i) maintaining a supply of written
14	materials that provide information to the
15	public on gynecologic cancers, HPV, and
16	HPV-associated cancers; and
17	"(ii) distributing the materials to
18	members of the public upon request.
19	"(C) Public service announce-
20	MENTS.—Activities under the national cam-
21	paign under subparagraph (A) shall, in accord-
22	ance with applicable law and regulations, in-
23	clude publishing materials in digital or print
24	form, public engagement, and developing and
25	placing public service announcements intended

1	to encourage individuals to discuss with their
2	physicians—
3	"(i) their risk of gynecologic cancers
4	and HPV-associated cancers; and
5	"(ii) the importance of HPV vaccines
6	in preventing HPV and HPV-associated
7	cancers.
8	"(D) TARGETED POPULATIONS.—Activities
9	under the national campaign under subpara-
10	graph (A) shall include culturally and linguis-
11	tically competent public service announcements
12	and other forms of communication and public
13	engagement under subparagraph (C) targeted
14	to—
15	"(i) specific higher-risk populations of
16	individuals based on race, ethnicity, level of
17	acculturation, and family history, including
18	African-American and Ashkenazi Jewish
19	individuals;
20	"(ii) communities with high rates of
21	unvaccinated individuals, including males;
22	"(iii) rural communities;
23	"(iv) populations affected by increas-
24	ing rates of oropharynx cancers;

1	"(v) health care providers specializing
2	in assisting survivors of sexual assault; and
3	"(vi) such other communities as the
4	Secretary determines appropriate.
5	"(2) Consultation.—In carrying out the na-
6	tional campaign under this section, the Secretary
7	shall consult with—
8	"(A) health care providers;
9	"(B) nonprofit organizations (including
10	gynecologic cancer organizations and organiza-
11	tions that represent communities and individ-
12	uals most affected by HPV-associated cancers
13	and low vaccination rates);
14	"(C) State and local public health depart-
15	ments; and
16	"(D) elementary and secondary education
17	organizations and institutions of higher edu-
18	cation.
19	"(3) Demonstration projects regarding
20	OUTREACH AND EDUCATION STRATEGIES.—
21	"(A) In General.—
22	"(i) Program.—The Secretary may
23	carry out a program to award grants or
24	contracts to public or nonprofit private en-
25	tities for the purpose of carrying out dem-

1	onstration projects to test, compare, and
2	evaluate different evidence-based outreach
3	and education strategies to increase the
4	awareness and knowledge of women, their
5	families, physicians, nurses, and other key
6	health professionals with respect to
7	gynecologic cancers, including with respect
8	to early warning signs, risk factors, pre-
9	vention, screening, and treatment options
10	"(ii) Science-based resources.—
11	In making awards under clause (i), the
12	Secretary shall encourage awardees to use
13	science-based resources such as the Inside
14	Knowledge About Gynecologic Cancer edu-
15	cation campaign of the Centers for Disease
16	Control and Prevention.
17	"(B) Preferences in awarding grants
18	OR CONTRACTS.—In making awards under sub-
19	paragraph (A), the Secretary shall give pref-
20	erence to—
21	"(i) applicants with demonstrated ex-
22	pertise in gynecologic cancer education or
23	treatment or in working with groups of
24	women who are at increased risk of
25	evnecologic cancers: and

1	"(ii) applicants that, in the dem-
2	onstration project funded by the grant or
3	contract, will establish linkages between
4	physicians, nurses, other key health profes-
5	sionals, health profession students, hos-
6	pitals, payers, and State health depart-
7	ments.
8	"(C) APPLICATION.—To seek a grant or
9	contract under subparagraph (A), an entity
10	shall submit an application to the Secretary in
11	such form, in such manner, and containing such
12	agreements, assurances, and information as the
13	Secretary determines to be necessary to carry
14	out this paragraph.
15	"(D) CERTAIN REQUIREMENTS.—In mak-
16	ing awards under subparagraph (A), the Sec-
17	retary shall—
18	"(i) make awards, as practicable, to
19	not fewer than five applicants; and
20	"(ii) ensure that information provided
21	through demonstration projects under this
22	paragraph is consistent with the best avail-
23	able medical information.
24	"(E) Report to congress.—Not later
25	than 24 months after the date of the enactment

1	of the PREVENT HPV Cancers Act of 2021,
2	and annually thereafter, the Secretary shall
3	submit to the Committee on Energy and Com-
4	merce of the House of Representatives and the
5	Committee on Health, Education, Labor, and
6	Pensions of the Senate a report that—
7	"(i) summarizes the activities of dem-
8	onstration projects under subparagraph
9	(A);
10	"(ii) evaluates the extent to which the
11	projects were effective in increasing aware-
12	ness and knowledge of risk factors and
13	early warning signs in the populations to
14	which the projects were directed; and
15	"(iii) identifies barriers to early detec-
16	tion and appropriate treatment of such
17	cancers.
18	"(4) Authorization of appropriations.—
19	For the purpose of carrying out this subsection,

- there is authorized to be appropriated \$25,000,000
- 2 for the period of fiscal years 2022 through 2026.".
