## AN ACT

To amend the Small Business Act and the CARES Act to extend the covered period for the paycheck protection program, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2       This Act may be cited as the “PPP Extension Act  
3 of 2021”.

4 **SEC. 2. EXTENSION OF COVERED PERIOD FOR PAYCHECK**  
5 **PROTECTION PROGRAM.**

6       (a) IN GENERAL.—Section 7(a)(36)(A)(iii) of the  
7 Small Business Act (15 U.S.C. 636(a)(36)(A)(iii)) is  
8 amended by striking “March 31, 2021” and inserting  
9 “June 30, 2021”.

10       (b) FUNDING.—Section 1102(b)(1) of the CARES  
11 Act (Public Law 116–136), as amended by section 323  
12 of the Economic Aid to Hard-Hit Small Businesses, Non-  
13 profits, and Venues Act (Public Law 116–260), is amend-  
14 ed by striking “March 31, 2021” and inserting “June 30,  
15 2021”.

16       (c) RESTRICTION.—From June 1, 2021, through  
17 June 30, 2021, the Administrator of the Small Business  
18 Administration shall not accept new lender applications  
19 for loans under paragraph (36) or (37) of section 7(a)  
20 of the Small Business Act (15 U.S.C. 636(a)) and shall  
21 only process such lender applications that have been sub-  
22 mitted to the Administrator before June 1, 2021.

23 **SEC. 3. DETERMINATION OF BUDGETARY EFFECTS.**

24       (a) IN GENERAL.—The budgetary effects of this Act  
25 shall not be entered on either PAYGO scorecard main-

1 tained pursuant to section 4(d) of the Statutory Pay-As-  
2 You-Go Act of 2010 (2 U.S.C. 933(d)).

3 (b) SENATE PAYGO SCORECARDS.—The budgetary  
4 effects of this Act shall not be entered on any PAYGO  
5 scorecard maintained for purposes of section 4106 of H.  
6 Con. Res. 71 (115th Congress).
