A BILL

To regulate assault weapons, to ensure that the right to keep and bear arms is not unlimited, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Assault Weapons Ban*
5 *of 2022”.*

6 **SEC. 2. DEFINITIONS.**

7 *(a) IN GENERAL.—Section 921(a) of title 18, United*
8 *States Code, is amended by adding at the end the following:*

9 *“(38) The term ‘semiautomatic pistol’ means any re-*
10 *peating pistol that—*

11 *“(A) utilizes a portion of the energy of a firing*
12 *cartridge to extract the fired cartridge case and cham-*
13 *ber the next round; and*

14 *“(B) requires a separate pull of the trigger to*
15 *fire each cartridge.*

16 *“(39) The term ‘semiautomatic shotgun’ means any re-*
17 *peating shotgun that—*

18 *“(A) utilizes a portion of the energy of a firing*
19 *shell to extract the fired shell casing and chamber the*
20 *next round; and*

21 *“(B) requires a separate pull of the trigger to*
22 *fire each shell.*

23 *“(40) The term ‘semiautomatic assault weapon’ means*
24 *any of the following, regardless of country of manufacture*
25 *or caliber of ammunition accepted:*

1 “(A) *A semiautomatic rifle that—*

2 “(i) *has the capacity to accept a detachable*
3 *ammunition feeding device; and*

4 “(ii) *has any 1 of the following:*

5 “(I) *A pistol grip.*

6 “(II) *A forward grip.*

7 “(III) *A folding, telescoping, or detach-*
8 *able stock, or a stock that is otherwise*
9 *foldable or adjustable in a manner that op-*
10 *erates to reduce the length, size, or any*
11 *other dimension, or otherwise enhances the*
12 *concealability, of the weapon.*

13 “(IV) *A grenade launcher.*

14 “(V) *A barrel shroud.*

15 “(VI) *A threaded barrel.*

16 “(B) *A semiautomatic rifle that has a fixed am-*
17 *munition feeding device with the capacity to accept*
18 *more than 15 rounds, except for an attached tubular*
19 *device designed to accept, and capable of operating*
20 *only with, .22 caliber rimfire ammunition.*

21 “(C) *Any part, combination of parts, component,*
22 *device, attachment, or accessory that is designed or*
23 *functions to accelerate the rate of fire of a semiauto-*
24 *matic firearm but not convert the semiautomatic fire-*
25 *arm into a machinegun.*

1 “(D) *A semiautomatic pistol that—*

2 “(i) *has an ammunition feeding device that*
3 *is not a fixed ammunition feeding device; and*

4 “(ii) *has any 1 of the following:*

5 “(I) *A threaded barrel.*

6 “(II) *A second pistol grip.*

7 “(III) *A barrel shroud.*

8 “(IV) *The capacity to accept a detach-*
9 *able ammunition feeding device at some lo-*
10 *cation outside of the pistol grip.*

11 “(V) *A semiautomatic version of an*
12 *automatic firearm.*

13 “(VI) *A manufactured weight of 50*
14 *ounces or more when unloaded.*

15 “(VII) *A buffer tube, stabilizing brace*
16 *or similar component that protrudes hori-*
17 *zontally behind the pistol grip.*

18 “(E) *A semiautomatic pistol with a fixed ammu-*
19 *nition feeding device that has the capacity to accept*
20 *more than 15 rounds.*

21 “(F) *A semiautomatic shotgun that—*

22 “(i) *has the capacity to accept a detachable*
23 *ammunition feeding device or a fixed ammu-*
24 *nition feeding device that has the capacity to ac-*
25 *cept more than 5 rounds; and*

1 “(ii) has any 1 of the following:

2 “(I) A folding, telescoping, or detach-
3 able stock.

4 “(II) A pistol grip or bird’s head grip.

5 “(III) A forward grip.

6 “(IV) A grenade launcher.

7 “(G) Any shotgun with a revolving cylinder.

8 “(H) All of the following rifles, copies, dupli-
9 cates, variants, or altered facsimiles with the capa-
10 bility of any such weapon thereof:

11 “(i) All AK types, including the following:

12 “(I) AK, AK47, AK47S, AK-74, AKM,

21 *changed, or converted to accept, more than 15 rounds*
22 *of ammunition; and*

23 “(B) *does not include an attached tubular device*
24 *designed to accept, and capable of operating only*
25 *with, .22 caliber rimfire ammunition.”.*

1 (b) *RELATED DEFINITIONS.*—Section 921(a) of title
2 18, United States Code, as amended by this Act, is amended
3 by adding at the end the following:

4 “(42) The term ‘barrel shroud’—

5 “(A) means a shroud that is attached to, or par-
6 tially or completely encircles, the barrel of a firearm
7 so that the shroud protects the user of the firearm
8 from heat generated by the barrel; and

9 “(B) does not include—

10 “(i) a slide that partially or completely en-
11 closes the barrel; or

12 “(ii) an extension of the stock along the bot-
13 tom of the barrel which does not encircle or sub-
14 stantially encircle the barrel.

15 “(43) The term ‘detachable ammunition feeding device’
16 means an ammunition feeding device that can be removed
17 from a firearm without disassembly of the firearm action.

18 “(44) The term ‘fixed ammunition feeding device’
19 means an ammunition feeding device that is contained in
20 and not removable from or is permanently fixed to the fire-
21 arm, but does not include an attached tubular device de-
22 signed to accept, and capable of operating only with, .22
23 caliber rimfire ammunition.

24 “(45) The term ‘folding, telescoping, or detachable
25 stock’ means a stock that folds, telescopes, detaches or other-

1 *wise operates to reduce the length, size, or any other dimen-*
2 *sion, or otherwise enhances the concealability, of a firearm.*

3 “(46) *The term ‘forward grip’ means a grip located*
4 *forward of the trigger that functions as a pistol grip.*

5 “(47) *The term ‘grenade launcher’ means an attach-*
6 *ment for use on a firearm that is designed to propel a gre-*
7 *nade or other similar destructive device.*

8 “(48) *The term ‘permanently inoperable’ means a fire-*
9 *arm which is incapable of discharging a shot by means of*
10 *an explosive and incapable of being readily restored to a*
11 *firing condition.*

12 “(49) *The term ‘pistol grip’ means a grip, a thumbhole*
13 *stock or Thordsen-type grip or stock, or any other char-*
14 *acteristic that can function as a grip.*

15 “(50) *The term ‘threaded barrel’ means a feature or*
16 *characteristic that is designed in such a manner to allow*
17 *for the attachment of a device such as a firearm silencer*
18 *or a flash suppressor.*

19 “(51) *The term ‘qualified law enforcement officer’ has*
20 *the meaning given the term in section 926B.*

21 “(52) *The term ‘grandfathered semiautomatic assault*
22 *weapon’ means any semiautomatic assault weapon the im-*
23 *portation, possession, sale, or transfer of which would be*
24 *unlawful under section 922(v) but for the exception under*
25 *paragraph (2) of such section.*

1 “(53) *The term ‘belt-fed semiautomatic firearm’ means*
 2 *any repeating firearm that—*

3 “(A) *utilizes a portion of the energy of a firing*
 4 *cartridge to extract the fired cartridge case and cham-*
 5 *ber the next round;*

6 “(B) *requires a separate pull of the trigger to*
 7 *fire each cartridge; and*

8 “(C) *has the capacity to accept a belt ammuni-*
 9 *tion feeding device.”.*

10 **SEC. 3. RESTRICTIONS ON ASSAULT WEAPONS AND LARGE**
 11 **CAPACITY AMMUNITION FEEDING DEVICES.**

2 or slide action, except for a shotgun described in sec-
3 tion 921(a)(40)(G);

4 “(B) has been rendered permanently inoperable;

5 “(C) is an antique firearm, as defined in section
6 921 of this title; or

7 “(D) is only capable of firing rimfire ammuni-
8 tion.

9 “(4) Paragraph (1) shall not apply to—

10 “(A) the importation for, manufacture for, sale
11 to, transfer to, or possession by the United States or
12 a department or agency of the United States or a

11 *“(i) sold or transferred to the individual by*
12 *the agency upon such retirement; or*

13 *“(ii) that the individual purchased, or oth-*
14 *erwise obtained, for official use before such re-*
15 *tirement;*

16 *“(D) the importation, sale, manufacture, trans-*
17 *fer, or possession of a semiautomatic assault weapon*
18 *by a licensed manufacturer or licensed importer for*
19 *the purposes of testing or experimentation authorized*
20 *by the Attorney General; or*

21 *“(E) the importation, sale, manufacture, trans-*
22 *fer, or possession of a firearm specified in Appendix*
23 *A to this section, as such firearm was manufactured*
24 *on the date of introduction of the Assault Weapons*
25 *Ban of 2022.*

1 “(5) *For purposes of paragraph (4)(A), the term ‘cam-*
2 *pus law enforcement officer’ means an individual who is—*

3 “(A) *employed by a private institution of higher*
4 *education that is eligible for funding under title IV*
5 *of the Higher Education Act of 1965 (20 U.S.C. 1070*
6 *et seq.);*

7 “(B) *responsible for the prevention or investiga-*
8 *tion of crime involving injury to persons or property,*
9 *including apprehension or detention of persons for*
10 *such crimes;*

11 “(C) *authorized by Federal, State, or local law*
