# **A BILL**

To amend the Federal Water Pollution Control Act to reauthorize the Lake Pontchartrain Basin Restoration Program, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. LAKE PONTCHARTRAIN BASIN RESTORATION**  
4 **PROGRAM REAUTHORIZATION.**

5 (a) REVIEW OF COMPREHENSIVE MANAGEMENT  
6 PLAN.—Section 121 of the Federal Water Pollution Con-  
7 trol Act (33 U.S.C. 1273) is amended—

8 (1) in subsection (c)—

9 (A) in paragraph (5), by striking “; and”  
10 and inserting a semicolon;

11 (B) in paragraph (6), by striking the pe-  
12 riod and inserting “; and”; and

13 (C) by adding at the end the following:

14 “(7) ensure that the comprehensive conserva-  
15 tion and management plan approved for the Basin  
16 under section 320 is reviewed and revised in accord-  
17 ance with section 320 not less often than once every  
18 5 years, beginning on the date of enactment of this  
19 paragraph.”; and

20 (2) in subsection (d), by striking “recommended  
21 by a management conference convened for the Basin  
22 under section 320” and inserting “identified in the  
23 comprehensive conservation and management plan  
24 approved for the Basin under section 320”.

1 (b) DEFINITIONS.—Section 121(e)(1) of the Federal  
2 Water Pollution Control Act (33 U.S.C. 1273(e)(1)) is  
3 amended by striking “, a 5,000 square mile”.

4 (c) AUTHORIZATION OF APPROPRIATIONS.—Section  
5 121(f) of the Federal Water Pollution Control Act (33  
6 U.S.C. 1273(f)) is amended—

7 (1) in paragraph (1), by striking “2001  
8 through 2012 and the amount appropriated for fis-  
9 cal year 2009 for each of fiscal years 2013 through  
10 2017” and inserting “2022 through 2026”; and

11 (2) by adding at the end the following:

12 “(3) ADMINISTRATIVE EXPENSES.—The Ad-  
13 ministrator may use for administrative expenses not  
14 more than 5 percent of the amounts appropriated to  
15 carry out this section.”.
