A BILL

To rescind amounts appropriated under the American Rescue Plan Act of 2021, and for other purposes.

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Proudly Eliminating
5 Liberal Objective Spending Items Rescissions Act of
6 2021” or the “PELOSI Rescissions Act of 2021”.

1 **SEC. 2. RESCISSIONS OF AMERICAN RESCUE PLAN ACT OF**

3 There are hereby rescinded, from amounts appro-
