## AN ACT

To direct the Secretary of the Interior to convey to the City of Eunice, Louisiana, certain Federal land in Louisiana, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Save the Liberty The-  
3 atre Act of 2021”.

4 **SEC. 2. DEFINITIONS.**

5 In this Act:

6 (1) CITY.—The term “City” means the City of  
7 Eunice, Louisiana.

8 (2) MAP.—The term “map” means the map en-  
9 titled “Jean Lafitte National Historical Park and  
10 Preserve, Proposed Boundary Revision and Dis-  
11 posal”, numbered 467/168813, and dated December  
12 2020.

13 (3) SECRETARY.—The term “Secretary” means  
14 the Secretary of the Interior.

15 **SEC. 3. LAND CONVEYANCE.**

16 (a) CONVEYANCE AUTHORITY.—The Secretary shall  
17 convey to the City, by quitclaim deed and without consid-  
18 eration, all right, title, and interest of the United States  
19 in and to the parcels of land described in subsection (b).

20 (b) DESCRIPTION OF LAND.—The parcels of land re-  
21 ferred to in subsection (a) are Lots 5 and 6, less the North  
22 27 feet of Lot 5, Block 22, of the Original Townsite of  
23 Eunice, generally depicted as “Proposed Disposal Area”  
24 on the map.

1       (c) AVAILABILITY OF MAP.—The map shall be on file  
2 and available for public inspection in the appropriate of-  
3 fices of the National Park Service.

4 **SEC. 4. BOUNDARY ADJUSTMENTS.**

5       Upon the conveyance to the City of the land described  
6 in section 3(b), the boundary of the Jean Lafitte National  
7 Historical Park and Preserve shall be adjusted to ex-  
8 clude—

9               (1) the conveyed land; and

10              (2) Lots 7 and 8 of the Original Townsite of  
11 Eunice generally depicted as “Non-NPS in Current  
12 Boundary” on the map.
