**AN ACT**

Making emergency supplemental appropriations for the fiscal year ending September 30, 2021, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2       *tives of the United States of America in Congress assembled,*  
3       That the following sums are appropriated, out of any  
4       money in the Treasury not otherwise appropriated, for the  
5       fiscal year ending September 30, 2021, and for other pur-  
6       poses, namely:

1           TITLE I—LEGISLATIVE BRANCH  
2           CHAPTER 1—SECURITY RELATED  
3           SUPPLEMENTAL APPROPRIATIONS  
4           SENATE  
5           CONTINGENT EXPENSES OF THE SENATE

6   SERGEANT AT ARMS AND DOORKEEPER OF THE SENATE

7       For an additional amount for “Sergeant at Arms and  
8   Doorkeeper of the Senate”, \$16,490,000, to remain avail-  
9   able until expended, to respond to the attack on the  
10   United States Capitol Complex that occurred on January  
11   6, 2021, and which shall be allocated in accordance with  
12   a spend plan submitted to the Committee on Appropria-  
13   tions of the Senate: *Provided*, That such sums, as nec-  
14   essary, may be used to restore amounts, either directly  
15   or through reimbursement, for obligations incurred by the  
16   Sergeant at Arms and Doorkeeper of the Senate prior to  
17   the date of enactment of this Act: *Provided further*, That  
18   such amount is designated by the Congress as being for  
19   an emergency requirement pursuant to section  
20   251(b)(2)(A)(i) of the Balanced Budget and Emergency  
21   Deficit Control Act of 1985.

22           HOUSE OF REPRESENTATIVES  
23           ALLOWANCES AND EXPENSES

24       For an additional amount for “Allowances and Ex-  
25   penses”, \$22,186,000, to remain available until September

1 30, 2022, to respond to the attack on the United States  
2 Capitol Complex that occurred on January 6, 2021, and  
3 for necessary expenses for business continuity and disaster  
4 recovery, to be allocated in accordance with a spend plan  
5 submitted to the Committee on Appropriations of the  
6 House of Representatives by the Chief Administrative Of-  
7 ficer and approved by such Committee: *Provided*, That of  
8 such amount, such sums as necessary may be used to re-  
9 store amounts, either directly or through reimbursement,  
10 for obligations incurred for such purposes by the Sergeant  
11 at Arms of the House of Representatives prior to the date  
12 of the enactment of this Act: *Provided further*, That of  
13 such amount, not more than \$500,800 may be transferred  
14 to the Office of Employee Assistance pursuant to section  
15 101(a) of the Legislative Branch Appropriations Act,  
16 1993 (2 U.S.C. 5507(a)), effective upon the expiration of  
17 the 10-day period which begins on the date the Chief Ad-  
18 ministrative Officer notifies the Committee on Appropria-  
19 tions of the transfer: *Provided further*, That such amount  
20 is designated by the Congress as being for an emergency  
21 requirement pursuant to section 251(b)(2)(A)(i) of the  
22 Balanced Budget and Emergency Deficit Control Act of  
23 1985.

## ADMINISTRATIVE PROVISION

## ENHANCED SECURITY FOR MEMBERS OF CONGRESS

SEC. 101. (a) AUTHORIZING USE OF FUNDS.—Subject to subsection (b), the Office of the Sergeant at Arms of the House of Representatives may use amounts which are appropriated or otherwise made available for the operations of the Office during a fiscal year to carry out security enhancements deemed necessary for the protection of Members of Congress including the Delegates and the Resident Commissioner of Congress only if the enhancement is deemed necessary by the Sergeant at Arms of the House of Representatives.

(b) REGULATIONS.—The Committee on House Administration of the House of Representatives shall have the authority to prescribe regulations to carry out this section.

(c) EFFECTIVE DATE.—This section shall take effect on the date on which the Committee on House Administration prescribes regulations under subsection (b) to carry out this section, and shall apply with respect to the fiscal year in which the Committee prescribes the regulations and each succeeding fiscal year.

## CAPITOL POLICE

## SALARIES

(INCLUDING TRANSFER OF FUNDS)

For an additional amount for “Salaries”, \$37,495,000, to remain available until September 30, 2022, to respond to the aftermath of the attack on the United States Capitol Complex that occurred on January 6, 2021: *Provided*, That amounts made available under this heading in this chapter for the purposes specified hereunder shall be in addition to amounts otherwise available for such purposes: *Provided further*, That of such amount, such sums as necessary may be used to restore amounts, either directly or through reimbursement, for obligations incurred for such purposes by the Capitol Police prior to the date of the enactment of this Act: *Provided further*, That of such amount \$3,600,000 shall remain available until expended for retention bonuses: *Provided further*, That of such amount, up to \$6,900,000 shall be made available for hazard pay for employees of the Capitol Police: *Provided further*, That of such amount, \$1,361,306 shall be made available for the wellness program for the United States Capitol Police: *Provided further*, That amounts provided under this heading in this chapter may be transferred between the headings “Salaries” and “General Expenses” under the heading “Capitol Police” for the

1 purposes specified under this heading in this chapter in  
2 accordance with section 1001 of the Legislative Branch  
3 Appropriations Act, 2014 (2 U.S.C. 1907a): *Provided fur-*  
4 *ther*, That such amount is designated by the Congress as  
5 being for an emergency requirement pursuant to section  
6 251(b)(2)(A)(i) of the Balanced Budget and Emergency  
7 Deficit Control Act of 1985.

8 GENERAL EXPENSES

9 (INCLUDING TRANSFER OF FUNDS)

10 For an additional amount for “General Expenses”,  
11 \$41,769,000, to remain available until September 30,  
12 2022, to respond to the aftermath of the attack on the  
13 United States Capitol Complex that occurred on January  
14 6, 2021: *Provided*, That amounts made available under  
15 this heading in this chapter for the purposes specified  
16 hereunder shall be in addition to amounts otherwise avail-  
17 able for such purposes: *Provided further*, That of such  
18 amount, such sums as necessary may be used to restore  
19 amounts, either directly or through reimbursement, for ob-  
20 ligations incurred for such purposes by the Capitol Police  
21 prior to the date of the enactment of this Act: *Provided*  
22 *further*, That of such amounts, \$2,628,000 shall remain  
23 available until expended for physical protection barriers  
24 and various civil disturbance unit equipment: *Provided*  
25 *further*, That such funds which are made available for

1 physical protection barriers under this heading in this  
2 chapter may be transferred to and merged with the Cap-  
3 itol Police Building and Grounds account of the Architect  
4 of the Capitol for similar purposes in accordance with sec-  
5 tion 906 of the 2002 Supplemental Appropriations Act for  
6 Further Recovery From and Response to Terrorist At-  
7 tacks on the United States (2 U.S.C. 1865): *Provided fur-*  
8 *ther*, That of such amount, not less than \$5,000,000 shall  
9 be made available for reimbursable agreements with State  
10 and local law enforcement agencies and not less than  
11 \$4,800,000 shall be available for protective details for  
12 Members of Congress, including Delegates and the Resi-  
13 dent Commissioner to the Congress: *Provided further*,  
14 That amounts provided under this heading in this chapter  
15 may be transferred between the headings “Salaries” and  
16 “General Expenses” under the heading “Capitol Police”  
17 for the purposes specified under this heading in this chap-  
18 ter in accordance with section 1001 of the Legislative  
19 Branch Appropriations Act, 2014 (2 U.S.C. 1907a): *Pro-*  
20 *vided further*, That such amount is designated by the Con-  
21 gress as being for an emergency requirement pursuant to  
22 section 251(b)(2)(A)(i) of the Balanced Budget and  
23 Emergency Deficit Control Act of 1985.

## ADMINISTRATIVE PROVISIONS

## WELLNESS PROGRAM

SEC. 102. (a) APPLICATION OF LAW.—The wellness program of the United States Capitol Police shall be known and designated as the “Howard C. ‘Howie’ Liebengood Center for Wellness”.

(b) EFFECTIVE DATE.—This section shall apply with respect to fiscal year 2021 and each succeeding fiscal year.

REQUIRING UNIFORMED UNITED STATES CAPITOL POLICE OFFICERS TO UTILIZE BODY-WORN CAMERAS WHILE ON DUTY

SEC. 103. (a) REQUIREMENT.—Each uniformed officer of the United States Capitol Police whose job duties include interacting with the general public shall utilize a body-worn camera and ensure that the body-worn camera is activated while on duty.

(b) EXCEPTION FOR OFFICERS ON PERSONAL PROTECTION DETAIL.—Subsection (a) does not apply to an officer during any time in which the officer is serving on a personal protection detail.

(c) REGULATIONS.—

(1) IN GENERAL.—The Capitol Police Board shall promulgate such regulations as may be necessary to carry out this section.

(2) BODY CAMERA FOOTAGE.—The regulations promulgated under paragraph (1) shall include guid-



1       ance on the retention and deletion of video footage  
2       recorded by a body-worn camera utilized by an offi-  
3       cer of the United States Capitol Police.

4               (3) REQUIRING NOTIFICATION PRIOR TO DIS-  
5       CLOSURE OF CERTAIN RECORDED INFORMATION.—

6       The regulations promulgated under paragraph (1)  
7       shall include a requirement that the United States  
8       Capitol Police shall not make any disclosure to any  
9       third party (including a law enforcement agency), in-  
10      cluding any disclosure pursuant to a request by com-  
11      pulsory process, of any video or audio information  
12      relating to the House of Representatives or the Sen-  
13      ate which is recorded by a body-worn camera utilized  
14      by an officer of the United States Capitol Police  
15      until the United States Capitol Police provides no-  
16      tice of the request to, and consults regarding the  
17      disclosure with—

18               (A) in the case of information relating to  
19               the House of Representatives, the Office of the  
20               General Counsel of the House of Representa-  
21               tives and any Member (including a Delegate or  
22               Resident Commissioner), officer, or employee of  
23               the House involved; or

24               (B) in the case of information relating to  
25               the Senate, the Office of Senate Legal Counsel,

1           and any Senator, officer, or employee of the  
2           Senate involved.

3           (d) EFFECTIVE DATE.—This section shall apply with  
4   respect to fiscal year 2021 and each succeeding fiscal year.

5   REPORT ON EVACUATION PROCEDURES OF THE CAPITOL  
6                                   BUILDINGS AND GROUNDS

7           SEC. 104. (a) IN GENERAL.—The appropriate secu-  
8   rity official of the House of Representatives and the Sen-  
9   ate shall submit a report (in the appropriate format) to  
10  the Committee on House Administration of the House of  
11  Representatives, the Committee on Rules and Administra-  
12  tion of the Senate, and the Committees on Appropriations  
13  of the House of Representatives and Senate not later than  
14  60 days after enactment of this Act on the procedures in  
15  place for evacuating the Membership, staff, workforce, and  
16  visitors of the Capitol, the House Office Buildings and the  
17  Senate Office buildings.

18          (b) REQUIREMENTS OF REPORT.—The report ref-  
19  erenced in subsection (a) shall include an assessment of  
20  previous evacuations, plans for evacuations involving civil  
21  disturbances, emergency management and emergency pre-  
22  paredness training and existing emergency action response  
23  plans and policies.

24          (c) CLASSIFICATION OF REPORT.—The report accom-  
25  panying this section shall be submitted in unclassified  
26  form but may be accompanied by a classified annex.

## 2 CAPITAL CONSTRUCTION AND OPERATIONS

## 3 (INCLUDING TRANSFER OF FUNDS)

4 For an additional amount for “Capital Construction  
5 and Operations”, \$221,678,000, to remain available until  
6 September 30, 2023, to respond to the aftermath of the  
7 attack on the United States Capitol Complex that oc-  
8 curred on January 6, 2021: *Provided*, That of such  
9 amount, such sums as necessary may be used to restore  
10 amounts, either directly or through reimbursement, for ob-  
11 ligations incurred for such purposes by the Architect of  
12 the Capitol prior to the date of the enactment of this Act:  
13 *Provided further*, That any such funds transferred by the  
14 Architect pursuant to the authority in the preceding pro-  
15 viso shall be merged with and made available for the same  
16 purposes, and period of availability, as the appropriations  
17 to which the funds are transferred: *Provided further*, That  
18 such amount is designated by the Congress as being for  
19 an emergency requirement pursuant to section  
20 251(b)(2)(A)(i) of the Balanced Budget and Emergency  
21 Deficit Control Act of 1985.

## 22 CAPITOL COMPLEX EMERGENCY RESPONSE AND

## 23 INFRASTRUCTURE SECURITY

24 For an additional amount for “Capitol Complex  
25 Emergency Response and Infrastructure Security”,

1 \$350,000,000, to remain available until expended, for  
2 emergency expenses to respond to necessary requirements  
3 associated with, and the consequences of, the attack on  
4 the United States Capitol Complex that occurred on Janu-  
5 ary 6, 2021, including for the costs of: (1) providing sup-  
6 port for the Architect of the Capitol, the Sergeants at  
7 Arms of the House of Representatives and the Senate, the  
8 United States Capitol Police, and the Library of Congress  
9 in responding to the attack and in preparing for and miti-  
10 gating the effects of similar attacks in the future; (2) re-  
11 pairing public facilities damaged by the attack; (3) secur-  
12 ing vulnerabilities of buildings and infrastructure in the  
13 Complex; and (4) updating and enhancing physical secu-  
14 rity in the Complex, including making revisions to the  
15 landscape design infrastructure of the Complex and oper-  
16 ational readiness: *Provided*, That of such amount  
17 \$100,000,000 shall be deposited into the Capitol Police  
18 Buildings and Grounds Account established under section  
19 906 of the of the 2002 Supplemental Appropriations Act  
20 for Further Recovery From and Response to Terrorist At-  
21 tacks on the United States (2 U.S.C. 1865) for construc-  
22 tion of security screening vestibules at the Capitol Build-  
23 ing, and design and construction of security screening ves-  
24 tibules at the House of Representatives and Senate office  
25 buildings: *Provided further*, That funds made available

1 under this heading may be used for design, installation,  
2 landscape architecture and to maintain a retractable secu-  
3 rity system as part of an interconnected security of the  
4 United States Capitol Grounds and such funds shall not  
5 be used to install permanent above ground fencing around  
6 the perimeter, or any portion thereof, of the United States  
7 Capitol Grounds as described in section 5102 of title 40,  
8 United States Code, in the current fiscal year or any fiscal  
9 year thereafter: *Provided further*, That amounts made  
10 available under this heading for the purposes specified  
11 hereunder shall be in addition to amounts otherwise avail-  
12 able for such purposes: *Provided further*, That as soon as  
13 practicable after the date of the enactment of this Act the  
14 Architect of the Capitol, in coordination with the Chief  
15 Administrative Officer of the House of Representatives  
16 and the Secretary of the Senate, after consultation with  
17 the Sergeants at Arms of the House of Representatives  
18 and the Senate, shall submit to the Speaker of the House  
19 of Representatives, the Minority Leader of the House of  
20 Representatives, the Majority and Minority Leaders of the  
21 Senate and the Chairpersons and ranking minority mem-  
22 bers of the Committees on Appropriations of the House  
23 of Representatives and the Senate, a signed, detailed  
24 spending plan for the use of the funds provided under this  
25 heading for review prior to the implementation of such

1 plan and obligation of any such funds: *Provided further*,  
2 That such spend plan shall be updated and resubmitted  
3 every 90 days (from initial submission) until such time  
4 as all funds have been obligated: *Provided further*, That  
5 none of the funds made available under this heading shall  
6 be available for reprogramming in an amount exceeding  
7 10 percent of the total amount allocated under the most  
8 recent version of such spend plan without the written con-  
9 currence of the Chairpersons and ranking minority mem-  
10 bers of the Committees on Appropriations of the House  
11 of Representatives and the Senate: *Provided further*, That  
12 upon obligating or expending any funds provided under  
13 this heading, the person responsible for the obligation or  
14 expenditure shall notify the Architect of the Capitol Office  
15 of Inspector General of such action: *Provided further*, That  
16 not later than 45 days after the end of any calendar quar-  
17 ter during which amounts provided under this heading are  
18 obligated or expended, the Office of Inspector General  
19 shall review and submit a report on the uses of such funds  
20 during the quarter to the Committee on House Adminis-  
21 tration of the House of Representatives, the Committee  
22 on Rules and Administration of the Senate, and the Com-  
23 mittees on Appropriations of the House of Representatives  
24 and Senate: *Provided further*, That such amount is des-  
25 ignated by the Congress as being for an emergency re-

1 quirement pursuant to section 251(b)(2)(A)(i) of the Bal-  
2 anced Budget and Emergency Deficit Control Act of 1985.

3 ADMINISTRATIVE PROVISION

4 AUTHORITY OF ARCHITECT OF THE CAPITOL TO MAKE  
5 EXPENDITURES IN RESPONSE TO EMERGENCIES

6 SEC. 105. (a) COVERAGE OF COMMUTING EX-  
7 PENSES.—Section 1305(a)(2) of the Legislative Branch  
8 Appropriations Act, 2010 (2 U.S.C. 1827(a)(2)) is amend-  
9 ed by inserting after “refreshments,” the following:  
10 “transportation and other related expenses incurred by  
11 employees in commuting between their residence and their  
12 place of employment,”.

13 (b) EXPANDED AUTHORITY TO PROVIDE SUPPLIES,  
14 PRODUCTS, AND SERVICES.—Section 1305(a) of such Act  
15 (2 U.S.C. 1827(a)) is amended—

16 (1) by striking “and” at the end of paragraph  
17 (1);

18 (2) by striking the period at the end of para-  
19 graph (2) and inserting “; and”; and

20 (3) by adding at the end the following new  
21 paragraph:

22 “(3) accept contributions of, and may incur ob-  
23 ligations and make expenditures out of available ap-  
24 propriations for, supplies, products, and services  
25 necessary to respond to the emergency, which may

1 be provided for the use of any office which is located  
 2 within any building, grounds, or facility for which  
 3 the Architect of the Capitol is responsible for the  
 4 maintenance, care, and operation, on a reimbursable  
 5 or non-reimbursable basis subject to the availability  
 6 of funds.”.

7 (c) EFFECTIVE DATE.—The amendments made by  
 8 subsections (a) and (b) shall apply with respect to fiscal  
 9 year 2021 and each succeeding fiscal year.

### 11 SALARIES AND EXPENSES

#### 12 (INCLUDING TRANSFER OF FUNDS)

13 For an additional amount for “Salaries and Ex-  
 14 penses”, \$13,699,000, to remain available until September  
 15 30, 2022, to respond to the aftermath of the attack on  
 16 the United States Capitol Complex that occurred on Janu-  
 17 ary 6, 2021 on the programs and activities of the Library  
 18 of Congress: *Provided*, That notwithstanding section 1402  
 19 of the Legislative Branch Appropriations Act, 2014 (2  
 20 U.S.C. 132a–3), amounts provided under this heading in  
 21 this chapter may be transferred among the accounts of  
 22 the Library of Congress for the purposes provided under  
 23 this heading in this chapter without the approval of the  
 24 Committees on Appropriations of the House of Represent-  
 25 atives and Senate under section 1402(a) of such Act and



1 shall not be subject to the limitation described in section  
2 1402(b) of such Act: *Provided further*, That such amount  
3 is designated by the Congress as being for an emergency  
4 requirement pursuant to section 251(b)(2)(A)(i) of the  
5 Balanced Budget and Emergency Deficit Control Act of  
6 1985.

16 Appropriations of the Senate and the Senate Committee  
17 on Rules and Administration: *Provided*, That such amount  
18 is designated by the Congress as being for an emergency  
19 requirement pursuant to section 251(b)(2)(A)(i) of the  
20 Balanced Budget and Emergency Deficit Control Act of  
21 1985.

9 *vided*, That notwithstanding section 1001 of the Legisla-  
10 tive Branch Appropriations Act, 2014 (2 U.S.C. 1907a),  
11 amounts provided under this heading in this chapter may  
12 be transferred between the headings “Salaries” and “Gen-  
13 eral Expenses” under the heading “Capitol Police” for the  
14 purposes provided under this heading in this chapter with-  
15 out the approval of the Committees on Appropriations of  
16 the House of Representatives and Senate: *Provided fur-*  
17 *ther*, That such amount is designated by the Congress as  
18 being for an emergency requirement pursuant to section  
19 251(b)(2)(A)(i) of the Balanced Budget and Emergency  
20 Deficit Control Act of 1985.

6 CAPITAL CONSTRUCTION AND OPERATIONS

7 (INCLUDING TRANSFER OF FUNDS)

8 For an additional amount for “Capital Construction  
9 and Operations”, \$99,606,000, to remain available until  
10 September 30, 2022, for necessary expenses of the Archi-  
11 tect of the Capitol to supplement the funding made avail-  
12 able for the purposes described in title IX of Division B  
13 of the Coronavirus Aid, Relief, and Economic Security  
14 (CARES) Act (Public Law 116–136), as amended by sec-  
15 tion 159(3) of the Continuing Appropriations Act, 2021  
16 (134 Stat. 722; Public Law 116–159): *Provided*, That  
17 amounts made available under this heading in this chapter  
18 may be used for the purchase and distribution of supplies  
19 to respond to coronavirus, including, but not limited to,  
20 cleaning and sanitation supplies, masks and face cov-  
21 erings, and other equipment and supplies for distribution  
22 to and use by Congressional offices, committees and visi-  
23 tors, including provisions for travel and other necessary  
24 work carried out by staff in their Congressional Districts  
25 and State Offices, wherever located: *Provided further*,

1 That Congressional offices and committees shall be re-  
 2 sponsible for distributing supplies to their staff in the cor-  
 3 responding Congressional District and State Office: *Pro-*  
 4 *vided further*, That of such amount, such sums as nec-  
 5 essary may be used to restore amounts, either directly or
