Mr. RODNEY DAVIS of Illinois (for himself, Mr. GARCÍA of Illinois, and Mr. LAHOOD) introduced the following bill; which was referred to the Committee on Natural Resources

## A BILL

To modify the boundary of the Lincoln Home National  
Historic Site in the State of Illinois.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Lincoln Home Na-  
5 tional Historic Site Boundary Modification Act”.

6 **SEC. 2. LINCOLN HOME NATIONAL HISTORIC SITE BOUND-**  
7 **ARY MODIFICATION.**

8 Public Law 92–127 (54 U.S.C. 320101 note; 85 Stat.  
9 347) is amended—

10 (1) in the first section—

1 (A) by striking “That, in order to” and in-  
2 serting the following:

3 **“SEC. 1. ESTABLISHMENT OF LINCOLN HOME NATIONAL**  
4 **HISTORIC SITE.**

5 “(a) IN GENERAL.—To”; and

6 (B) by adding at the end the following:

7 “(b) BOUNDARY MODIFICATION.—The boundary of  
8 the Lincoln Home National Historic Site established  
9 under subsection (a) is modified as generally depicted on  
10 the map entitled ‘Proposed Boundary Expansion of the  
11 Lincoln Home National Historic Site’ and dated February  
12 26, 2021.”;

13 (2) in section 2—

14 (A) by striking the section designation and  
15 all that follows through “The” and inserting  
16 the following:

17 **“SEC. 2. ADMINISTRATION.**

18 “(a) IN GENERAL.—The”; and

19 (B) by adding at the end the following:

20 “(b) ACCESSIBILITY.—To improve accessibility, the  
21 Secretary of the Interior shall modify the following areas  
22 located within the boundary of the Lincoln Home National  
23 Historic Site to provide universal design and accessibility  
24 by raising the height of the street to match the height  
25 of the sidewalk with no sloped surfaces:

1           “(1) The intersection at 8th Street and Jackson  
2 Street.

3           “(2) The area in front of the home of Abraham  
4 Lincoln.”; and

5           (3) in section 3, by striking the section designa-  
6 tion and all that follows through “There are” and  
7 inserting the following:

8 **“SEC. 3. AUTHORIZATION OF APPROPRIATIONS.**

9           “‘There are’”.
