Mr. GALLAGHER (for himself, Mr. MALINOWSKI, Ms. STEFANIK, Mr. PANNETTA, Mr. TAYLOR, and Mr. KIM of New Jersey) introduced the following bill; which was referred to the Committee on Armed Services, and in addition to the Committee on Foreign Affairs, for a period to be subsequently determined by the Speaker, in each case for consideration of such provisions as fall within the jurisdiction of the committee concerned

A BILL

To limit the use of funds to reduce the total number of members of the Armed Forces serving on active duty who are deployed to the Republic of Korea, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “United States and Re-
5 public of Korea Alliance Support Act”.

1 **SEC. 2. LIMITATION ON USE OF FUNDS TO REDUCE THE**
2 **TOTAL NUMBER OF MEMBERS OF THE**
3 **ARMED FORCES SERVING ON ACTIVE DUTY**
4 **WHO ARE DEPLOYED TO THE REPUBLIC OF**
5 **KOREA.**

6 (a) SENSE OF CONGRESS.—It is the sense of Con-
7 gress that—

8 (1) it is in the United States national interest
9 to maintain treaty alliances and its forward military
10 presence in the Indo-Pacific region to deter conflict
11 and preserve peace and security;

12 (2) the United States fully stands behind com-
13 mitments to its allies in Northeast Asia as articu-
14 lated in the Mutual Defense Treaty Between the
15 United States and the Republic of Korea and the
16 Treaty of Mutual Cooperation and Security between
17 the United States and Japan;

18 (3) the alliances between the United States and
19 the Republic of Korea and between the United
20 States and Japan form the bedrock of regional sta-
21 bility in the Indo-Pacific region, including with re-
22 spect to the threat posed by North Korea;

23 (4) the withdrawal or significant reduction of
24 United States Armed Forces from the Republic of
25 Korea may risk upsetting the military balance in
26 that region; and

1 (5) Congress should be consulted in advance of
2 any significant changes to the status quo on the Ko-
3 rean Peninsula.

4 (b) LIMITATION.—None of the funds made available
5 to the Department of Defense for fiscal year 2022 may
6 be used to reduce the total number of members of the
7 United States Armed Forces serving on active duty who
8 are deployed to the Republic of Korea below 22,000 un-
9 less—

10 (1) the Secretary of Defense first submits to
11 the appropriate congressional committees a report
12 on—

13 (A) the effect of such reduction on pre-
14 serving deterrence on the Korean Peninsula;

15 (B) the anticipated reaction of North
16 Korea to such reduction;

17 (C) the effect of such reduction on increas-
18 ing incentives for the Republic of Korea to de-
19 velop an independent nuclear deterrent;

20 (D) the effect of such reduction on the
21 long-term military and economic partnership
22 between the United States and the Republic of
23 Korea and the United States and Japan, re-
24 spectively; and

1 (E) the effect of such reduction on the
2 military balance between the United States and
3 the People’s Republic of China and between the
4 United States and the Russian Federation;

5 (2) the Secretary of Defense, in consultation
6 with the Chairman of the Joint Chiefs of Staff, first
7 certifies to the appropriate congressional committees
8 that—

9 (A) such a reduction is in the national se-
10 curity interest of the United States and will not
11 significantly undermine the security of United
12 States allies in the region;

13 (B) the Secretary has appropriately con-
14 sulted with allies of the United States, includ-
15 ing the Republic of Korea and Japan, regarding
16 such a reduction; and

17 (C) the Republic of Korea would be fully
18 capable of defending itself and deterring a con-
19 flict on the Korean Peninsula following such a
20 reduction; and

21 (3) such a reduction supports and is consistent
22 with the most current national defense strategy
23 under section 113 of title 10, United States Code.

1 (c) APPROPRIATE CONGRESSIONAL COMMITTEES DE-
2 FINED.—In this section, the term “appropriate congres-
3 sional committees” means—

4 (1) the Committee on Foreign Affairs and the
5 Committee on Armed Services of the House of Rep-
6 resentatives; and

7 (2) the Committee on Foreign Relations and
8 the Committee on Armed Services of the Senate.
