A BILL

To amend title 49, United States Code, to permit the use of incentive payments to expedite certain federally financed airport development projects.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Expedited Delivery of
5 Airport Infrastructure Act of 2021”.

6 **SEC. 2. ALLOWABLE COST STANDARDS FOR AIRPORT DE-**
7 **VELOPMENT PROJECTS.**

8 (a) IN GENERAL.—Section 47110(b)(1) of title 49,
9 United States Code, is amended—

10 (1) by striking “(1) if the cost necessarily” and
11 inserting “(1)(A) if the cost necessarily”;

12 (2) by striking the semicolon at the end and in-
13 serting “; or”; and

14 (3) by adding at the end the following:

15 “(B) if the cost is an incentive payment in-
16 curred in carrying out the project described in sub-
17 paragraph (A) that is to be provided to a contractor
18 upon early completion of a project, if—

19 “(i) such payment does not exceed the less-
20 er of 5 percent of the initial construction con-
21 tract amount or \$1,000,000;

22 “(ii) the level of contractor’s control of, or
23 access to, the worksite necessary to shorten the
24 duration of the project does not negatively im-
25 pact the operation of the airport;

1 “(iii) the contract specifies application of
2 the incentive structure in the event of unfore-
3 seeable, non-weather delays beyond the control
4 of the contractor;

5 “(iv) nothing in any agreement with the
6 contractor prevents the airport operator from
7 retaining responsibility for the safety, efficiency,
8 and capacity of the airport during the execution
9 of the grant agreement; and

10 “(v) the Secretary determines that the use
11 of an incentive payment is likely to increase air-
12 port capacity or efficiency or result in cost sav-
13 ings as a result of shortening the project’s du-
14 ration;”.

15 (b) TECHNICAL CORRECTION.—Section 47110(e)(7)
16 of title 49, United States Code, is amended in the heading
17 by striking “PARTNERSHIP PROGRAM AIRPORTS” and in-
18 serting “PARTNERSHIP PROGRAM AIRPORTS”.
