A BILL

To direct the Secretary of Agriculture to prioritize the completion of the Continental Divide National Scenic Trail, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Continental Divide*
 5 *Trail Completion Act”.*

6 **SEC. 2. CONTINENTAL DIVIDE NATIONAL SCENIC TRAIL.**

7 *(a) COMPLETION OF TRAIL.—*

8 *(1) IN GENERAL.—Not later than November 10,*
 9 *2028, the Secretary and the Secretary of the Interior*
 10 *shall, to the maximum extent practicable, ensure the*
 11 *completion of the Continental Divide National Scenic*
 12 *Trail as a contiguous route, consistent with the fol-*
 13 *lowing provisions of the National Trails System Act:*

14 *(A) Section 3(a)(2) (16 U.S.C. 1242(a)(2)).*

15 *(B) Section 5(a)(5) (16 U.S.C. 1244(a)(5)).*

16 *(C) Section 7 (16 U.S.C. 1246).*

17 *(2) PRIORITY OF ACTIONS.—The Secretary and*
 18 *the Secretary of the Interior shall, to the maximum*
 19 *extent practicable, take necessary actions to achieve*
 20 *this goal, including the following steps, listed in order*
 21 *of priority:*

22 *(A) Complete the Continental Divide Na-*
 23 *tional Scenic Trail by acquiring land or an in-*
 24 *terest in land, or by encouraging States or local*
 25 *governments to enter into cooperative agreements*

1 *to acquire interests in land, to eliminate gaps be-*
2 *tween sections of the Trail while maintaining the*
3 *nature and purposes of the Trail.*

4 *(B) Optimize the Trail by relocating incom-*
5 *patible existing portions of the Trail on Federal*
6 *land as necessary to provide for maximum out-*
7 *door recreation potential and for the conserva-*
8 *tion and enjoyment of the nationally significant*
9 *scenic, historic, natural, or cultural qualities of*
10 *the areas through which the Trail passes, con-*
11 *sistent with the Trail's nature and purposes.*

12 *(C) Publish maps of the completed Trail*
13 *corridor.*

14 ***(b) TRAIL COMPLETION TEAM.—***

15 *(1) IN GENERAL.—In carrying out subsection*
16 *(a), not later than 1 year after the date of the enact-*
17 *ment of this section, the Secretary, in coordination*
18 *with the Secretary of the Interior, shall establish a*
19 *joint Forest Service and Bureau of Land Management*
20 *trail completion team to work in coordination with*
21 *the Trail Administrator to facilitate the completion*
22 *and optimization of the Trail, pursuant to the pur-*
23 *poses of section 3(a)(2) of the National Trails System*
24 *Act (16 U.S.C. 1242(a)(2)) and the Trail's nature*
25 *and purposes.*

1 (2) *DUTIES OF THE TEAM.*—*The Team shall:*

2 (A) *Implement land and right-of-way ac-*
3 *quisitions, relocations, and trail construction*
4 *consistent with any Optimal Location Review*
5 *for the trail, giving priority to land that—*

6 (i) *eliminates gaps between segments of*
7 *the Trail;*

8 (ii) *may be acquired by the Secretary*
9 *or the Secretary of the Interior by purchase*
10 *from a willing seller, donation, exchange, or*
11 *by cooperative agreement;*

12 (iii) *is best suited for inclusion in the*
13 *Trail corridor in accordance with the pur-*
14 *poses, policies, and provisions of the Na-*
15 *tional Trails System Act (16 U.S.C. 1241 et*
16 *seq.); and*

17 (iv) *has been identified as a segment of*
18 *the Trail on Federal land that should be re-*
19 *located to provide for maximum outdoor*
20 *recreation potential and the conservation*
21 *and enjoyment of the nationally significant*
22 *scenic, historic, natural, or cultural quali-*
23 *ties of the areas through which the Trail*
24 *passes.*

1 (B) *Provide the necessary administrative*
 2 *and technical support to complete the Trail cor-*
 3 *ridor under subsection (a).*

4 (C) *As appropriate, consult with other Fed-*
 5 *eral agencies, Governors of affected States, In-*
 6 *dian Tribes, Land Grants-Mercedes, Acequias,*
 7 *relevant landowners or land users of an acequia*
 8 *or land grant-merced, the Continental Divide*
 9 *Trail Coalition, and other volunteer and non-*
 10 *profit organizations that assist in, or whose*
 11 *members may be affected by, the development,*
 12 *maintenance, and management of the Trail.*

13 (D) *Support the Secretary in the develop-*
 14 *ment of the acquisition and development plan*
 15 *under subsection (c) and annual reports under*
 16 *subsection (f).*

17 (c) *COMPREHENSIVE ACQUISITION AND DEVELOPMENT*

18 *PLAN.—*

19 (1) *IN GENERAL.—Not later than 2 years after*
 20 *the establishment of the Team under subsection (b),*
 21 *the Secretary shall submit to the Committee on Nat-*
 22 *ural Resources of the House of Representatives and*
 23 *the Committee on Energy and Natural Resources of*
 24 *the Senate a comprehensive acquisition and develop-*
 25 *ment plan for the Trail.*

1 (2) *CONTENTS OF PLAN.*—*The comprehensive ac-*
 2 *quisition and development plan should—*

3 (A) *identify any gaps in the Trail where*
 4 *the Secretary and the Secretary of the Interior*
 5 *have not been able to acquire land or interests in*
 6 *land by purchase from a willing seller, by dona-*
 7 *tion, by exchange, or by cooperative agreement;*

8 (B) *include a plan for closing such gaps by*
 9 *acquiring lands or interests in land; and*

10 (C) *include general and site-specific devel-*
 11 *opment plans, including anticipated costs.*

12 (d) *METHOD OF ACQUISITION.*—*In carrying out this*
 13 *section, the Secretary and the Secretary of the Interior—*

14 (1) *may acquire land only by purchase from a*
 15 *willing seller with donated or appropriated funds, by*
 16 *donation, or by exchange; and*

17 (2) *may not acquire land by eminent domain.*

18 (e) *MAINTAINING EXISTING PARTNERSHIPS.*—*In car-*
 19 *rying out this section, the Secretary, the Secretary of the*
 20 *Interior, and the Team shall continue to maintain and de-*
 21 *velop working relationships with volunteer and nonprofit*
 22 *organizations that assist in the development, maintenance,*
 23 *and management of the Trail.*

24 (f) *REPORTS.*—*Not later than September 30, 2024,*
 25 *and at the close of each fiscal year until the acquisition*

1 *and development plan is fully implemented, the Secretary*
2 *shall report on the following, in writing, to the Committee*
3 *on Natural Resources of the House of Representatives and*
4 *the Committee on Energy and Natural Resources of the Sen-*
5 *ate:*

6 (1) *The progress in acquiring land or interests*
7 *in land to complete the Trail consistent with this Act.*

8 (2) *The amount of land or interests in land ac-*
9 *quired during the fiscal year and the amount ex-*
10 *pende for such land or interests in land.*

11 (3) *The amount of land or interests in land*
12 *planned for acquisition in the ensuing fiscal year and*
13 *the estimated cost of such land or interests in land.*

14 (4) *The estimated amount of land or interests in*
15 *land remaining to be acquired.*

16 (5) *The amount of existing Trail miles on Fed-*
17 *eral lands that need to be relocated to provide for*
18 *maximum outdoor recreation potential and for con-*
19 *servation and enjoyment of the nationally significant*
20 *scenic, historic, natural, or cultural qualities of the*
21 *areas through which the Trail passes.*

22 (g) *DEFINITIONS.—In this section:*

23 (1) *ACEQUIA.—The term “acequia” has the*
24 *meaning of the term “community ditch” as such term*

1 *is defined under section 73-2-27 of the New Mexico*
 2 *Statutes.*

3 (2) *LAND GRANT-MERCED.*—*The term “land*
 4 *grant-merced” means a community land grant issued*
 5 *under the laws or customs of the Government of*
 6 *Spain or Mexico that is recognized under chapter 49*
 7 *of the New Mexico Statutes (or a successor statute).*

8 (3) *OPTIMAL LOCATION REVIEW.*—*The term “Op-*
 9 *timal Location Review” means the procedures de-*
 10 *scribed in the Continental Divide National Scenic*
 11 *Trail Optimal Location Review Guide, dated Novem-*
 12 *ber 2017.*

13 (4) *SECRETARY.*—*The term “Secretary” means*
 14 *the Secretary of Agriculture, acting through the Chief*
 15 *of the Forest Service.*

16 (5) *TEAM.*—*The term “Team” means the trail*
 17 *completion team established under subsection (b).*

18 (6) *TRAIL.*—*The term “Trail” means the Conti-*
 19 *ental Divide National Scenic Trail established by*
 20 *section 5 of the National Trails System Act (16*
 21 *U.S.C. 1244).*

Amend the title so as to read: “A bill to direct the Secretary of Agriculture and the Secretary of the Interior to prioritize the completion of the Continental Divide National Scenic Trail, and for other purposes.”.
