AN ACT

To provide an extension of Federal-aid highway, highway safety, and transit programs, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Further Surface
3 Transportation Extension Act of 2021”.

4 **SEC. 2. AMENDMENT TO THE EXTENSION END DATE.**

5 Section 2(2) of the Surface Transportation Extension
6 Act of 2021 (Public Law 117–44) is amended by striking
7 “October 31, 2021” and inserting “December 3, 2021”.

8 **SEC. 3. AMENDMENT FOR FEDERAL EMPLOYEE COMPENSA-**

9 **TION FOLLOWING HIGHWAY TRUST FUND EX-**

10 **PIRATION.**

11 Section 108(b) of the Surface Transportation Exten-
12 sion Act of 2021 (Public Law 117–44) is amended by
13 striking “that begins” and all that follows through the pe-
14 riod at the end and inserting the following: “that begins
15 on—

16 “(1) October 1, 2021, and ends on or before
17 the date of enactment of this Act; or

18 “(2) November 1, 2021, and ends on or before
19 the date of enactment of the Further Surface Trans-
20 portation Extension Act of 2021.”.

1 **SEC. 4. EXTENSION OF EXPENDITURE AUTHORITY FOR THE**
2 **HIGHWAY TRUST FUND, SPORT FISH RES-**
3 **TORATION AND BOATING TRUST FUND, AND**
4 **LEAKING UNDERGROUND STORAGE TANK**
5 **TRUST FUND.**

6 (a) HIGHWAY TRUST FUND.—Section 9503 of the
7 Internal Revenue Code of 1986 is amended—

8 (1) in subsections (b)(6)(B), (c)(1), and (e)(3)
9 by striking “November 1, 2021” and inserting “De-
10 cember 4, 2021”; and

11 (2) by striking “Surface Transportation Exten-
12 sion Act of 2021” each place it appears and insert-
13 ing “Further Surface Transportation Extension Act
14 of 2021”.

15 (b) SPORT FISH RESTORATION AND BOATING TRUST
16 FUND.—Section 9504 of such Code is amended—

17 (1) in subsection (b)(2) by striking “Surface
18 Transportation Extension Act of 2021” each place it
19 appears and inserting “Further Surface Transpor-
20 tation Extension Act of 2021”; and

21 (2) in subsection (d)(2) by striking “November
22 1, 2021” and inserting “December 4, 2021”.

23 (c) LEAKING UNDERGROUND STORAGE TANK TRUST
24 FUND.—Section 9508(e)(2) of such Code is amended by
25 striking “November 1, 2021” and inserting “December 4,
26 2021”.

1 (d) SPECIAL RULE FOR AMENDMENTS.—On the date
2 of enactment of H.R. 3684 (117th Congress)—

3 (1) subsections (a), (b), and (c) of this section,
4 the amendments made by such subsections, section
5 201 of the Surface Transportation Extension Act of
6 2021 (Public Law 117–44), and the amendments
7 made by such section shall cease to be effective;

8 (2) the text of the laws amended by subsections
9 (a), (b), and (c) of this section and section 201 of
10 the Surface Transportation Extension Act of 2021
11 (Public Law 117–44) shall revert back so as to read
12 as the text read on September 30, 2021; and

13 (3) the amendments made by H.R. 3684 (117th
14 Congress) shall be executed as if this section and
15 section 201 of the Surface Transportation Extension
16 Act had not been enacted.

17 (e) CONFORMING AMENDMENT.—Section 201 of the
18 Surface Transportation Extension Act of 2021 (Public
19 Law 117–44) is amended by striking subsection (d).

1 **SEC. 5. PRIOR ENACTED AUTHORIZATION.**

2 If H.R. 3684 (117th Congress) is enacted before the
3 date of enactment of this Act, this Act shall not take effect
4 and the provisions of this Act shall not be executed.
