AN ACT

To require the United States Postal Service to continue selling the Multinational Species Conservation Funds Semipostal Stamp until all remaining stamps are sold, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. SHORT TITLE.**

2 This Act may be cited as the “Multinational Species
3 Conservation Funds Semipostal Stamp Reauthorization
4 Act of 2021”.

5 **SEC. 2. REAUTHORIZATION; REQUIREMENT TO SELL ALL**
6 **STAMPS.**

7 (a) IN GENERAL.—Section 2(c) of the Multinational
8 Species Conservation Funds Semipostal Stamp Act of
9 2010 (39 U.S.C. 416 note; Public Law 111–241) is
10 amended—

11 (1) in paragraph (2)—

12 (A) by striking “of at least 6 years,”; and

13 (B) by inserting before the period at the
14 end the following: “and ending not earlier than
15 the date on which the United States Postal
16 Service provides notice to Congress under para-
17 graph (5)”;

18 (2) by adding at the end the following:

19 “(5) REQUIREMENT TO SELL ALL STAMPS
20 PRINTED.—

21 “(A) IN GENERAL.—The United States
22 Postal Service shall sell each copy of the Multi-
23 national Species Conservation Fund Semipostal
24 Stamp that the United States Postal Service
25 prints under this Act.

1 “(B) NOTIFICATION OF CONGRESS.—The
2 United States Postal Service shall notify the
3 Committee on Homeland Security and Govern-
4 mental Affairs in the Senate, the Committee on
5 Environment and Public Works of the Senate,
6 the Committee on Oversight and Reform of the
7 House of Representatives, and the Committee
8 on Natural Resources of the House of Rep-
9 resentatives when all copies of the Multinational
10 Species Conservation Fund Semipostal Stamp
11 printed under this Act have been sold.”.

12 (b) RETROACTIVE APPLICABILITY.—The amend-
13 ments made by subsection (a) shall take effect as if en-
14 acted on the day after the date of enactment of the Multi-
15 national Species Conservation Funds Semipostal Stamp
16 Reauthorization Act of 2013 (Public Law 113–165; 128
17 Stat. 1878).

18 **SEC. 3. DETERMINATION OF BUDGETARY EFFECTS.**

19 The budgetary effects of this Act, for the purpose of
20 complying with the Statutory Pay-As-You-Go Act of 2010,
21 shall be determined by reference to the latest statement
22 titled “Budgetary Effects of PAYGO Legislation” for this
23 Act, submitted for printing in the Congressional Record
24 by the Chairman of the House Budget Committee, pro-

- 1 vided that such statement has been submitted prior to the
- 2 vote on passage.
