A BILL

To amend the Radiation Exposure Compensation Act to include certain communities, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Downwinders Parity*
5 *Act of 2021”.*

6 **SEC. 2. INCLUSION UNDER THE RADIATION EXPOSURE**
7 **COMPENSATION ACT.**

8 *Section 4(b)(1) of the Radiation Exposure Compensa-*
9 *tion Act (42 U.S.C. 2210 note; Public Law 101–426) is*
10 *amended—*

11 *(1) in subparagraph (B)—*

12 *(A) by striking “that portion of”; and*

13 *(B) by striking “that consists of townships*
14 *13 through 16 at ranges 63 through 71”; and*

15 *(2) in subparagraph (C), by inserting “all acre-*
16 *age in any county all or part of which is located in”*
17 *before “that part”.*

18 **SEC. 3. REPORT.**

19 *Within 60 days after the date of enactment of this Act,*
20 *the Attorney General shall submit to the relevant commit-*
21 *tees of the House of Representatives and of the Senate a*
22 *report that outlines efforts to educate and conduct outreach*
23 *to persons made newly eligible for benefits under the amend-*
24 *ments made by section 2 of this Act.*
