A BILL

To amend the Omnibus Crime Control and Safe Streets Act of 1968 to authorize public safety officer death benefits to officers suffering from post-traumatic stress disorder or acute stress disorder, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Public Safety Officer*
5 *Support Act of 2022”.*

6 **SEC. 2. FINDINGS.**

7 *Congress finds the following:*

8 (1) *Every day, public safety officers, including*
9 *police officers, firefighters, emergency medical techni-*
10 *cians, and others, work to maintain the safety, health,*
11 *and well-being of the communities they serve.*

12 (2) *This means public safety officers are rou-*
13 *tinely called to respond to stressful and potentially*
14 *traumatic situations, often putting their own lives in*
15 *danger.*

16 (3) *This work not only puts public safety officers*
17 *at-risk for experiencing harm, serious injury, and cu-*
18 *mulative and acute trauma, but also places them at*
19 *up to 25.6 times higher risk for developing post-trau-*
20 *matic stress disorder when compared to individuals*
21 *without such experiences.*

22 (4) *Psychological evidence indicates that law en-*
23 *forcement officers experience significant job-related*
24 *stressors and exposures that may confer increased risk*
25 *for mental health morbidities (such as post-traumatic*

1 *stress disorder and suicidal thoughts, ideation, in-*
2 *tents, and behaviors) and hastened mortality.*

3 *(5) Public safety officers often do not have the re-*
4 *sources or support they need, leaving them at higher*
5 *risk for long-term mental health consequences.*

6 *(6) Whereas, although the Department of Defense*
7 *already considers servicemember suicides to be line-of-*
8 *duty deaths and provides Federal support to eligible*
9 *surviving families, the Federal Government does not*
10 *recognize public safety officer suicides as deaths in the*
11 *line of duty.*

12 *(7) In 2017, the Department of Justice approved*
13 *481 claims under the Public Safety Officers' Benefits*
14 *Program under subpart 1 of part L of title I of the*
15 *Omnibus Crime Control and Safe Streets Act of 1968*
16 *(34 U.S.C. 10281 et seq.), but not one of them for the*
17 *more than 240 public safety officers who died by sui-*
18 *cide that year.*

19 *(8) Public safety officers who have died or are*
20 *disabled as a result of suicide or post-traumatic stress*
21 *disorder do not qualify for the Public Safety Officers'*
22 *Benefits Program, despite the fact that public safety*
23 *officers are more likely to die by suicide than from*
24 *any other line-of-duty cause of death.*

1 **SEC. 3. PUBLIC SAFETY OFFICER DEATH BENEFITS FOR**
2 **POST-TRAUMATIC STRESS DISORDER AND**
3 **ACUTE STRESS DISORDER.**

4 (a) *IN GENERAL.*—Section 1201 of title I of the Omni-
5 bus Crime Control and Safe Streets Act of 1968 (34 U.S.C.
6 10281) is amended by adding at the end the following:

7 “(o) *POST-TRAUMATIC STRESS DISORDER AND ACUTE*
8 *STRESS DISORDER.*—

9 “(1) *DEFINITIONS.*—*In this section:*

10 “(A) *MASS CASUALTY EVENT.*—*The term*
11 *‘mass casualty event’ means an incident result-*
12 *ing in casualties to not fewer than 3 victims, in-*
13 *cluding—*

14 “(i) *an incident that exceeds the nor-*
15 *mal resources for emergency response avail-*
16 *able in the jurisdiction where the incident*
17 *takes place; and*

18 “(ii) *an incident that results in a sud-*
19 *den temporal surge of injured individuals*
20 *necessitating emergency services.*

21 “(B) *MASS FATALITY EVENT.*—*The term*
22 *‘mass fatality event’ means an incident resulting*
23 *in the fatalities of not fewer than 3 individuals*
24 *at 1 or more locations close to one another with*
25 *a common cause.*

1 “(C) *MASS SHOOTING.*—*The term ‘mass*
2 *shooting’ means a multiple homicide incident in*
3 *which not fewer than 3 victims are killed—*

4 “(i) *with a firearm;*

5 “(ii) *within 1 event; and*

6 “(iii) *in 1 or more locations in close*
7 *proximity.*

8 “(D) *EXPOSED.*—*The term ‘exposed’ in-*
9 *cludes—*

10 “(i) *directly experiencing or witnessing*
11 *an event; or*

12 “(ii) *being subjected, in an intense*
13 *way, to aversive consequences of the event*
14 *(including a public safety officer collecting*
15 *human remains).*

16 “(E) *TRAUMATIC EVENT.*—*The term ‘trau-*
17 *matic event’ means, in the case of a public safety*
18 *officer exposed to an event, an event that is—*

19 “(i) *a homicide, suicide, or the violent*
20 *or gruesome death of another individual*
21 *(including such a death resulting from a*
22 *mass casualty event, mass fatality event, or*
23 *mass shooting);*

24 “(ii) *a harrowing circumstance posing*
25 *an extraordinary and significant danger or*

1 *threat to the life of or of serious bodily*
2 *harm to any individual (including such a*
3 *circumstance as a mass casualty event,*
4 *mass fatality event, or mass shooting); or*
5 *“(iii) an act of criminal sexual vio-*
6 *lence committed against any individual.*

7 “(2) *PERSONAL INJURY SUSTAINED IN LINE OF*
8 *DUTY.—As determined by the Bureau—*

9 “(A) *post-traumatic stress disorder, acute*
10 *stress disorder, or trauma and stress related dis-*
11 *orders suffered by a public safety officer and di-*
12 *agnosed by a licensed medical or mental health*
13 *professional, shall be presumed to constitute a*
14 *personal injury within the meaning of subsection*
15 *(a), sustained in the line of duty by the officer,*
16 *if the officer was exposed, while on duty, to one*
17 *or more traumatic events and such exposure was*
18 *a substantial factor in the disorder;*

19 “(B) *post-traumatic stress disorder, acute*
20 *stress disorder, or trauma and stress related dis-*
21 *orders, suffered by a public safety officer who has*
22 *contacted or attempted to contact the employee*
23 *assistance program of the agency or entity that*
24 *the officer serves, a licensed medical or mental*
25 *health professional, suicide prevention services,*

1 *or another mental health assistance service in*
2 *order to receive help, treatment, or diagnosis for*
3 *post-traumatic stress disorder or acute stress dis-*
4 *order, shall be presumed to constitute a personal*
5 *injury within the meaning of subsection (a), sus-*
6 *tained in the line of duty by the officer, if the*
7 *officer, was exposed, while on duty, to one or*
8 *more traumatic events and such exposure was a*
9 *substantial factor in the disorder; and*

10 “(C) *post-traumatic stress disorder, acute*
11 *stress disorder, or trauma and stress related dis-*
12 *orders, suffered by a public safety officer who*
13 *was exposed, while on duty, to one or more trau-*
14 *matic events shall be presumed to constitute a*
15 *personal injury within the meaning of subsection*
16 *(a), sustained in the line of duty by the officer*
17 *if such exposure was a substantial factor in the*
18 *disorder.*

19 “(3) *PRESUMPTION OF DEATH OR TOTAL DIS-*
20 *ABILITY.—A public safety officer shall be presumed to*
21 *have died or become permanently and totally disabled*
22 *(within the meaning of subsection (a) or (b)) as the*
23 *direct and proximate result of a personal injury sus-*
24 *tained in the line of duty, if (as determined by the*
25 *Bureau) the officer either—*

1 “(A) took an action, which action was in-
2 tended to bring about the officer’s death and di-
3 rectly and proximately resulted in such officer’s
4 death or permanent and total disability and ex-
5 posure to one or more traumatic events was a
6 substantial factor in the action taken by the offi-
7 cer; or

8 “(B) took an action within 45 days of the
9 end of exposure to a traumatic event, which ac-
10 tion was intended to bring about the officer’s
11 death and directly and proximately resulted in
12 such officer’s death or permanent and total dis-
13 ability, if such action was not inconsistent with
14 a psychiatric disorder.

15 “(4) *APPLICABILITY OF LIMITATIONS ON BENE-*
16 *FITS.—*

17 “(A) *INTENTIONAL ACTIONS.—*Section
18 1202(a)(1) shall not apply to any claim for a
19 benefit under this part that is payable in accord-
20 ance with this subsection.

21 “(B) *SUBSTANCE USE.—*Section 1202(a)(2)
22 shall not preclude the payment of a benefit under
23 this part if the benefit is otherwise payable in
24 accordance with this subsection.”.

25 (b) *RETROACTIVE APPLICABILITY.—*

1 (1) *IN GENERAL.*—*Except as provided in para-*
2 *graph (2), the amendments made by this section*
3 *shall—*

4 (A) *take effect on the date of enactment of*
5 *this Act; and*

6 (B) *apply to any matter pending, before the*
7 *Bureau of Justice Assistance or otherwise, on the*
8 *date of enactment of this Act, or filed (consistent*
9 *with pre-existing effective dates) or accruing*
10 *after that date.*

11 (2) *EXCEPTIONS.*—*The amendments made by*
12 *this section shall apply to any action taken by a pub-*
13 *lic safety officer described in paragraph (3) of section*
14 *1201(o) of title I of the Omnibus Crime Control and*
15 *Safe Streets Act of 1968 (as added by this Act) that*
16 *occurred on or after January 1, 2019.*

17 **SEC. 4. TECHNICAL FIXES.**

18 (a) *SUBPOENA POWER; EMPLOYMENT OF HEARING*
19 *OFFICERS; AUTHORITY TO HOLD HEARINGS.*—*Section 806*
20 *of title I of the Omnibus Crime Control and Safe Streets*
21 *Act of 1968 is amended by—*

22 (1) *striking “by the Attorney General”;*

23 (2) *inserting “Assistant” before “Attorney” ev-*
24 *erywhere it appears;*

1 (3) striking “Code)” and inserting “Code (with-
2 out regard to the days limitation prescribed therein),
3 but shall, in no event, be understood to be (or to have
4 the authority of) officers of the United States)”;

5 (4) striking “necessary to carry out” and insert-
6 ing “necessary or convenient to assist them in car-
7 rying out”;

8 (5) striking “or any” and inserting “, or (subject
9 to such limitations as the appointing authority may,
10 in its sole discretion, impose from time to time) any”;

11 (6) inserting a comma after “thereby”;

12 (7) striking “duties under this title” and insert-
13 ing “duties under any law administered by or under
14 the Office”;

15 (8) striking “such hearing examiners” the second
16 place it appears; and

17 (9) striking “examinations and” and inserting
18 “examinations, and”.

19 (b) *DEFINITIONS.*—Section 1204 of title I of the Omni-
20 bus Crime Control and Safe Streets Act of 1968 is amend-
21 ed—

22 (1) in paragraph (11), by striking “; and” and
23 inserting “;”;

24 (2) in paragraph (12)(B), by striking “basis.”
25 and inserting “basis;” and

1 (3) in paragraph (14), by redesignating the sec-
2 ond subparagraph (F) as subparagraph (G).

3 **SEC. 5. GAO REPORT.**

4 Not later than 1 year after the date of enactment of
5 this Act, the Comptroller General of the United States shall
6 submit to Congress a report that details benefits issued pur-
7 suant to subsection (o) of section 1201 of title I of the Omni-
8 bus Crime Control and Safe Streets Act of 1968 (34 U.S.C.
9 10281), as added by section 3, and includes any rec-
10 ommendations to improve that subsection.
