# **A BILL**

To establish Department of Homeland Security funding restrictions on institutions of higher education that have a relationship with Confucius Institutes, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*  
 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “DHS Restrictions on*  
 5 *Confucius Institutes and Chinese Entities of Concern Act”.*

6 **SEC. 2. LIMITATIONS ON CONFUCIUS INSTITUTES’ HOST**  
 7 **SCHOOLS.**

8 (a) *DEFINITIONS.—In this section:*

9 (1) *CHINESE ENTITY OF CONCERN.—The term*  
 10 *“Chinese entity of concern” means any university or*  
 11 *college in the People’s Republic of China that—*

12 (A) *is involved in the implementation of*  
 13 *military-civil fusion;*

14 (B) *participates in the Chinese defense in-*  
 15 *dustrial base;*

16 (C) *is affiliated with the Chinese State Ad-*  
 17 *ministration for Science, Technology and Indus-*  
 18 *try for the National Defense;*

19 (D) *receives funding from any organization*  
 20 *subordinate to the Central Military Commission*  
 21 *of the Chinese Communist Party; or*

22 (E) *provides support to any security, de-*  
 23 *fense, police, or intelligence organization of the*  
 24 *Government of the People’s Republic of China or*  
 25 *the Chinese Communist Party.*

1           (2) *CONFUCIUS INSTITUTE*.—The term “Confu-  
 2           *cius Institute*” means a cultural institute funded by  
 3           the Government of the People’s Republic of China.

4           (3) *INSTITUTION OF HIGHER EDUCATION*.—The  
 5           term “institution of higher education” has the mean-  
 6           ing given such term in section 102 of the Higher Edu-  
 7           cation Act of 1965 (20 U.S.C. 1002).

8           (4) *RELATIONSHIP*.—The term “relationship”  
 9           means, with respect to an institution of higher edu-  
 10          cation, any contract awarded, or agreement entered  
 11          into, as well as any in-kind donation or gift, received  
 12          from a Confucius Institute or Chinese entity of con-  
 13          cern.

14          (b) *RESTRICTIONS ON INSTITUTIONS OF HIGHER EDU-*  
 15          *CATION*.—Beginning with the first fiscal year that begins  
 16          after the date that is 12 months after the date of the enact-  
 17          ment of this Act, the Secretary of Homeland Security shall  
 18          ensure that an institution of higher education (referred to  
 19          in this section as an “institution”) which has a relationship  
 20          with a Confucius Institute is ineligible to receive any  
 21          Science and Technology or Research and Development funds  
 22          from the Department of Homeland Security, unless the in-  
 23          stitution terminates the relationship between the institution  
 24          and such Confucius Institute. Upon the termination of such  
 25          a relationship, the institution at issue shall be eligible to

1 *receive Science and Technology or Research and Develop-*  
2 *ment funds from the Department of Homeland Security.*

3       (c) *CHINESE ENTITIES OF CONCERN RELATIONSHIP*  
4 *DISCLOSURES.—Beginning on the date that is 12 months*  
5 *after the date of the enactment of this Act, the Secretary*  
6 *of Homeland Security shall require each institution of high-*  
7 *er education which has a relationship with a Chinese entity*  
8 *of concern that is seeking or receives Science and Tech-*  
9 *nology or Research and Development funds from the De-*  
10 *partment of Homeland Security to notify the Secretary of*  
11 *such relationship. Such notification shall include the fol-*  
12 *lowing with respect to such relationship:*

13           (1) *An identification of the Chinese entity of*  
14 *concern.*

15           (2) *Information relating to the length of such re-*  
16 *lationship.*

17           (3) *A description of the nature of such institu-*  
18 *tion's relationship with such Chinese entity of con-*  
19 *cern, including the monetary value of any contract*  
20 *awarded, or agreement entered into, as well as any*  
21 *in-kind donation or gift, from such Chinese entity of*  
22 *concern.*

23       (d) *ASSISTANCE.—The Secretary of Homeland Secu-*  
24 *rity shall provide outreach and, upon request, technical as-*  
25 *sistance to institutions of higher education relating to com-*

1 *pliance with this Act. In carrying out this subsection, the*  
 2 *Secretary shall provide particular attention to institutions*  
 3 *assisting historically Black colleges and universities (as*  
 4 *such term is defined in part B of section 322(2) of the High-*  
 5 *er Education Act of 1965 (22 U.S.C. 1061(2)), Hispanic*  
 6 *serving institutions (as such term is defined in section 502*  
 7 *of the Higher Education Act of 1965 (20 U.S.C. 1101a)),*  
 8 *Tribal colleges and universities (as such term is defined in*  
 9 *section 316(b) of the Higher Education Act of 1965 (20*  
 10 *U.S.C. 1059c(b)), and other minority serving institutions*  
 11 *(as such defined in section 371(a) of the Higher Education*  
 12 *Act of 1965 (20 U.S.C. 1067q(a))).*

13 *(e) WAIVER.—*

14 *(1) IN GENERAL.—The Secretary of Homeland*  
 15 *Security may waive, on a case-by-case basis, and for*  
 16 *a period of not more than one year, the application*  
 17 *of subsection (b) to an institution of higher education*  
 18 *if the Secretary determines such is in the national se-*  
 19 *curity interests of the United States.*

20 *(2) RENEWAL.—The Secretary of Homeland Se-*  
 21 *curity may annually renew a waiver issued pursuant*  
 22 *to paragraph (1) if the Secretary determines such is*  
 23 *in the national security interests of the United States.*

24 *(3) NOTIFICATION.—If the Secretary of Home-*  
 25 *land Security issues or renews a waiver pursuant to*

1 paragraph (1) or (2), respectively, not later than 30  
2 days after such issuance or renewal, as the case may  
3 be, the Secretary shall provide written notification to  
4 the Committee on Homeland Security of the House of  
5 Representatives and the Committee on Homeland Se-  
6 curity and Governmental Affairs of the Senate re-  
7 garding such issuance or renewal, including a jus-  
8 tification relating thereto.

9 (f) *REPORTS*.—Not later than 18 months after the date  
10 of the enactment of this Act and annually thereafter, the  
11 Secretary of Homeland Security shall report to the Com-  
12 mittee on Homeland Security of the House of Representa-  
13 tives and the Committee on Homeland Security and Gov-  
14 ernmental Affairs of the Senate regarding implementation  
15 of this Act during the immediately preceding 12 month pe-  
16 riod. Each such report shall include information relating  
17 to—

18 (1) the implementation of subsections (b) and  
19 (c), including the information disclosed pursuant to  
20 such subsection (c); and

21 (2) outreach and the provision of technical as-  
22 sistance pursuant to subsection (d).
