RESOLUTION

Providing for consideration of the bill (H.R. 2543) to amend the Federal Reserve Act to add additional demographic reporting requirements, to modify the goals of the Federal Reserve System, and for other purposes; providing for consideration of the bill (H.R. 2773) to amend the Pittman-Robertson Wildlife Restoration Act to make supplemental funds available for management of fish and

wildlife species of greatest conservation need as determined by State fish and wildlife agencies, and for other purposes; providing for consideration of the bill (H.R. 7606) to establish the Office of the Special Investigator for Competition Matters within the Department of Agriculture; and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 2543) to amend the Federal Reserve Act to add additional
4 demographic reporting requirements, to modify the goals
5 of the Federal Reserve System, and for other purposes.
6 All points of order against consideration of the bill are
7 waived. In lieu of the amendment in the nature of a sub-
8 stitute recommended by the Committee on Financial Serv-
9 ices now printed in the bill, an amendment in the nature
10 of a substitute consisting of the text of Rules Committee
11 Print 117–49, modified by the amendment printed in part
12 A of the report of the Committee on Rules accompanying
13 this resolution, shall be considered as adopted. The bill,
14 as amended, shall be considered as read. All points of
15 order against provisions in the bill, as amended, are
16 waived. The previous question shall be considered as or-
17 dered on the bill, as amended, and on any further amend-
18 ment thereto, to final passage without intervening motion
19 except: (1) one hour of debate equally divided and con-
20 trolled by the chair and ranking minority member of the

1 Committee on Financial Services or their respective des-
2 ignees; (2) the further amendments described in section
3 2 of this resolution; (3) the amendments en bloc described
4 in section 3 of this resolution; and (4) one motion to re-
5 commit.

6 SEC. 2. After debate pursuant to the first section of
7 this resolution, each further amendment printed in part
8 B of the report of the Committee on Rules not earlier con-
9 sidered as part of amendments en bloc pursuant to section
10 3 of this resolution shall be considered only in the order
11 printed in the report, may be offered only by a Member
12 designated in the report, shall be considered as read, shall
13 be debatable for the time specified in the report equally
14 divided and controlled by the proponent and an opponent,
15 may be withdrawn by the proponent at any time before
16 the question is put thereon, shall not be subject to amend-
17 ment, and shall not be subject to a demand for division
18 of the question.

19 SEC. 3. It shall be in order at any time after debate
20 pursuant to the first section of this resolution for the chair
21 of the Committee on Financial Services or her designee
22 to offer amendments en bloc consisting of further amend-
23 ments printed in part B of the report of the Committee
24 on Rules accompanying this resolution not earlier disposed
25 of. Amendments en bloc offered pursuant to this section

1 shall be considered as read, shall be debatable for 20 min-
2 utes equally divided and controlled by the chair and rank-
3 ing minority member of the Committee on Financial Serv-
4 ices or their respective designees, shall not be subject to
5 amendment, and shall not be subject to a demand for divi-
6 sion of the question.

7 SEC. 4. All points of order against the further amend-
8 ments printed in part B of the report of the Committee
9 on Rules or amendments en bloc described in section 3
10 of this resolution are waived.

11 SEC. 5. Upon adoption of this resolution it shall be
12 in order to consider in the House the bill (H.R. 2773)
13 to amend the Pittman-Robertson Wildlife Restoration Act
14 to make supplemental funds available for management of
15 fish and wildlife species of greatest conservation need as
16 determined by State fish and wildlife agencies, and for
17 other purposes. All points of order against consideration
18 of the bill are waived. In lieu of the amendment in the
19 nature of a substitute recommended by the Committee on
20 Natural Resources now printed in the bill, an amendment
21 in the nature of a substitute consisting of the text of Rules
22 Committee Print 117–47, modified by the amendment
23 printed in part C of the report of the Committee on Rules
24 accompanying this resolution, shall be considered as
25 adopted. The bill, as amended, shall be considered as read.

1 All points of order against provisions in the bill, as amend-
2 ed, are waived. The previous question shall be considered
3 as ordered on the bill, as amended, and on any further
4 amendment thereto, to final passage without intervening
5 motion except: (1) one hour of debate equally divided and
6 controlled by the chair and ranking minority member of
7 the Committee on Natural Resources or their respective
8 designees; (2) the further amendments described in sec-
9 tion 6 of this resolution; (3) the amendments en bloc de-
10 scribed in section 7 of this resolution; and (4) one motion
11 to recommit.

12 SEC. 6. After debate pursuant to section 5 of this
13 resolution, each further amendment printed in part D of
14 the report of the Committee on Rules not earlier consid-
15 ered as part of amendments en bloc pursuant to section
16 7 of this resolution shall be considered only in the order
17 printed in the report, may be offered only by a Member
18 designated in the report, shall be considered as read, shall
19 be debatable for the time specified in the report equally
20 divided and controlled by the proponent and an opponent,
21 may be withdrawn by the proponent at any time before
22 the question is put thereon, shall not be subject to amend-
23 ment, and shall not be subject to a demand for division
24 of the question.

1 SEC. 7. It shall be in order at any time after debate
2 pursuant to section 5 of this resolution for the chair of
3 the Committee on Natural Resources or his designee to
4 offer amendments en bloc consisting of further amend-
5 ments printed in part D of the report of the Committee
6 on Rules accompanying this resolution not earlier disposed
7 of. Amendments en bloc offered pursuant to this section
8 shall be considered as read, shall be debatable for 20 min-
9 utes equally divided and controlled by the chair and rank-
10 ing minority member of the Committee on Natural Re-
11 sources or their respective designees, shall not be subject
12 to amendment, and shall not be subject to a demand for
13 division of the question.

14 SEC. 8. All points of order against the further amend-
15 ments printed in part D of the report of the Committee
16 on Rules or amendments en bloc described in section 7
17 of this resolution are waived.

18 SEC. 9. Upon adoption of this resolution it shall be
19 in order to consider in the House the bill (H.R. 7606)
20 to establish the Office of the Special Investigator for Com-
21 petition Matters within the Department of Agriculture. All
22 points of order against consideration of the bill are waived.
23 In lieu of the amendment in the nature of a substitute
24 recommended by the Committee on Agriculture now print-
25 ed in the bill, an amendment in the nature of a substitute

1 consisting of the text of Rules Committee Print 117–50,
2 modified by the amendment printed in part E of the report
3 of the Committee on Rules accompanying this resolution,
4 shall be considered as adopted. The bill, as amended, shall
5 be considered as read. All points of order against provi-
6 sions in the bill, as amended, are waived. The previous
7 question shall be considered as ordered on the bill, as
8 amended, and on any further amendment thereto, to final
9 passage without intervening motion except: (1) one hour
10 of debate equally divided and controlled by the chair and
11 ranking minority member of the Committee on Agriculture
12 or their respective designees; (2) the further amendments
13 described in section 10 of this resolution; and (3) one mo-
14 tion to recommit.

15 SEC. 10. After debate pursuant to section 9 of this
16 resolution, each further amendment printed in part F of
17 the report of the Committee on Rules shall be considered
18 only in the order printed in the report, may be offered
19 only by a Member designated in the report, shall be con-
20 sidered as read, shall be debatable for the time specified
21 in the report equally divided and controlled by the pro-
22 ponent and an opponent, may be withdrawn by the pro-
23 ponent at any time before the question is put thereon,
24 shall not be subject to amendment, and shall not be sub-
25 ject to a demand for division of the question. All points

1 of order against the further amendments printed in part
2 F of the report of the Committee on Rules are waived.

3 SEC. 11. House Resolution 188, agreed to March 8,
4 2021 (as most recently amended by House Resolution
5 1153, agreed to June 8, 2022), is amended by striking
6 “June 17, 2022” each place it appears and inserting (in
7 each instance) “June 22, 2022”.
