## RESOLUTION

Denouncing domestic terrorist violence against religious organizations and domestic terrorist violence against groups and organizations providing pregnancy support for expectant mothers, and for other purposes.

Whereas, on May 2, 2022, a Supreme Court draft decision regarding abortion was leaked;

Whereas, on May 3, 2022, the Sacred Heart of Mary was vandalized in Boulder, Colorado;

Whereas, on May 3, 2022, the CareNet Pregnancy Center was vandalized in Frederick, Maryland;

Whereas, on May 3, 2022, the Trotter House pregnancy help center was vandalized in Austin, Texas;

Whereas, on May 7, 2022, the Loreto House Pregnancy Resource Center was vandalized in Denton, Texas;

Whereas, on May 8, 2022, the Wisconsin Family Action office was set on fire in Madison, Wisconsin;

Whereas, on May 8, 2022, the Oregon Right to Life office was set on fire in Keizer, Oregon;

Whereas, on May 8, 2022, First Care Women's Health was vandalized in Manassas, Virginia;

Whereas, on May 10, 2022, the Concerned Women for America's office was vandalized in Alexandria, Virginia;

Whereas, on May 14, 2022, the Alpha Pregnancy Center was vandalized in Reisterstown, Maryland;

Whereas, on May 22, 2022, Calvary Chapel was vandalized in Olympia, Washington;

Whereas, on May 22, 2022, the Church of Jesus Christ of Latter-day Saints was vandalized in Olympia, Washington;

Whereas, on May 22, 2022, Harbor Church was vandalized in Olympia, Washington;

Whereas, on May 22, 2022, St. Michael Catholic Church was vandalized in Olympia, Washington;

Whereas, on May 25, 2022, the Next Step Pregnancy Center was vandalized in Lynnwood, Washington;

Whereas, on June 2, 2022, Agape Pregnancy Resource Center was vandalized in Des Moines, Iowa;

Whereas, on June 3, 2022, the Capitol Hill Pregnancy Center was vandalized in Washington, DC;

Whereas, on June 6, 2022, Mountain Area Pregnancy Services was vandalized in Asheville, North Carolina;

Whereas, on June 7, 2022, the CompassCare Pregnancy Services facility was set on fire in Buffalo, New York;

Whereas, on June 8, 2022, there was an attempted assassination of Supreme Court Associate Justice Brett Kavanaugh;

Whereas, on June 10, 2022, the Gresham Pregnancy Resource Center was set on fire in Gresham, Oregon;

Whereas political commentators conflate protecting the lives of the unborn and support for organized religious groups with an opposition to women's rights;

Whereas the would-be assassin of Supreme Court Associate Justice Brett Kavanaugh cited the leaked Supreme Court draft decision as a motivating factor in his decision to attempt murder; and

Whereas the Federal Bureau of Investigation defines domestic terrorism as “violent, criminal acts committed by individuals and/or groups to further ideological goals stemming from domestic influences, such as those of a political, religious, social, racial, or environmental nature”:  
Now, therefore, be it

1       *Resolved*, That the House of Representatives—

2               (1) denounces domestic terrorist violence  
3       against religious organizations;

4               (2) denounces domestic terrorist violence  
5       against groups and organizations providing preg-  
6       nancy support for expectant mothers;

1           (3) encourages the Department of Justice and  
2           Federal Bureau of Investigation to appropriately in-  
3           vestigate and prosecute domestic terrorists targeting  
4           religious organizations and pregnancy support  
5           groups; and

6           (4) encourages the National Security Council to  
7           update the June 2021 “National Strategy for Coun-  
8           tering Domestic Terrorism” with provisions related  
9           to preventing domestic terrorism operations against  
10          religious organizations and pregnancy support  
11          groups.
