## RESOLUTION

Providing for consideration of the bill (H.R. 803) to designate certain lands in the State of Colorado as components of the National Wilderness Preservation System, and for other purposes, and providing for consideration of the bill (H.R. 5) to prohibit discrimination on the basis of sex, gender identity, and sexual orientation, and for other purposes.

1       *Resolved*, That upon adoption of this resolution it  
2 shall be in order to consider in the House the bill (H.R.  
3 803) to designate certain lands in the State of Colorado

1 as components of the National Wilderness Preservation  
2 System, and for other purposes. All points of order against  
3 consideration of the bill are waived. An amendment in the  
4 nature of a substitute consisting of the text of Rules Com-  
5 mittee Print 117-2, modified by the amendment printed  
6 in part A of the report of the Committee on Rules accom-  
7 panying this resolution, shall be considered as adopted.  
8 The bill, as amended, shall be considered as read. All  
9 points of order against provisions in the bill, as amended,  
10 are waived. The previous question shall be considered as  
11 ordered on the bill, as amended, and on any further  
12 amendment thereto, to final passage without intervening  
13 motion except: (1) one hour of debate equally divided and  
14 controlled by the chair and ranking minority member of  
15 the Committee on Natural Resources; (2) the further  
16 amendments described in section 2 of this resolution; (3)  
17 the amendments en bloc described in section 3 of this reso-  
18 lution; and (4) one motion to recommit.

19       SEC. 2. After debate pursuant to the first section of  
20 this resolution, each further amendment printed in part  
21 B of the report of the Committee on Rules not earlier con-  
22 sidered as part of amendments en bloc pursuant to section  
23 3 of this resolution shall be considered only in the order  
24 printed in the report, may be offered only by a Member  
25 designated in the report, shall be considered as read, shall

1 be debatable for the time specified in the report equally  
2 divided and controlled by the proponent and an opponent,  
3 may be withdrawn by the proponent at any time before  
4 the question is put thereon, shall not be subject to amend-  
5 ment, and shall not be subject to a demand for division  
6 of the question.

7       SEC. 3. It shall be in order at any time after debate  
8 pursuant to the first section of this resolution for the chair  
9 of the Committee on Natural Resources or his designee  
10 to offer amendments en bloc consisting of further amend-  
11 ments printed in part B of the report of the Committee  
12 on Rules accompanying this resolution not earlier disposed  
13 of. Amendments en bloc offered pursuant to this section  
14 shall be considered as read, shall be debatable for 20 min-  
15 utes equally divided and controlled by the chair and rank-  
16 ing minority member of the Committee on Natural Re-  
17 sources or their respective designees, shall not be subject  
18 to amendment, and shall not be subject to a demand for  
19 division of the question.

20       SEC. 4. All points of order against the further amend-  
21 ments printed in part B of the report of the Committee  
22 on Rules or amendments en bloc described in section 3  
23 of this resolution are waived.

24       SEC. 5. Upon adoption of this resolution it shall be  
25 in order to consider in the House the bill (H.R. 5) to pro-

1 hibit discrimination on the basis of sex, gender identity,  
2 and sexual orientation, and for other purposes. All points  
3 of order against consideration of the bill are waived. The  
4 bill shall be considered as read. All points of order against  
5 provisions in the bill are waived. The previous question  
6 shall be considered as ordered on the bill and on any  
7 amendment thereto to final passage without intervening  
8 motion except: (1) 90 minutes of debate equally divided  
9 and controlled by the chair and ranking minority member  
10 of the Committee on the Judiciary; and (2) one motion  
11 to recommit.
