8 and other communications, and any financial statements
9 detailing purchases, recipients, and government expendi-
10 tures to the extent that any such one or more items are
11 within the possession of the President or Secretaries afore-
12 mentioned, respectively, and refer or relate to congression-
13 ally appropriated funds directed to the nation of
14 Ukraine—whether in regard to military, civilian, or finan-
15 cial aid—between January 20, 2021 and November 15,
