Mr. PERLMUTTER, from the Committee on Rules, reported the following resolution; which was referred to the House Calendar and ordered to be printed

RESOLUTION

Providing for consideration of the bill (H.R. 2547) to expand and enhance consumer, student, servicemember, and small business protections with respect to debt collection practices, and for other purposes; providing for consideration of the bill (H.R. 1065) to eliminate discrimination and promote womens health and economic security by ensuring reasonable workplace accommodations for workers whose ability to perform the functions of a job are

limited by pregnancy, childbirth, or a related medical condition; and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 2547) to expand and enhance consumer, student, service-
4 member, and small business protections with respect to
5 debt collection practices, and for other purposes. All points
6 of order against consideration of the bill are waived. The
7 amendment in the nature of a substitute recommended by
8 the Committee on Financial Services now printed in the
9 bill, modified by the amendment printed in part A of the
10 report of the Committee on Rules accompanying this reso-
11 lution, shall be considered as adopted. The bill, as amend-
12 ed, shall be considered as read. All points of order against
13 provisions in the bill, as amended, are waived. The pre-
14 vious question shall be considered as ordered on the bill,
15 as amended, and on any further amendment thereto, to
16 final passage without intervening motion except: (1) one
17 hour of debate equally divided and controlled by the chair
18 and ranking minority member of the Committee on Finan-
19 cial Services or their respective designees; (2) the further
20 amendments described in section 2 of this resolution; (3)
21 the amendments en bloc described in section 3 of this reso-
22 lution; and (4) one motion to recommit.

23 SEC. 2. After debate pursuant to the first section of
24 this resolution, each further amendment printed in part

1 B of the report of the Committee on Rules not earlier con-
2 sidered as part of amendments en bloc pursuant to section
3 3 of this resolution shall be considered only in the order
4 printed in the report, may be offered only by a Member
5 designated in the report, shall be considered as read, shall
6 be debatable for the time specified in the report equally
7 divided and controlled by the proponent and an opponent,
8 may be withdrawn by the proponent at any time before
9 the question is put thereon, shall not be subject to amend-
10 ment, and shall not be subject to a demand for division
11 of the question.

12 SEC. 3. It shall be in order at any time after debate
13 pursuant to the first section of this resolution for the chair
14 of the Committee on Financial Services or her designee
15 to offer amendments en bloc consisting of further amend-
16 ments printed in part B of the report of the Committee
17 on Rules accompanying this resolution not earlier disposed
18 of. Amendments en bloc offered pursuant to this section
19 shall be considered as read, shall be debatable for 20 min-
20 utes equally divided and controlled by the chair and rank-
21 ing minority member of the Committee on Financial Serv-
22 ices or their respective designees, shall not be subject to
23 amendment, and shall not be subject to a demand for divi-
24 sion of the question.

1 SEC. 4. All points of order against the further amend-
2 ments printed in part B of the report of the Committee
3 on Rules or amendments en bloc described in section 3
4 of this resolution are waived.

5 SEC. 5. Upon adoption of this resolution it shall be
6 in order to consider in the House the bill (H.R. 1065)
7 to eliminate discrimination and promote women's health
8 and economic security by ensuring reasonable workplace
9 accommodations for workers whose ability to perform the
10 functions of a job are limited by pregnancy, childbirth, or
11 a related medical condition. All points of order against
12 consideration of the bill are waived. The amendment in
13 the nature of a substitute recommended by the Committee
14 on Education and Labor now printed in the bill shall be
15 considered as adopted. The bill, as amended, shall be con-
16 sidered as read. All points of order against provisions in
17 the bill, as amended, are waived. The previous question
18 shall be considered as ordered on the bill, as amended,
19 and on any further amendment thereto, to final passage
20 without intervening motion except: (1) one hour of debate
21 equally divided and controlled by the chair and ranking
22 minority member of the Committee on Education and
23 Labor or their respective designees; and (2) one motion
24 to recommit.

1 SEC. 6. (a) At any time through the legislative day
2 of Friday, May 14, 2021, the Speaker may entertain mo-
3 tions offered by the Majority Leader or a designee that
4 the House suspend the rules as though under clause 1 of
5 rule XV with respect to multiple measures described in
6 subsection (b), and the Chair shall put the question on
7 any such motion without debate or intervening motion.

8 (b) A measure referred to in subsection (a) includes
9 any measure that was the object of a motion to suspend
10 the rules on the legislative day of May 11, 2021, or May
11 12, 2021, in the form as so offered, on which the yeas
12 and nays were ordered and further proceedings postponed
13 pursuant to clause 8 of rule XX.

14 (c) Upon the offering of a motion pursuant to sub-
15 section (a) concerning multiple measures, the ordering of
16 the yeas and nays on postponed motions to suspend the
17 rules with respect to such measures is vacated to the end
18 that all such motions are considered as withdrawn.

19 SEC. 7. House Resolution 379 is hereby adopted.
