RESOLUTION

Providing for consideration of the bill (H.R. 3233) to establish the National Commission to Investigate the January 6 Attack on the United States Capitol Complex, and for other purposes; and providing for consideration of the bill (H.R. 3237) making emergency supplemental appropriations for the fiscal year ending September 30, 2021, and for other purposes..

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 3233) to establish the National Commission to Investigate

1 the January 6 Attack on the United States Capitol Com-
2 plex, and for other purposes. All points of order against
3 consideration of the bill are waived. The bill shall be con-
4 sidered as read. All points of order against provisions in
5 the bill are waived. The previous question shall be consid-
6 ered as ordered on the bill and on any amendment thereto
7 to final passage without intervening motion except: (1) one
8 hour of debate equally divided and controlled by the chair
9 and ranking minority member of the Committee on Home-
10 land Security or their respective designees; and (2) one
11 motion to recommit.

12 SEC. 2. Upon adoption of this resolution it shall be
13 in order to consider in the House the bill (H.R. 3237)
14 making emergency supplemental appropriations for the
15 fiscal year ending September 30, 2021, and for other pur-
16 poses. All points of order against consideration of the bill
17 are waived. The bill shall be considered as read. All points
18 of order against provisions in the bill are waived. The pre-
19 vious question shall be considered as ordered on the bill
20 and on any amendment thereto to final passage without
21 intervening motion except: (1) one hour of debate equally
22 divided and controlled by the chair and ranking minority
23 member of the Committee on Appropriations or their re-
24 spective designees; and (2) one motion to recommit.
