RESOLUTION

Providing for further consideration of the bill (H.R. 3684) to authorize funds for Federal-Aid Highways, Highway Safety Programs, and Transit Programs, and for other purposes; and for other purposes.

1 *Resolved*, That during further consideration of the bill
2 (H.R. 3684) to authorize funds for Federal-aid highways,
3 highway safety programs, and transit programs, and for
4 other purposes, pursuant to section 6 of House Resolution
5 504—

1 (a) after debate, each further amendment printed in
2 the report of the Committee on Rules accompanying this
3 resolution not earlier considered as part of amendments
4 en bloc pursuant to subsection (b) shall be considered only
5 in the order printed in the report, may be offered only
6 by a Member designated in the report, shall be considered
7 as read, shall be debatable for the time specified in the
8 report equally divided and controlled by the proponent and
9 an opponent, may be withdrawn by the proponent at any
10 time before the question is put thereon, shall not be sub-
11 ject to amendment, and shall not be subject to a demand
12 for division of the question; and

13 (b) it shall be in order at any time after debate for
14 the chair of the Committee on Transportation and Infra-
15 structure or his designee to offer amendments en bloc con-
16 sisting of further amendments printed in the report of the
17 Committee on Rules accompanying this resolution not ear-
18 lier disposed of, and such amendments en bloc shall be
19 considered as read, shall be debatable for 20 minutes
20 equally divided and controlled by the chair and ranking
21 minority member of the Committee on Transportation and
22 Infrastructure or their respective designees, shall not be
23 subject to amendment, and shall not be subject to a de-
24 mand for division of the question.

1 SEC. 2. All points of order against the further amend-
2 ments printed in the report of the Committee on Rules
3 or amendments en bloc described in subsection (b) of the
4 first section of this resolution are waived.

5 SEC. 3. It shall be in order without intervention of
6 any point of order to consider concurrent resolutions pro-
7 viding for adjournment during the month of July.

8 SEC. 4. The provisions of section 202 of the National
9 Emergencies Act (50 U.S.C. 1622) shall not apply during
10 the remainder of the One Hundred Seventeenth Congress
11 to a joint resolution terminating the national emergency
12 declared by the President on March 13, 2020.

13 SEC. 5. House Resolution 188, agreed to March 8,
14 2021 (as most recently amended by House Resolution
15 403, agreed to May 18, 2021), is amended by striking
16 “July 1, 2021” each place it appears and inserting (in
17 each instance) “July 30, 2021”.
