Providing for consideration of the bill (H.R. 4346) making appropriations for Legislative Branch for the fiscal year ending September 30, 2022, and for other purposes; providing for consideration of the bill (H.R. 4373) making appropriations for the Department of State, foreign operations, and related programs for the fiscal year ending September 30, 2022, and for other purposes; and providing for consideration of the bill (H.R. 4505) mak-

ing appropriations for the Departments of Commerce and Justice, Science, and Related Agencies for the fiscal year ending September 30, 2022, and for other purposes.

1 *Resolved*, That upon adoption of this resolution it
2 shall be in order to consider in the House the bill (H.R.
3 4346) making appropriations for Legislative Branch for
4 the fiscal year ending September 30, 2022, and for other
5 purposes. All points of order against consideration of the
6 bill are waived. The amendment printed in part A of the
7 report of the Committee on Rules accompanying this reso-
8 lution shall be considered as adopted. The bill, as amend-
9 ed, shall be considered as read. All points of order against
10 provisions in the bill, as amended, are waived. The pre-
11 vious question shall be considered as ordered on the bill,
12 as amended, and on any further amendment thereto, to
13 final passage without intervening motion except: (1) one
14 hour of debate equally divided and controlled by the chair
15 and ranking minority member of the Committee on Appro-
16 priations or their respective designees; (2) the further
17 amendments described in section 2 of this resolution; (3)
18 the amendments en bloc described in section 3 of this reso-
19 lution; and (4) one motion to recommit.

20 SEC. 2. After debate pursuant to the first section of
21 this resolution, each further amendment printed in part
22 B of the report of the Committee on Rules not earlier con-
23 sidered as part of amendments en bloc pursuant to section

1 3 of this resolution shall be considered only in the order
2 printed in the report, may be offered only by a Member
3 designated in the report, shall be considered as read, shall
4 be debatable for the time specified in the report equally
5 divided and controlled by the proponent and an opponent,
6 may be withdrawn by the proponent at any time before
7 the question is put thereon, shall not be subject to amend-
8 ment, and shall not be subject to a demand for division
9 of the question.

10 SEC. 3. It shall be in order at any time after debate
11 pursuant to the first section of this resolution for the chair
12 of the Committee on Appropriations or her designee to
13 offer amendments en bloc consisting of further amend-
14 ments printed in part B of the report of the Committee
15 on Rules accompanying this resolution not earlier disposed
16 of. Amendments en bloc offered pursuant to this section
17 shall be considered as read, shall be debatable for 20 min-
18 utes equally divided and controlled by the chair and rank-
19 ing minority member of the Committee on Appropriations
20 or their respective designees, shall not be subject to
21 amendment, and shall not be subject to a demand for divi-
22 sion of the question.

23 SEC. 4. All points of order against the further amend-
24 ments printed in part B of the report of the Committee

1 on Rules or amendments en bloc described in section 3
2 of this resolution are waived.

3 SEC. 5. Upon adoption of this resolution it shall be
4 in order to consider in the House the bill (H.R. 4373)
5 making appropriations for the Department of State, for-
6 eign operations, and related programs for the fiscal year
7 ending September 30, 2022, and for other purposes. All
8 points of order against consideration of the bill are waived.
9 The amendment printed in part C of the report of the
10 Committee on Rules accompanying this resolution shall be
11 considered as adopted. The bill, as amended, shall be con-
12 sidered as read. All points of order against provisions in
13 the bill, as amended, are waived. The previous question
14 shall be considered as ordered on the bill, as amended,
15 and on any further amendment thereto, to final passage
16 without intervening motion except: (1) one hour of debate
17 equally divided and controlled by the chair and ranking
18 minority member of the Committee on Appropriations or
19 their respective designees; (2) the further amendments de-
20 scribed in section 6 of this resolution; (3) the amendments
21 en bloc described in section 7 of this resolution; and (4)
22 one motion to recommit.

23 SEC. 6. After debate pursuant to section 5 of this
24 resolution, each further amendment printed in part D of
25 the report of the Committee on Rules not earlier consid-

1 ered as part of amendments en bloc pursuant to section
2 7 of this resolution shall be considered only in the order
3 printed in the report, may be offered only by a Member
4 designated in the report, shall be considered as read, shall
5 be debatable for the time specified in the report equally
6 divided and controlled by the proponent and an opponent,
7 may be withdrawn by the proponent at any time before
8 the question is put thereon, shall not be subject to amend-
9 ment, and shall not be subject to a demand for division
10 of the question.

11 SEC. 7. It shall be in order at any time after debate
12 pursuant to section 5 of this resolution for the chair of
13 the Committee on Appropriations or her designee to offer
14 amendments en bloc consisting of further amendments
15 printed in part D of the report of the Committee on Rules
16 accompanying this resolution not earlier disposed of.
17 Amendments en bloc offered pursuant to this section shall
18 be considered as read, shall be debatable for 20 minutes
19 equally divided and controlled by the chair and ranking
20 minority member of the Committee on Appropriations or
21 their respective designees, shall not be subject to amend-
22 ment, and shall not be subject to a demand for division
23 of the question.

24 SEC. 8. All points of order against the further amend-
25 ments printed in part D of the report of the Committee

1 on Rules or amendments en bloc described in section 7
2 of this resolution are waived.

3 SEC. 9. Upon adoption of this resolution it shall be
4 in order to consider in the House the bill (H.R. 4505)
5 making appropriations for the Departments of Commerce
6 and Justice, Science, and Related Agencies for the fiscal
7 year ending September 30, 2022, and for other purposes.
8 All points of order against consideration of the bill are
9 waived. The amendment printed in part E of the report
10 of the Committee on Rules accompanying this resolution
11 shall be considered as adopted. The bill, as amended, shall
12 be considered as read. All points of order against provi-
13 sions in the bill, as amended, are waived. The previous
14 question shall be considered as ordered on the bill, as
15 amended, and on any further amendment thereto, to final
16 passage without intervening motion except: (1) one hour
17 of debate equally divided and controlled by the chair and
18 ranking minority member of the Committee on Appropria-
19 tions or their respective designees; (2) the further amend-
20 ments described in section 10 of this resolution; (3) the
21 amendments en bloc described in section 11 of this resolu-
22 tion; and (4) one motion to recommit.

23 SEC. 10. After debate pursuant to section 9 of this
24 resolution, each further amendment printed in part F of
25 the report of the Committee on Rules not earlier consid-

1 ered as part of amendments en bloc pursuant to section
2 11 of this resolution shall be considered only in the order
3 printed in the report, may be offered only by a Member
4 designated in the report, shall be considered as read, shall
5 be debatable for the time specified in the report equally
6 divided and controlled by the proponent and an opponent,
7 may be withdrawn by the proponent at any time before
8 the question is put thereon, shall not be subject to amend-
9 ment, and shall not be subject to a demand for division
10 of the question.

11 SEC. 11. It shall be in order at any time after debate
12 pursuant to section 9 of this resolution for the chair of
13 the Committee on Appropriations or her designee to offer
14 amendments en bloc consisting of further amendments
15 printed in part F of the report of the Committee on Rules
16 accompanying this resolution not earlier disposed of.
17 Amendments en bloc offered pursuant to this section shall
18 be considered as read, shall be debatable for 20 minutes
19 equally divided and controlled by the chair and ranking
20 minority member of the Committee on Appropriations or
21 their respective designees, shall not be subject to amend-
22 ment, and shall not be subject to a demand for division
23 of the question.
