## RESOLUTION

Impeaching Joseph R. Biden, President of the United States, for dereliction of duty by leaving behind thousands of American civilians and Afghan allies, along with numerous taxpayer-financed weapons and military equipment, endangering the lives of the American people and the security of the United States.

- 1        *Resolved*, That Joseph Robinette Biden, President of
- 2    the United States, is impeached for dereliction of duty by
- 3    leaving behind thousands of American civilians and Af-
- 4    ghan allies, along with numerous taxpayer-financed weap-
- 5    ons and military equipment, endangering the lives of the

1 American people and the security of the United States,  
2 and that the following Articles of Impeachment be exhib-  
3 ited to the United States Senate:

4       Articles of Impeachment exhibited by the House of  
5 Representatives of the United States of America in the  
6 name of itself and of the people of the United States of  
7 America, against Joseph Robinette Biden, President of the  
8 United States of America, in maintenance and support of  
9 its impeachment against him for dereliction of duty by  
10 leaving behind thousands of American civilians and Af-  
11 ghan allies, along with numerous taxpayer-financed weap-  
12 ons and military equipment, endangering the lives of the  
13 American people and the security of the United States.

14       The Constitution provides that the House of Rep-  
15 resentatives “shall have the sole Power of Impeachment”  
16 and that the President “shall be removed from Office on  
17 Impeachment for, and Conviction of, Treason, Bribery, or  
18 other high Crimes and Misdemeanors.”.

19       In his conduct as President of the United States, in  
20 violation of his constitutional oath faithfully to execute the  
21 office of the President of the United States, and, to the  
22 best of his ability, preserve, protect, defend, the Constitu-  
23 tion of the United States—Joseph Robinette Biden  
24 showed dereliction of duty by leaving behind thousands of  
25 American civilians and Afghan allies, along with numerous

1 taxpayer-financed weapons and military equipment, en-  
2 dangering the lives of the American people and the secu-  
3 rity of the United States.

4                                  ARTICLE I

5       Whereas Joe Biden failed to secure the extraction of  
6 thousands of American civilians and Afghan allies before  
7 and during the withdrawal between August 14 and August  
8 16, 2021, putting thousands of lives in imminent danger  
9 from the Taliban.

10     Whereas, as Commander-in-Chief, Joe Biden has  
11 armed our enemies by leaving numerous weapons, ammu-  
12 nition, and other military equipment which could be used  
13 against American citizens, allies, and other civilians in Af-  
14 ghanistan.

15     Whereas Joe Biden has shown the American people  
16 that his administration failed to properly prepare for the  
17 extraction of civilian and military assets from the nation  
18 of Afghanistan.

19     Whereas Joe Biden abandoned tens of thousands of  
20 American citizens and Afghan allies stuck in Afghanistan  
21 at danger of being captured, tortured, held hostage for  
22 ransom, or killed.

23     In each of these actions, Joseph R. Biden showed  
24 grave dereliction of duty and continues to demonstrate

1 that he is unfit to hold the office of President of the  
2 United States.

3 Wherefore President Biden, by such conduct, has  
4 demonstrated that he will remain a threat to national se-  
5 curity and the Constitution if allowed to remain in office,  
6 and has acted in a manner grossly incompatible with self-  
7 governance and the rule of law. President Biden thus war-  
8 rants impeachment and trial, removal from office, and dis-  
9 qualification to hold and enjoy any office of honor, trust,  
10 or profit under the United States.
