A BILL

To ensure due process protections of individuals in the United States against unlawful detention based solely on a protected characteristic.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Korematsu-Takai Civil
5 Liberties Protection Act of 2021”.

1 **SEC. 2. PROHIBITION AGAINST UNLAWFUL DETENTION.**

2 Section 4001 of title 18, United States Code, is
3 amended—

4 (1) by redesignating subsection (b) as sub-
5 section (c); and

6 (2) by inserting after subsection (a) the fol-
7 lowing:

8 “(b) PROHIBITION ON DETENTION BASED ON PRO-
9 TECTED CHARACTERISTICS.—

10 “(1) IN GENERAL.—No individual may be im-
11 prisoned or otherwise detained based solely on an ac-
12 tual or perceived protected characteristic of the indi-
13 vidual.

14 “(2) DEFINITION.—In this subsection, the term
15 ‘protected characteristic’ includes each of the fol-
16 lowing:

17 “(A) Race.

18 “(B) Ethnicity.

19 “(C) National origin.

20 “(D) Religion.

21 “(E) Sex.

22 “(F) Gender identity.

23 “(G) Sexual orientation.

24 “(H) Disability.

1 “(I) Any additional characteristic that the
2 Attorney General determines to be a protected
3 characteristic.

4 “(3) RULE OF CONSTRUCTION.—Nothing in
5 this subsection shall be construed to allow the Attor-
6 ney General to remove a characteristic described in
7 subparagraphs (A) through (H) of paragraph (2)
8 from the definition of the term ‘protected char-
9 acteristic’ under this subsection.”.
