A BILL

To authorize the National Cyber Director to accept details from other elements of the Federal Government on nonreimbursable basis, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

1 **SECTION 1. AUTHORITY FOR NATIONAL CYBER DIRECTOR**
2 **TO ACCEPT DETAILS ON NONREIMBURSABLE**
3 **BASIS.**

4 Section 1752(e) of the William M. (Mac) Thornberry
5 National Defense Authorization Act for Fiscal Year 2021
6 (Public Law 116–283) is amended—

7 (1) by redesignating paragraphs (1) through
8 (8) as subparagraphs (A) through (H), respectively,
9 and indenting such subparagraphs two ems to the
10 right;

11 (2) in the matter before subparagraph (A), as
12 redesignated by paragraph (1), by striking “The Di-
13 rector may” and inserting the following:

14 “(1) IN GENERAL.—The Director may”;

15 (3) in paragraph (1)—

16 (A) as redesignated by paragraph (2), by
17 redesignating subparagraphs (C) through (H)
18 as subparagraphs (D) through (I), respectively;
19 and

20 (B) by inserting after subparagraph (B)
21 the following new subparagraph (C):

22 “(C) accept officers or employees of the
23 United States or member of the Armed Forces
24 on a detail from an element of the intelligence
25 community or from another element of the Fed-
26 eral Government on a nonreimbursable basis, as

1 jointly agreed to by the heads of the receiving
2 and detailing elements, for a period not to ex-
3 ceed three years;” and

4 (4) by adding at the end the following new
5 paragraph:

6 “(2) RULES OF CONSTRUCTION REGARDING DE-
7 TAILS.—Paragraph (1)(C) shall not be construed to
8 impose any limitation on any other authority for re-
9 imburseable or nonreimbursable details. A nonreim-
10 bursable detail made under such paragraph shall not
11 be considered an augmentation of the appropriations
12 of the receiving element of the Office of the National
13 Cyber Director.”.
