Mr. TUBERVILLE (for himself and Ms. LUMMIS) introduced the following bill; which was read twice and referred to the Committee on Banking, Housing, and Urban Affairs

A BILL

To amend the Defense Production Act of 1950 to prevent harm and disruption to the United States agriculture industry by protecting against foreign influence over agriculture production and supply chains, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Foreign Adversary
5 Risk Management Act” or the “FARM Act”.

6 **SEC. 2. FINDINGS.**

7 Congress finds the following:

1 (1) United States agriculture and supply chains
 2 are critical to United States economic success and
 3 prosperity, and should each be classified as critical
 4 infrastructure and critical technologies.

5 (2) Agriculture is the lifeblood that helps to
 6 feed United States families nationwide. As such,
 7 food security is a matter of national security and
 8 should be a top priority of the United States.

9 (3) To prevent harm to the United States pub-
 10 lic health sector and to prevent disruption to the
 11 United States economy and food supply chains, the
 12 increasing influence foreign countries may have on
 13 the United States agriculture industry and agri-
 14 culture supply chains should be mitigated.

15 **SEC. 3. UNITED STATES AGRICULTURE INCLUDED IN COM-**
 16 **MITTEE ON FOREIGN INVESTMENT IN THE**
 17 **UNITED STATES.**

18 (a) AGRICULTURE REPRESENTATIVE.—Section
 19 721(k)(2) of the Defense Production Act of 1950 (50
 20 U.S.C. 4565(k)(2)) is amended—

21 (1) by redesignating subparagraphs (H), (I),
 22 and (J) as subparagraphs (I), (J), and (K), respec-
 23 tively; and

24 (2) by inserting after subparagraph (G) the fol-
 25 lowing:

1 “(H) The Secretary of Agriculture.”.

2 (b) REVIEW OF AGRICULTURE INVESTMENTS BY
3 FOREIGN ENTITIES.—Section 721(a)(4) of the Defense
4 Production Act of 1950 (50 U.S.C. 4565(a)(4)) is amend-
5 ed—

6 (1) in subparagraph (A)—

7 (A) in clause (i), by striking “; and” and
8 inserting a semicolon;

9 (B) in clause (ii), by striking the period at
10 the end and inserting “; and”; and

11 (C) by adding at the end the following:

12 “(iii) any transaction described in
13 subparagraph (B)(vi) that is proposed,
14 pending, or completed on or after the date
15 of the enactment of the Foreign Adversary
16 Risk Management Act.”; and

17 (2) in subparagraph (B), by adding at the end
18 the following:

19 “(vi) Any transaction, merger, acqui-
20 sition, transfer, agreement, takeover, or
21 other arrangement that could result in for-
22 eign control of any United States business
23 that is engaged in agriculture and uses ag-
24 ricultural products (as defined in the first

1 section of the Act of July 2, 1926 (44
2 Stat. 802, chapter 725; 7 U.S.C. 451)).”.

3 (c) AGRICULTURAL SUPPLY CHAINS INCLUDED IN
4 CRITICAL INFRASTRUCTURE.—Section 721(a)(5) of the
5 Defense Production Act of 1950 (50 U.S.C. 4565(a)(5))
6 is amended—

7 (1) by striking “‘critical infrastructure’ means”
8 and inserting the following: “‘critical infrastruc-
9 ture’—

10 “(i) means”;

11 (2) by striking the period at the end and insert-
12 ing “; and”; and

13 (3) by adding at the end the following:

14 “(ii) includes, subject to regulations
15 prescribed by the Committee, agricultural
16 systems and supply chains.”.

17 (d) AGRICULTURAL SUPPLY CHAINS INCLUDED AS
18 CRITICAL TECHNOLOGIES.—Section 721(a)(6)(A) of the
19 Defense Production Act of 1950 (50 U.S.C.
20 4565(a)(6)(A)) is amended by adding at the end the fol-
21 lowing:

22 “(vii) Agricultural supply chains used
23 for agricultural products (as defined in the
24 first section of the Act of July 2, 1926 (44
25 Stat. 802, chapter 725; 7 U.S.C. 451)).”.

1 **SEC. 4. REPORTS ON INVESTMENTS BY FOREIGN COUN-**
2 **TRIES IN UNITED STATES AGRICULTURE IN-**
3 **DUSTRY.**

4 Not later than one year after the date of the enact-
5 ment of this Act, the Secretary of Agriculture and the
6 Comptroller General of the United States shall each—

7 (1) conduct an analysis of foreign influence in
8 the United States agriculture industry; and

9 (2) submit to Congress a report that includes a
10 summary of—

11 (A) foreign investments in the United
12 States agriculture industry;

13 (B) the potential for foreign investment to
14 undermine United States agriculture production
15 and agricultural supply chains;

16 (C) the largest international threats for in-
17 creased foreign control of, and investment in,
18 the United States agriculture sector; and

19 (D) agriculture-related espionage and theft
20 techniques used by foreign governments, includ-
21 ing any attempts to target United States agri-
22 cultural intellectual property, innovation, re-
23 search and development, cost or pricing data, or
24 internal strategy documents.
