Mr. PAUL introduced the following bill; which was read twice and referred to the Committee on Appropriations

A BILL

Making supplemental appropriations for the fiscal year ending September 30, 2022, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 That the following sums are appropriated, out of any
4 money in the Treasury not otherwise appropriated, for the
5 fiscal year ending September 30, 2022, and for other pur-
6 poses, namely:

1 DEPARTMENT OF DEFENSE
2 PROCUREMENT
3 PROCUREMENT, DEFENSE-WIDE

4 For an additional amount for “Procurement, De-
5 fense-Wide”, \$1,000,000,000, to remain available until
6 September 30, 2024, for the Secretary of Defense to pro-
7 vide to the Government of Israel for the procurement of
8 the Iron Dome defense system to counter short-range
9 rocket threats: *Provided*, That such funds shall be pro-
10 vided to address emergent requirements in support of Op-
11 eration Guardian of the Walls: *Provided further*, That such
12 funds shall be transferred pursuant to an exchange of let-
13 ters and are in addition to funds provided pursuant to the
14 U.S.-Israel Iron Dome Procurement Agreement, as
15 amended: *Provided further*, That nothing in the preceding
16 provisos shall be construed to apply to amounts made
17 available in prior appropriations Acts for the procurement
18 of the Iron Dome defense system: *Provided further*, That
19 such amount is designated by the Congress as being for
20 an emergency requirement pursuant to section 4001(a)(1)
21 and section 4001(b) of S. Con. Res. 14 (117th Congress),
22 the concurrent resolution on the budget for fiscal year
23 2022.

1 GENERAL PROVISIONS—THIS ACT

2 SEC. 101. Each amount appropriated or made avail-
3 able by this Act is in addition to amounts otherwise appro-
4 priated for the fiscal year involved.

5 SEC. 102. Unless otherwise provided for by this Act,
6 the additional amounts appropriated by this Act to appro-
7 priations accounts shall be available under the authorities
8 and conditions applicable to such appropriations accounts
9 for fiscal year 2022.

10 PREVENTION OF FUNDS BEING ALLOCATED TO THE

11 TALIBAN

12 SEC. 103. (a) There is hereby rescinded all of the
13 unobligated balances from the amounts appropriated or
14 otherwise made available to the covered funds for recon-
15 struction activities in Afghanistan.

16 (b) In this section, the term “covered funds” means,
17 with respect to amounts appropriated for Afghanistan—

18 (1) the Afghanistan Security Forces Fund
19 (ASFF);

20 (2) the Economic Support Fund (ESF);

21 (3) International Narcotics Control and Law
22 Enforcement (INCLE);

23 (4) the Commanders’ Emergency Response Pro-
24 gram (CERP);

25 (5) Drug Interdiction and Counter-Drug Activi-
26 ties (DICDA);

1 (6) Migration and Refugee Assistance (MRA);
2 (7) International Disaster Assistance (IDA);
3 and
4 (8) Non-Proliferation, Antiterrorism, Demining,
5 and Related (NADR).
6 This Act may be cited as the “Funding Iron Dome
7 by Defunding the Taliban Act”.
