1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Ste. Genevieve Na-
5 tional Historical Park Boundary Revision Act”.

1 **SEC. 2. STE. GENEVIEVE NATIONAL HISTORICAL PARK**
 2 **BOUNDARY REVISION.**

3 (a) MAP.—Section 7134(a)(3) of ~~appendix C~~ of the
 4 Consolidated Appropriations Act, 2018 (16 U.S.C.
 5 ~~410xxx(a)(3))~~, of the *Energy and Natural Resources Act*
 6 of 2017 (as enacted into law by section 121(a)(2) of division
 7 G of the Consolidated Appropriations Act, 2018 (Public
 8 Law 115–141; 16 U.S.C. 410xxx(a)(3))) is amended by
 9 striking “numbered 571/149,942, and dated December
 10 2018” and inserting “numbered 571/177,464, and dated
 11 September 2021”.

12 (b) AUTHORITY TO CORRECT ERRORS IN MAP.—Sec-
 13 tion 7134(d) of ~~appendix C~~ of the Consolidated Appropria-
 14 tions Act, 2018 (16 U.S.C. ~~410xxx(d)~~), of the *Energy and*
 15 *Natural Resources Act of 2017* (as enacted into law by sec-
 16 tion 121(a)(2) of division G of the Consolidated Appropria-
 17 tions Act, 2018 (Public Law 115–141; 16 U.S.C.
 18 410xxx(d))) is amended—

19 (1) by striking “The Map” and inserting the
 20 following:

21 “(1) IN GENERAL.—The Map”; and

22 (2) by adding at the end the following:

23 “(2) AUTHORITY TO CORRECT ERRORS.—The
 24 Secretary may correct any clerical or typographical
 25 errors in the Map.”.

1 (c) VISITOR CENTER AND ADMINISTRATIVE FACILI-
 2 TIES.—Section 7134(e) of ~~appendix C of the Consolidated~~
 3 ~~Appropriations Act, 2018 (16 U.S.C. 410xxx(e))~~, of the
 4 *Energy and Natural Resources Act of 2017 (as enacted into*
 5 *law by section 121(a)(2) of division G of the Consolidated*
 6 *Appropriations Act, 2018 (Public Law 115–141; 16 U.S.C.*
 7 *410xxx(e))*) is amended by adding at the end the following:

8 “(3) VISITOR CENTER.—The Secretary—

9 “(A) may acquire, by donation, the land
 10 (including any improvements to the land)
 11 owned by the city of Ste. Genevieve, Missouri,
 12 and used as the visitor center for the Historical
 13 Park, as generally depicted on the Map as ‘Pro-
 14 posed Boundary Addition’; and

15 “(B) on acquisition of the land described
 16 in subparagraph (A), shall revise the boundary
 17 of the Historical Park to include the acquired
 18 ~~land.”.~~ *land.*

19 “(4) ADMINISTRATIVE FACILITIES.—*The Sec-*
 20 *retary of the Interior (referred to in this section as*
 21 *the ‘Secretary’) may acquire, by purchase from a*
 22 *willing seller or by donation, not more than 20 acres*
 23 *of land in the vicinity of the Historical Park for ad-*
 24 *ministrative facilities for the Historical Park.”.*
