To clarify that section 107 of the Countering America’s Adversaries Through Sanctions Act applies sanctions with respect to unmanned combat aerial vehicles following a 2019 change by the United Nations providing additional clarity to the United Nations Register of Conventional Arms.

Mr. MENENDEZ (for himself and Mr. RISCH) introduced the following bill;
which was read twice and referred to the Committee on Foreign Relations

A BILL

To clarify that section 107 of the Countering America’s Adversaries Through Sanctions Act applies sanctions with respect to unmanned combat aerial vehicles following a 2019 change by the United Nations providing additional clarity to the United Nations Register of Conventional Arms.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Stop Iranian Drones
5 Act of 2021”.

1 **SEC. 2. FINDINGS.**

2 Congress finds the following:

3 (1) A United Nations General Assembly report
4 entitled, “Continuing operation of the United Na-
5 tions Register of Conventional Arms and its further
6 development” (document A/68/140) and dated July
7 15, 2013, states, in paragraph 45, the following:
8 “The Group noted the discussion of the 2006 Group
9 that category IV already covered armed unmanned
10 aerial vehicles and of the 2009 Group on a proposal
11 to include a new category for such vehicles. The
12 Group reviewed proposals for providing greater clar-
13 ity to category IV. . . .”.

14 (2) Section 107 of the Countering America’s
15 Adversaries Through Sanctions Act (22 U.S.C.
16 9406) requires that the President impose sanctions
17 on any person that the President determines “know-
18 ingly engages in any activity that materially contrib-
19 utes to the supply, sale, or transfer directly or indi-
20 rectly to or from Iran, or for the use in or benefit
21 of Iran, of any battle tanks, armored combat vehi-
22 cles, large caliber artillery systems, combat aircraft,
23 attack helicopters, warships, missiles or missile sys-
24 tems, as defined for the purpose of the United Na-
25 tions Register of Conventional Arms, or related ma-
26 teriel, including spare parts”.

1 (3) In 2019, the United Nations formally
 2 changed the title of category IV of the United Na-
 3 tions Register of Conventional Arms to “Combat air-
 4 craft and unmanned combat aerial vehicles
 5 (UCAV)”.

6 **SEC. 3. STATEMENT OF POLICY.**

7 It is the policy of the United States to prevent Iran
 8 and terrorist and militia groups aligned with Iran from
 9 acquiring unmanned aerial vehicles, including commer-
 10 cially available component parts that can be used in at-
 11 tacks against United States persons and allies and part-
 12 ners of the United States.

13 **SEC. 4. AMENDMENT TO COUNTERING AMERICA’S ADVER-**
 14 **SARIES THROUGH SANCTIONS ACT RELATING**
 15 **TO SANCTIONS WITH RESPECT TO IRAN.**

16 (a) IN GENERAL.—Section 107 of the Countering
 17 America’s Adversaries Through Sanctions Act (22 U.S.C.
 18 9406) is amended—

19 (1) in the section heading, by striking “**EN-**
 20 **FORCEMENT OF ARMS EMBARGOS**” and insert-
 21 ing “**SANCTIONS WITH RESPECT TO MAJOR**
 22 **CONVENTIONAL ARMS**”; and

23 (2) in subsection (a)(1), by inserting “or un-
 24 manned combat aerial vehicles” after “combat air-
 25 craft”.

1 (b) CLERICAL AMENDMENT.—The table of contents
 2 for the Countering America’s Adversaries Through Sanc-
 3 tions Act is amended by striking the item relating to sec-
 4 tion 107 and inserting the following:

“Sec. 107. Sanctions with respect to major conventional arms.”.

5 (c) EFFECTIVE DATE; APPLICABILITY.—The amend-
 6 ments made by this section shall—

7 (1) take effect on the date of the enactment of
 8 this Act; and

9 (2) apply with respect to any person that know-
 10 ingly engages, before, on, or after such date of en-
 11 actment, in any activity that materially contributes
 12 to the supply, sale, or transfer of an unmanned com-
 13 bat aerial vehicle (as defined by the United Nations
 14 Register of Conventional Arms)—

15 (A) directly or indirectly to or from Iran;

16 or

17 (B) for the use in or benefit of Iran.
