To amend the Infrastructure Investment and Jobs Act to make certain activities eligible for grants from the Abandoned Mine Reclamation Fund, and for other purposes.

1 SECTION 1. SHORT TITLE.

2	This Act may be cited as the "Safeguarding Treat-					
3	ment for the Restoration of Ecosystems from Abandoned					
4	Mines Act" or the "STREAM Act".					
5	SEC. 2. LONG-TERM ABANDONED MINE LAND RECLAMA-					
6	TION.					
7	Section 40701(c) of the Infrastructure Investment					
8	and Jobs Act (30 U.S.C. 1231a(c)) is amended—					
9	(1) by striking "Grants under" and inserting					
10	the following:					
11	"(1) IN GENERAL.—Except as provided in para-					
12	graph (2), grants under"; and					
13	(2) by adding at the end the following:					
14	"(2) Long-term abandoned mine land rec-					
15	LAMATION.—					
16	"(A) In general.—Not more than 30					
17	percent of the total amount of a grant made					
18	annually under subsection (b)(1) may be re-					
19	tained by the recipient of the grant if those					
20	amounts are deposited into a long-term aban-					
21	doned mine land reclamation fund established					
22	under State law, from which amounts (together					
23	with all interest earned on the amounts) are ex-					
24	pended by the State or Indian Tribe, as appli-					
25	cable, for—					

1	"(i) the abatement of the causes and
2	the treatment of the effects of acid mine
3	drainage resulting from coal mining prac-
4	tices, including for the costs of building,
5	operating, maintaining, and rehabilitating
6	acid mine drainage treatment systems;
7	"(ii) the prevention, abatement, and
8	control of subsidence; or
9	"(iii) the prevention, abatement, and
10	control of coal mine fires.
11	"(B) Reporting requirements.—Each
12	recipient of a grant under subsection $(b)(1)$
13	that deposits grant amounts into a long-term
14	abandoned mine land reclamation fund under
15	subparagraph (A) shall—
16	"(i) offer amendments to the inven-
17	tory maintained under section 403(c) of
18	the Surface Mining Control and Reclama-
19	tion Act of 1977 (30 U.S.C. 1233(c)) to
20	reflect the use of the amounts for—
21	"(I) acid mine drainage abate-
22	ment and treatment;
23	"(II) subsidence prevention,
24	abatement, and control: and

1	"(III) coal mine fire prevention,					
2	abatement, and control; and					
3	"(ii) include in the annual grant re-					
4	port of the recipient information on the					
5	status and balance of amounts in the long-					
6	term abandoned mine land reclamation					
7	fund.					
8	"(C) Term.—Amounts retained under					
9	subparagraph (A) shall not be subject to—					
10	"(i) subsection (d)(4)(B); or					
11	"(ii) any other limitation on the					
12	length of the term of an annual grant					
13	under subsection (b)(1).".
