A BILL

To amend chapter 44 of title 18, United States Code, to define “State of residence” and “resident”, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Traveler’s Gun Rights
5 Act”.

6 **SEC. 2. STATE OF RESIDENCE.**

7 (a) DEFINITIONS.—Section 921 of title 18, United
8 States Code, is amended—

1 (1) in subsection (a)—

2 (A) by striking “(a)” before “As used”;

3 and

4 (B) by adding at the end the following:

5 “(36)(A) The term ‘State of residence’ means—

6 “(i) the State in which an individual re-
7 sides;

8 “(ii) in the case of an individual, or spouse
9 of an individual, who is an active duty member
10 of the Armed Forces—

11 “(I) the State in which the permanent
12 duty station of the member is located; and

13 “(II) the State in which the member
14 maintains a place of abode from which the
15 member commutes each day to the perma-
16 nent duty station of the member; or

17 “(iii) in the case of an individual who does
18 not have a physical residence in any State, the
19 State in which an individual maintains a private
20 mailbox or post office box.

21 “(B) For purposes of subparagraph (A)(i)—

22 “(i) an individual resides in a State if the
23 individual is present in the State with the inten-
24 tion of making a home in that State; and

1 “(ii) an individual who maintains a home
 2 in more than 1 State is a resident of each such
 3 State during the time when the individual is
 4 present in that State.

5 “(37) The term ‘resident’, with respect to a
 6 State, means an individual who satisfies clause (i),
 7 (ii), or (iii) of paragraph (36)(A) with respect to
 8 that State.”; and

9 (2) by striking subsection (b).

10 (b) NATIONAL INSTANT CRIMINAL BACKGROUND
 11 CHECK SYSTEM.—Section 922(t)(1)(C) of title 18, United
 12 States Code, is amended by striking “transferee con-
 13 taining a photograph of the transferee.” and inserting the
 14 following: “transferee—

15 “(i) containing a photograph of the trans-
 16 feree; and

17 “(ii) containing—

18 “(I) the address of the residence of
 19 the transferee; or

20 “(II) the address for a private mail-
 21 box or post office box maintained by the
 22 transferee, if the transferee does not have
 23 a physical residence in any State.”.
