CONCURRENT RESOLUTION

Setting forth the congressional budget for the United States Government for fiscal year 2021 and setting forth the appropriate budgetary levels for fiscal years 2022 through 2030.

24 ERNMENTAL AFFAIRS.—The Committee on Homeland Se-
25 curity and Governmental Affairs of the Senate shall report

1 changes in laws within its jurisdiction that increase the
2 deficit by not more than \$50,687,000,000 for the period
3 of fiscal years 2021 through 2030.

4 (i) COMMITTEE ON INDIAN AFFAIRS.—The Com-
5 mittee on Indian Affairs of the Senate shall report
6 changes in laws within its jurisdiction that increase the
7 deficit by not more than \$8,604,000,000 for the period
8 of fiscal years 2021 through 2030.

9 (j) COMMITTEE ON SMALL BUSINESS AND ENTRE-
10 PRENEURSHIP.—The Committee on Small Business and
11 Entrepreneurship of the Senate shall report changes in
12 laws within its jurisdiction that increase the deficit by not
13 more than \$50,000,000,000 for the period of fiscal years
14 2021 through 2030.

15 (k) COMMITTEE ON VETERANS' AFFAIRS.—The
16 Committee on Veterans' Affairs of the Senate shall report
17 changes in laws within its jurisdiction that increase the
18 deficit by not more than \$17,000,000,000 for the period
19 of fiscal years 2021 through 2030.

20 (l) SUBMISSIONS.—In the Senate, not later than Feb-
21 ruary 16, 2021, the Committees named in the subsections
22 of this section shall submit their recommendations to the
23 Committee on the Budget of the Senate. Upon receiving
24 all such recommendations, the Committee on the Budget
25 of the Senate shall report to the Senate a reconciliation

1 bill carrying out all such recommendations without any
2 substantive revision.

3 **TITLE III—RESERVE FUNDS**

4 **SEC. 3001. RESERVE FUND FOR RECONCILIATION LEGISLA-** 5 **TION.**

6 (a) HOUSE OF REPRESENTATIVES.—

7 (1) IN GENERAL.—In the House of the Rep-
8 resentatives, the chair of the Committee on the
9 Budget may revise the allocations of a committee or
10 committees, aggregates, and other appropriate levels
11 in this resolution for any bill or joint resolution con-
12 sidered pursuant to section 2001 containing the rec-
13 ommendations of one or more committees, or for one
14 or more amendments to, a conference report on, or
15 an amendment between the Houses in relation to
16 such a bill or joint resolution, by the amounts nec-
17 essary to accommodate the budgetary effects of the
18 legislation, if the budgetary effects of the legislation
19 comply with the reconciliation instructions under
20 this concurrent resolution.

21 (2) DETERMINATION OF COMPLIANCE.—For
22 purposes of this section, compliance with the rec-
23 onciliation instructions under this concurrent resolu-
24 tion shall be determined by the chair of the Com-

1 committee on the Budget of the House of Representa-
2 tives.

3 (3) EXCEPTION FOR LEGISLATION.—The point
4 of order set forth in clause 10 of rule XXI of the
5 House of Representatives shall not apply to rec-
6 onciliation legislation reported by the Committee on
7 the Budget pursuant to submissions under section
8 2001.

9 (b) SENATE.—

10 (1) IN GENERAL.—In the Senate, the Chairman
11 of the Committee on the Budget of the Senate may
12 revise the allocations of a committee or committees,
13 aggregates, and other appropriate levels in this reso-
14 lution, and make adjustments to the pay-as-you-go
15 ledger, for any bill or joint resolution considered
16 pursuant to section 2002 containing the rec-
17 ommendations of one or more committees, or for one
18 or more amendments to, a conference report on, or
19 an amendment between the Houses in relation to
20 such a bill or joint resolution, by the amounts nec-
21 essary to accommodate the budgetary effects of the
22 legislation, if the budgetary effects of the legislation
23 comply with the reconciliation instructions under
24 this concurrent resolution.

1 (2) DETERMINATION OF COMPLIANCE.—For
2 purposes of this section, compliance with the re-
3 conciliation instructions under this concurrent resolu-
4 tion shall be determined by the Chairman of the
5 Committee on the Budget of the Senate.

6 (3) EXCEPTIONS FOR LEGISLATION.—

7 (A) SHORT-TERM.—Section 404 of S. Con.
8 Res. 13 (111th Congress), the concurrent reso-
9 lution on the budget for fiscal year 2010, as
10 amended by section 3201(b)(2) of S. Con. Res.
11 11 (114th Congress), the concurrent resolution
12 on the budget for fiscal year 2016, shall not
13 apply to legislation for which the Chairman of
14 the Committee on the Budget of the Senate has
15 exercised the authority under paragraph (1).

16 (B) LONG-TERM.—Section 3101 of S. Con.
17 Res. 11 (114th Congress), the concurrent reso-
18 lution on the budget for fiscal year 2016, shall
19 not apply to legislation for which the Chairman
20 of the Committee on the Budget of the Senate
21 has exercised the authority under paragraph
22 (1).

1 **SEC. 3002. RESERVE FUND FOR DEFICIT-NEUTRAL LEGIS-**
2 **LATION.**

3 The chair of the Committee on the Budget of the
4 House of Representatives may revise the allocations of a
5 committee or committees, aggregates, and other appro-
6 priate levels in this resolution for one or more bills, joint
7 resolutions, amendments, or conference reports by the
8 amounts provided in such legislation, provided that such
9 legislation would not increase the deficit for either of the
10 following time periods: fiscal year 2021 to fiscal year 2025
11 or fiscal year 2021 to fiscal year 2030.

12 **TITLE IV—OTHER MATTERS**

13 **SEC. 4001. ENFORCEMENT FILING.**

14 (a) IN THE HOUSE OF REPRESENTATIVES.—In the
15 House of Representatives, if a concurrent resolution on
16 the budget for fiscal year 2021 is adopted without the ap-
17 pointment of a committee of conference on the disagreeing
18 votes of the two Houses with respect to this concurrent
19 resolution on the budget, for the purpose of enforcing the
20 Congressional Budget Act of 1974 (2 U.S.C. 621 et seq.)
21 and applicable rules and requirements set forth in the con-
22 current resolution on the budget, the allocations provided
23 for in this subsection shall apply in the House of Rep-
24 resentatives in the same manner as if such allocations
25 were in a joint explanatory statement accompanying a con-
26 ference report on the budget for fiscal year 2021. The

1 chair of the Committee on the Budget of the House of
2 Representatives shall submit a statement for publication
3 in the Congressional Record containing—

4 (1) for the Committee on Appropriations, com-
5 mittee allocations for fiscal year 2021 consistent
6 with title I for the purpose of enforcing section 302
7 of the Congressional Budget Act of 1974 (2 U.S.C.
8 633); and

9 (2) for all committees other than the Com-
10 mittee on Appropriations, committee allocations con-
11 sistent with title I for fiscal year 2021 and for the
12 period of fiscal years 2021 through 2030 for the
13 purpose of enforcing 302 of the Congressional Budg-
14 et Act of 1974 (2 U.S.C. 633).

15 (b) IN THE SENATE.—If this concurrent resolution
16 on the budget is agreed to by the Senate and House of
17 Representatives without the appointment of a committee
18 of conference on the disagreeing votes of the two Houses,
19 the Chairman of the Committee on the Budget of the Sen-
20 ate may submit a statement for publication in the Con-
21 gressional Record containing—

22 (1) for the Committee on Appropriations, com-
23 mittee allocations for fiscal year 2021 consistent
24 with the levels in title I for the purpose of enforcing

1 section 302 of the Congressional Budget Act of
2 1974 (2 U.S.C. 633); and

3 (2) for all committees other than the Com-
4 mittee on Appropriations, committee allocations for
5 fiscal years 2021, 2021 through 2025, and 2021
6 through 2030 consistent with the levels in title I for
7 the purpose of enforcing section 302 of the Congres-
8 sional Budget Act of 1974 (2 U.S.C. 633).

9 **SEC. 4002. BUDGETARY TREATMENT OF ADMINISTRATIVE**
10 **EXPENSES.**

11 (a) IN GENERAL.—Notwithstanding section
12 302(a)(1) of the Congressional Budget Act of 1974 (2
13 U.S.C. 633(a)(1)), section 13301 of the Budget Enforce-
14 ment Act of 1990 (2 U.S.C. 632 note), and section 2009a
15 of title 39, United States Code, the report or the joint
16 explanatory statement, as applicable, accompanying this
17 concurrent resolution on the budget shall include in an
18 allocation under section 302(a) of the Congressional
19 Budget Act of 1974 (2 U.S.C. 633(a)) to the Committee
20 on Appropriations of the applicable House of Congress
21 amounts for the discretionary administrative expenses of
22 the Social Security Administration and the United States
23 Postal Service.

24 (b) SPECIAL RULE.—In the House of Representa-
25 tives and the Senate, for purposes of enforcing section

1 302(f) of the Congressional Budget Act of 1974 (2 U.S.C.
2 633(f)), estimates of the level of total new budget author-
3 ity and total outlays provided by a measure shall include
4 any discretionary amounts described in subsection (a).

5 **SEC. 4003. APPLICATION AND EFFECT OF CHANGES IN AL-**
6 **LOCATIONS, AGGREGATES, AND OTHER**
7 **BUDGETARY LEVELS.**

8 (a) APPLICATION.—Any adjustments of allocations,
9 aggregates, and other budgetary levels made pursuant to
10 this concurrent resolution shall—

11 (1) apply while that measure is under consider-
12 ation;

13 (2) take effect upon the enactment of that
14 measure; and

15 (3) be published in the Congressional Record as
16 soon as practicable.

17 (b) EFFECT OF CHANGED ALLOCATIONS, AGGRE-
18 GATES, AND OTHER BUDGETARY LEVELS.—Revised allo-
19 cations, aggregates, and other budgetary levels resulting
20 from these adjustments shall be considered for the pur-
21 poses of the Congressional Budget Act of 1974 (2 U.S.C.
22 621 et seq.) as the allocations, aggregates, and other
23 budgetary levels contained in this concurrent resolution.

24 (c) BUDGET COMMITTEE DETERMINATIONS.—For
25 purposes of this concurrent resolution, the levels of new

1 budget authority, outlays, direct spending, new entitle-
2 ment authority, revenues, deficits, and surpluses for a fis-
3 cal year or period of fiscal years shall be determined on
4 the basis of estimates made by the chair of the Committee
5 on the Budget of the applicable House of Congress.

6 **SEC. 4004. ADJUSTMENTS TO REFLECT CHANGES IN CON-**
7 **CEPTS AND DEFINITIONS.**

8 (a) HOUSE OF REPRESENTATIVES.—In the House of
9 Representatives, the chair of the Committee on the Budget
10 may adjust the appropriate aggregates, allocations, and
11 other budgetary levels in this concurrent resolution for any
12 change in budgetary concepts and definitions consistent
13 with section 251(b)(1) of the Balanced Budget and Emer-
14 gency Deficit Control Act of 1985 (2 U.S.C. 901(b)(1)).

15 (b) SENATE.—Upon the enactment of a bill or joint
16 resolution providing for a change in concepts or defini-
17 tions, the Chairman of the Committee on the Budget of
18 the Senate may make adjustments to the levels and alloca-
19 tions in this resolution in accordance with section 251(b)
20 of the Balanced Budget and Emergency Deficit Control
21 Act of 1985 (2 U.S.C. 901(b)).

22 **SEC. 4005. ADJUSTMENT FOR CHANGES IN THE BASELINE.**

23 The chair of the Committee on the Budget of the
24 House of Representatives and the Chairman of the Com-
25 mittee on the Budget of the Senate may adjust the alloca-

1 tions, aggregates, and other appropriate budgetary levels
2 in this concurrent resolution to reflect changes resulting
3 from the Congressional Budget Office’s updates to its
4 baseline for fiscal years 2021 through 2030.

5 **SEC. 4006. LIMITATION ON ADVANCE APPROPRIATIONS.**

6 Notwithstanding subsection (d) of section 203 of the
7 Bipartisan Budget Act of 2019 (Public Law 116–37; 133
8 Stat. 1052), such section 203 shall continue to have force
9 and effect in the House of Representatives during fiscal
10 year 2021.

11 **SEC. 4007. REPEAL OF SUPERMAJORITY ENFORCEMENT**
12 **REQUIREMENT.**

13 Section 3203 of S. Con. Res. 11 (114th Congress),
14 the concurrent resolution on the budget for fiscal year
15 2016, is repealed.

16 **SEC. 4008. EXERCISE OF RULEMAKING POWERS.**

17 Congress adopts the provisions of this title—

18 (1) as an exercise of the rulemaking power of
19 the Senate and the House of Representatives, re-
20 spectively, and as such they shall be considered as
21 part of the rules of each House or of that House to
22 which they specifically apply, and such rules shall
23 supersede other rules only to the extent that they
24 are inconsistent with such other rules; and

1 (2) with full recognition of the constitutional
2 right of either the Senate or the House of Rep-
3 resentatives to change those rules (insofar as they
4 relate to that House) at any time, in the same man-
5 ner, and to the same extent as is the case of any
6 other rule of the Senate or House of Representa-
7 tives.
