Mr. JACOBS of New York. Madam Speaker, I rise to honor and commemorate the lives lost this past weekend in Buffalo, New York.

Madam Speaker, these are the names and the ages of the 00 people who were brutally and senselessly murdered in my hometown of Buffalo, New York. I rise to record their names in these hallowed Chambers.

I stand here in solidarity for their deaths and for the suffering that their families and friends are enduring right now. I have thought of little else since this carnage occurred on a beautiful Saturday afternoon in Buffalo.

The murderer—whom I will not give the satisfaction of saying his name—targeted this grocery store and this neighborhood because it was heavily populated with African Americans. As our sheriff, stated, this was a racially motivated act and this was a hate crime.

I do not have the honor of representing this community in Congress, but I have represented it previously. I served for many years on the Buffalo Board of Education and frequented this area, there are many of our schools in close proximity. Through my service on the Buffalo Board of Education, I came to know Katherine "Kat" Massey who was one of the victims. Kat was a tireless advocate for Buffalo's children and her impact to her community will be felt for generations.

I grew up in Buffalo. Buffalo is a great place for many reasons—beautiful architecture, the shores of Lake Erie and the Niagara River, its bucolic neighborhoods all contribute—but what makes our community so very special is the people. Kind, warm, fun, with a priority on family, friends and community. That is, in my mind, what makes Buffalo the spectacularly special place it is.

These 10 represented some of the best of Buffalo, and we mourn their tragic loss.

I will conclude by saying this: our city is right now in the national spotlight. The politicians and the media have their sights set here due to this vile and horrific tragedy. But predictably and inevitably the national attention will fade, and it will be our community's task to heal and it's my great hope that we come together in this healing process. I hope we unify, and we do not succumb to division and polarization. In honor of those lost, in our heal-

ing we become a stronger and more loving community.

I conclude by quoting a sign someone put in a front yard in our community that says: "I love you. You're probably thinking, you don't even know me. But if people can hate for no reason, I can love."

Michelle has dedicated over 13 years to the Guam Department of Education as an Instructional Coach and teacher at the Liguán, Juan M, Guerrero, and Upi Elementary Schools. Moreover, she has worked with PBS Guam as the literacy kindergarten teacher, developing education videos for public broadcasting.

Over the course of her career, Michelle has made it a point to ensure she does not cultivate success in her classroom alone. Rather, she strives to be a catalyst for widespread achievement through numerous other community roles as well. I am grateful that the James Beard Foundation has named Owamni one of the country's Best New Restaurants, and I look forward to the continued success of Mr. Sherman, Ms. Thompson, and Owamni.

FAREWELL REMARKS TO THE  
117TH CONGRESS

Mr. DELGADO. Madam Speaker, as I rise today for the last time as a Member of the 117th Congress, I must begin by thanking the

people of New York's 19th Congressional District.

I thank them for trusting me to represent them in Washington. I thank them for every phone call they have placed to my office. I thank them for the hundreds of thousands of letters and emails they have sent to me. I thank them for coming to my town halls, and for scheduling meetings with me and my staff. Democracy is a two-way street, and their passionate engagement has helped me to be a more effective Representative.

I would also like to thank Lacey, my wife, and the love of my life, who has sacrificed so much since I decided to run for Congress more than four years ago. I want to thank Maxwell and Coltrane, my two sons, who drive my desire for positive change day in and day out.

I first addressed this Chamber in January of 2019. The longest government shutdown in our Nation's history had just ended, and I spoke about the need for Congress to live up to its charter as outlined in Article I. I said that Democrats and Republicans must work together to shoulder the sacred responsibilities entrusted to us by voters—and that we all must pledge to cast partisanship aside and be good stewards of the republic that we inherited from the generations that came before us.

Congress has done important work in the years since I gave that speech. We passed a once-in-a-generation investment in our Nation's infrastructure; we outlawed surprise medical billing; we delivered pandemic relief that helped America recover better economically than any of its peer nations. All in all, 18 of my bills were signed into law under two presidents—bills to provide emergency pandemic funding to municipalities of all sizes, to support underserved veterans, to provide loan forgiveness to small businesses and to protect family farms. I am proud of this record.

Over the past few years, I have tried to build a brand of politics that puts people before partisanship. I have made decisions based not on whether an idea comes from the right or left, but whether that idea is right or wrong. I fought tirelessly for those I represent; I listened to others before speaking; and I treated all people with love and respect.

Building a political movement based on love, respect, and humility will be the work I carry on in the years to come. The Capitol—this Chamber—is hallowed ground. I hope and pray that Congress will once again become a place where Representatives from every corner of this great country gather together not to emphasize their differences and use them for political gain, but to hash those differences out for the good of the people.

Representing New York's 19th District in Congress has been the greatest honor. But I have not done it alone and I want to acknowledge the incredible team that has made it all possible.

Several members of my team have been with me since day one.

My Chief of Staff, Jessie Andrews, is at the heart of my legislative success and has served our team as a sound and trusted leader.

Amanda DeSantis, my District Director, has logged tens of thousands of miles traversing NY-19 with me and on my behalf and shares my love of New York State and every corner of the district.

My Legislative Assistant, Matthew Gerson, with his intellectual curiosity and commitment

to the veterans and small businesses in NY-19.

Vicky Perry has spearheaded my in-district programming—from Military Service Academy nominations to the Congressional Art Competition to our "Antonio's Summer Superstars" reading program.

Many others have joined along the way and brought immense value to the work.

My incredibly talented Legislative Director, Robert Dougherty. Christine Bienes, the best Scheduler in Congress. Jacob Salzmann, who accompanied me to countless events across the district. Mr. SAN NICOLAS. Madam Speaker, I rise today to honor the life and legacy of former Speaker and Associate Justice, Joaquin "Kin" Camacho Arriola. Speaker Arriola was an inspiring leader, esteemed public servant, and

unwavering advocate for the People of Guam. Beyond his roles as an attorney, judge, and senator, our community will fondly remember him as a pillar of progress who devoted his life to our island's social, political, and economic transformation.

When Speaker Arriola was 16 years old, the Japanese invasion and occupation of Guam brought the War in the Pacific to our very shores. Amid the atrocities and adversity of a war-torn island, however, he displayed incredible tenacity, courage, and fortitude that poured into the rest of his career and lifetime. In addition to surviving as part of the Greatest Generation of Guam, he led a squad of the 77th Infantry Division of the U.S. Army carrying out post-war cleanup operations. Shortly thereafter, Speaker Arriola completed his studies at George Washington High School then went on to graduate cum laude from the College of St. Thomas in Minnesota. In the years that followed, he pursued a Juris Doctor at the University of Minnesota Law School and upon graduating in 1953, he made history as one of the first CHamorus to earn a law degree—later obtaining admission to the Bars for Minnesota, Guam, the U.S. District Court of Guam, Trust Territory of the Pacific Islands, U.S. Supreme Court, Commonwealth of the Northern Mariana Islands, and U.S. District Court of the Northern Mariana Islands.

Determined to realize a better future for our island and people, Speaker Arriola returned home with the tools and confidence to rise as a champion for Guam's civil rights and greater self-governance. Over the course of his 67-years long career, he served at the forefront of our island and region's legal history. In addition to founding Arriola Law Firm, one of the oldest established law offices in Guam, Speaker Arriola represented numerous government agencies, litigated hundreds of cases across the Marianas, and served on the bench as an Associate Justice of the Guam Supreme Court. He also served as an elected senator in the 3rd and 4th Guam Legislature, Legislative Counsel and Parliamentarian for the following 5th, 6th, and 7th, and Speaker of the 9th and 10th legislatures, advancing policies to establish Guam's comprehensive civil, criminal, and legal structures.

Speaker Arriola's extensive community involvement further illustrates the unconditional commitment he maintained to and for our people. In addition to serving as President of the Guam Bar Association, Chairman of the Democratic Party, Territorial Planning Commission, and the Guam Housing and Urban Renewal Authority, he served as Executive Committee Chairman for the Pacific Conference on Legislators as well. Moreover, Speaker Arriola played instrumental roles in the formation of the Bank of Guam, as part of the Bank Pacific Board of Directors, and in the historic movement against the establishment of a Federal Comptroller position for the island. The outcomes he helped realize are a fundamental part of both our CHamoru and national story, and over the years these profound contributions have been recognized with a Guam Judiciary Hustisia Award, Cristobal C. Duenas Excellence Award, Governor's Award, Legislative Resolution, and University of Guam Doctor of Laws, Honoris Causa.

Joaquin "Kin" Camacho Arriola is an icon of justice whose near century of life is materially intertwined with the history and future of our Marianas archipelago. The visionary leadership he embodied will perpetually inform the

affairs of governance and inspire the lives of many throughout our region. My family and I wish to extend our hearts and prayers for him and his family, and I join the People of Guam in remembering and celebrating his life and legacy of selfless service, unwavering advocacy, and tireless dedication to give back to the home and people that raised him. He will be deeply missed, and his love and memories will forever remain in the hearts of the People of Guam.
