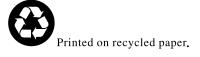

#### FY 2023 Project Summary

The General Services Administration (GSA) is proposing to invest in projects that directly result in reduced energy usage, reduced water usage, utility cost savings, and reduced pollution and emissions in Government-owned buildings beginning in Fiscal Year (FY) 2023.

#### FY 2023 Committee Approval and Appropriation Requested ......\$15,000,000

#### **Program Summary**

GSA proposes the implementation of energy and water retrofit and conservation measures in Government-owned buildings beginning in FY 2023. The Energy and Water Conservation Measures Program (Program) is designed to reduce on-site energy and water consumption through building alteration projects or retrofits of existing buildings systems. Completing these projects is an important part of GSA's approach to complying with requirements in the Energy Act of 2020 (EA2020) and Executive Order 14057: Catalyzing Clean Energy Industries and Jobs Through Federal Sustainability.

Projects will reflect GSA and Administration priorities including improving reducing costs; advancing clean and innovative technologies; and reducing pollutants and emissions from building operations. Furthermore, this investment may generate rebates and incentives from utility companies and grid operators.

In addition to meeting the stated priorities, proposed projects will be screened for life-cycle cost effectiveness to ensure they will generate a positive return-on-investment within the expected lifetime of the equipment.

This Prospectus program supports design and construction of energy and water management projects and retrofits in Federal buildings. Typical projects include, but are not limited to, the following:

- Upgrade heating, ventilation, and air-conditioning (HVAC) systems with new, high efficiency systems;
- Replace existing lighting and lighting controls including associated wiring:
- Install and upgrade building automation systems (BAS) and energy management control systems (EMCS);
- Design and install and connect renewable energy systems including solar photovoltaics, solar water heating, and wind power;

- Design and install advanced geothermal heat pumps to replace conventional heating and cooling equipment;
- Install or repair energy and water metering systems, diagnostic sensors, and equipment;
- Replace electrical motors with multi-speed or variable-speed motors;
- Install battery backup systems with load shedding and grid stabilization functions;
- Insulate roofs, walls, pipes, HVAC ducts; and mechanical equipment;
- Install multi-pane windows, and seal and repair existing windows;
- Upgrade plumbing systems with high efficiency toilets and sinks; and
- Install high efficiency irrigation and watering systems and provide for native landscaping and natural habitat restoration.

#### **Justification**

GSA is leading by example on the call to action and helping to facilitate an all-of-government approach to address climate change in federal government operations including implementing efficiency projects and reducing reliance on fossil fuels. GSA's portfolio includes a significant number of Federal buildings with investment needs in critical, energy-consuming infrastructure. GSA is increasing the agency's focus to improve energy and water efficiencies to reduce usage and costs along with the associated greenhouse gas emissions. Statutory and Executive Order direction supports key investments in energy and water to exceed prior levels of consumption and emission.

Approval of this FY 2023 request will enable GSA to meet these goals.

#### FY 2023 Project Summary

This prospectus proposes alterations to upgrade, replace, and improve fire protection systems and life-safety features in buildings under the jurisdiction, custody, and control of the General Services Administration (GSA) during fiscal year (FY) 2023.

Since FY 2010, GSA has received \$173,224,000 in support of this program. These funds supported 106 projects in 98 Government-owned buildings.

FY 2023 Committee Approval and Appropriation Requested ......\$30,000,000

#### **Program Summary**

As part of its fire protection and life-safety efforts, GSA is currently identifying projects in Federal buildings throughout the country through surveys and studies. These projects will vary in size, location, and delivery method. The approval and appropriation requested in this prospectus is for a set of retrofit projects with engineering solutions to reduce fire and life-safety hazards. Typical projects include:

- Replacing antiquated fire alarm and detection systems that are in need of repair or for which parts are no longer available.
- Installing emergency voice communication systems to facilitate occupant notification and evacuation in Federal buildings during an emergency.
- Installing or expanding, as necessary, fire sprinkler systems to provide a reasonable degree of protection for life and property from fire in Federal buildings.
- Constructing additional exit stairs or enclosing existing exit stairs to facilitate the safe and timely evacuation of building occupants in the event of an emergency.

#### Justification

GSA periodically assesses all facilities to identify hazards and initiate correction or risk-reduction protection strategies so that its buildings do not present an unreasonable risk to Government personnel or the general public. Completion of these proposed projects will improve the overall level of safety from fire and similar risks in features in buildings under the jurisdiction, custody, and control of GSA.

#### FY 2023 Project Summary

This prospectus proposes alterations to improve physical security in buildings under the jurisdiction, custody, and control of the General Services Administration (GSA) occupied by the Federal judiciary and the Department of Justice, U.S. Marshals Service (USMS), during fiscal year (FY) 2023.

Since FY 2012, GSA has received \$128,922,000 in support of this program. These funds were allocated to 15 projects.

FY 2023 Committee Approval and Appropriation Requested ......\$20,000,000

#### **Program Summary**

The Judiciary Capital Security program is dedicated to improving physical security in buildings occupied by the Federal judiciary and USMS. These projects are in lieu of constructing new facilities, thereby providing cost savings and expedited delivery. These projects will vary in size, location, and delivery method, and are designed to improve the separation of circulation for the public, judges, and prisoners. Funding provided for the security improvement projects will address elements such as adding doors, reconfiguring, or adding corridors, reconfiguring or adding elevators and sallyports, and constructing physical or visual barriers.

#### **Justification**

This program provides funding to address security deficiencies in existing Federal facilities in a timely and less costly manner than constructing a new courthouse. The projects in this program are based on studies undertaken by the judiciary. This prospectus requests separate funding to address security conditions at existing Federal courthouses. GSA uses the judiciary's asset management planning process to assist in the identification of potential projects that involve courthouses with poor security ratings nationwide.

#### FY 2023 Program Summary

This prospectus proposes alterations to install, upgrade, and improve seismic performance in buildings under the jurisdiction, custody, and control of the General Services Administration (GSA).

Since FY 2018, GSA has received \$8,696,000<sup>1</sup> in support of this program. These funds supported six projects in six GSA-controlled buildings.

FY 2023 Committee Approval and Appropriation Requested ......\$10,000,000

#### **Program Summary**

As part of its Seismic Mitigation program efforts, GSA is currently identifying seismic risks in Federal facilities in high seismic areas throughout the country through previous seismic evaluations, inspections, and 41 American Society of Civil Engineers Tier 1 studies undertaken as part of the GSA Seismic Risk Rating program. The approval requested in this prospectus is for a set of retrofit projects with engineering solutions to reduce hazards. Resulting mitigation projects will vary in size, location, and delivery method. Typical projects include:

- Installing or upgrading seismic bracing on fire suppression piping, water lines, gas lines, and steam lines to reduce fire risk and reduce risk from falling hazards to the building occupants;
- Installing seismic bracing on partitions with large height-to-thickness ratios, terra cotta, or unbraced stairwell conditions, including revisions to stairs to allow for relative floor movement during seismic events;
- Installing seismic bracing and snubbers, as required, to mechanical and electrical equipment to reduce instability, fire risk, and post-event downtime;
- Installing seismic bracing on and above suspended ceilings to prevent ceilings, fixtures, equipment, and piping from falling;
- Bracing parapet walls and other facade elements to reduce falling hazards at the exterior of buildings and at building exits;
- Strengthening diaphragm and connections to lateral load resisting elements;
- Strengthening critical structural members and connections; and

• Anchoring features and installing seismic bracing on furniture, fixtures, and equipment to mitigate injury risk.

#### Justification

Based on seismic studies, GSA initiated a program to identify nonstructural seismic hazards, and initiated correction and risk reduction projects associated with those hazards. According to the Department of Homeland Security, Federal Emergency Management Agency, most of the damage caused by several recent U.S. earthquakes was the result of nonstructural failures and falling nonstructural building components are responsible for the majority of injuries. Completion of projects funded through this program will reduce the risk from seismic events in GSA-controlled buildings.

#### FY 2023 Project Summary

The General Services Administration (GSA) proposes a repair and alteration project to upgrade, replace, and improve the conveying systems in multiple buildings under the jurisdiction, custody, and control of GSA during fiscal year (FY) 2023.

#### **Major Work Items**

Elevator, escalator, and wheelchair lift upgrades; hazardous materials abatement; and life-safety upgrades

#### **Proposed Project**

The program proposes the full modernization of the elevators, escalators, and wheelchair lifts in numerous Government-owned buildings within GSA's inventory. All the buildings evaluated are considered long-term holds, and the proposed modernizations are required to extend the useful life of these assets. The proposed projects include:

- Replacement of the major system components, including motors and controls, and upgrades to elevator pits, machine rooms, and interior cabs; and
- Incorporation of power standby technologies in escalators to reduce energy consumption during periods of low or no passenger activity, and hazardous materials abatement.

#### **Justification**

The repairs and replacements of these systems will provide reliable, timely, and efficient service and meet current building codes, and fire, life-safety, and accessibility requirements. The current systems have exceeded their useful lives and are difficult to maintain. Some of the equipment dates to the original construction of the buildings and component parts are no longer manufactured. Tenant impacts include numerous entrapments in the elevators and multiple elevators or escalators being taken out of service due to mechanical failures and lack of replacement parts. The systems are not in compliance with current code and safety standards, and the control systems are not compatible with current technology.

The General Services Administration (GSA) proposes a repair and alteration project to upgrade, replace, and improve the fire alarm systems in multiple Government-owned buildings during fiscal year (FY) 2023 to address critical fire-safety issues.

#### FY 2023 Project Summary

The General Services Administration (GSA) proposes the reconfiguration and renovation of space within Government-owned and leased buildings during fiscal year (FY) 2023 to support GSA's ongoing consolidation efforts to improve space utilization, optimize inventory, decrease reliance on leased space, and reduce the Government's environmental footprint.

Since the inception of the Consolidation Activities program in FY 2014, GSA has received \$322,353,000 in support of the program and, through FY 2021, has funded 87 projects. When complete, these 87 projects will result in more than a 1.8 million usable square foot space reduction, thereby reducing agency rental payments to GSA by \$76 million annually and generating more than \$163,000,000 in annual Government lease cost avoidance. These projects will more than recover the initial capital investment after just two years of project completion and will continue to accrue additional savings over the life of these assets.

#### FY 2023 Committee Approval and Appropriation Requested ......\$30,000,000

#### **Program Summary**

As part of its ongoing effort to improve space utilization, optimize inventory, decrease reliance on leased space, and reduce the Government's environmental footprint, GSA is identifying consolidation opportunities within its inventory of real property assets. These opportunities are presented through surveys and studies, partnering with customer agencies and agency initiatives. Projects will vary in size by location and agency mission and operations; however, no single project will exceed \$20 million in GSA costs. Funds will support consolidation of customer agencies and will not be available for GSA internal consolidations. Preference will be given to projects that result in an office utilization rate of 130 usable square feet per person or less and a total project payback period of 10 years or less.

Typical projects include the following:

- Reconfiguration and alteration of existing Federal space to accommodate incoming agency relocation/consolidation (which may include reconfigurations of existing occupied Federal tenant space);
- Right sizing the federal footprint including restacking and consolidations to account for anticipated remote and hybrid work arrangements; and
- Incidental alterations and system upgrades, such as fire sprinklers or heating, ventilation, and air conditioning, needed as part of relocation and consolidation.



His service to our city has proven invaluable and we continue to express our endless gratitude.

While protecting and serving your community for over 15 years is remarkable in and of itself, Captain Hughley continues to go above and beyond the call of duty. Appointed by Governor Jay Nixon, he served as Commissioner of the Missouri Peace Officers Standards & Training Commission from 2015 until 2019. A delegation created to analyze the current training practices of law enforcement in hopes of creating better outcomes for both officers and those they serve, the Commission eventually increased continuing education programs and the training required for police officers throughout the State of Missouri. Having already obtained a degree in Criminal Justice from the University of Arkansas Grantham, Captain Hughley felt compelled to return to school. Applying his exceptional leadership experience to his coursework, Captain Hughley received an Executive Master of Business Administration from Rockhurst University in Kansas City, Missouri. He has used the knowledge gained from this program in his work both as a police officer and in his current position as Senior Advisor to the Regional Administrator at the Environmental Protection Agency. Captain Hughley masterfully employs his extensive education, professional experience, and institutional knowledge as he continues to support and serve the Kansas City community. We are extremely lucky to have such a kind and generous soul working to make our city the best that it can be.

The Black Achievers Society of Greater Kansas City is an acclaimed, respected, and exclusive institution. I founded this organization in 1974 with the goal of recognizing companies that demonstrated leadership in the areas of diversity and inclusion. Today, nearly 50 years later, the Black Achievers Society's mission is to respond to the multifaceted needs of the community by providing role models for Black and minority youth. Membership in the Society is reserved for African American professionals who have been nominated for their leadership, achievements, and community involvement. Having known him personally for many years and having seen the impact his work has made in the lives of others, it was with great joy that I nominated Captain Hughley for admission into the Societv. Being inducted as a member is a great honor and momentous occasion. I believe I speak for all Kansas Citians when I say that Captain Hughley is deeply deserving of this induction. I look forward to seeing all that he accomplishes and wish him the best of luck in all his future endeavors.

Lawanda made a career of treating people with compassion and respect, working to ensure that each defendant received their constitutional right to a good defense.

Where Lawanda sees a need, she takes action. After the murder of George Floyd, she used her position on the Santa Maria Police Department's police advisory board to call for the creation of a civilian review board to investigate officers accused of abuse and help rebuild trust between the police and community.

With the many daunting challenges brought on by the COVID-19 pandemic, her leadership has guided many in the community to safely face those challenges. In the destructive wake of COVID-19, Lawanda became a trusted source for information about the virus and the vaccine. She is a strong advocate for COVID-19 vaccination within the BIPOC community, taking the time to talk through questions and fears, helping to ease vaccine hesitancy and encourage individuals to protect themselves and those around them. She gives so much of her time, energy, and resources to serve our community.

Lawanda's openness and commitment to her community is a testament to her selflessness. She is a worthy candidate for this honor and a role model for community leaders of all kinds.

Mr. McCARTHY. Madam Speaker, I rise today to honor the Director of the National Aeronautics and Space Administration (NASA) Armstrong Flight Research Center, David McBride, on his retirement after many years of service to the scientific community.

Pursuing his passion for aeronautics research, David kicked off his career with NASA as a cooperative education student in 1982. Specializing in digital flight control systems analysis, he explored the way in which aircraft perform under an array of flight test conditions. Wanting to continue his interest in the field, David received both an undergraduate and graduate degree from the University of New Mexico, earning his Bachelor of Science in Electrical Engineering in 1985 and Executive Master of Business Administration in 1998

Upon graduation, David climbed the ranks at NASA Armstrong, eventually becoming Program Manager for the Flight Research Program, as well as Deputy Center Director and Associate Director for Programs and Projects. In these roles, David was integral in the study, development, and testing of groundbreaking technologies, including the Intelligent Flight Control System, X–53 Active Aeroelastic Wing flight research project, and solar-powered Helios aircraft.

In 2010, David was appointed Director of the Armstrong Flight Research Center, formerly the Hugh L. Dryden Flight Research Center. Under his leadership, NASA Armstrong remained the premier research center for aeronautics in the United States. In fact, NASA Armstrong conducted critical flight development tests over the years, including the notable testing of the X-48B/C hybrid wing body experimental aircraft and the testing of NAŚA Orion's launch and abort systems. Additionally, during David's tenure as Director, NASA Armstrong's Boeing 747SP SOFIA (Stratospheric Observatory for Infrared Astronomy) project became fully operational—a feat that has allowed our nation's foremost scientists to further our nation's scientific understanding.

Throughout his career, David has devoted himself to exploring new frontiers and building upon NASA Armstrong's proud legacy of scientific discovery. Though he will be greatly missed at the Armstrong Flight Research Center, I am confident David will continue to be a force in the world of scientific development. Rev. Lindsey made a firm commitment to the church in December 1983, and he began a life of faithful service at the Samaritan Missionary Baptist Church, where his family has worshipped since 1952. Under the stellar leadership of the late Pastor Robert E. Starghill, Sr., Rev. Lindsey was ordained as a deacon in March 1984 and served in a variety of leadership and service roles, including financial clerk, board secretary, Bible teacher, van ministry, Pastor's Chorus, and Men's group president.

In June 1992, Rev. Lindsey served as Pastor of the Greater Bibleway Missionary Baptist Church in Detroit, Michigan. During his tenure, Rev. Lindsey has diligently cultivated the congregation's spiritual growth and development and prioritizes expository preaching, sound biblical teaching, and the practical application of scriptural principles. With the assistance of faithful deacons and trustees, Pastor Lindsey oversees the church's pastoral and business administration. For thirty years, Rev. Lindsey has faithfully performed the clerical duties of "feeding and tending the flock," including teaching and preaching the Word, christening newborns, baptizing new believers, providing spiritual counsel to individuals and couples, comforting the bereaved, visiting sick and infirmed members, and aiding congregants in times of need.

Before joining WSU in 2012, Rev. Lindsey was Director of External Affairs & Development for Focus: HOPE and enjoyed a 20-year career at Chrysler as Manager of Community Relations and Senior Manager of State Relations

I am genuinely amazed by Rev. Lindsey's extended capacity for a true impact on the community, evident in his various leadership roles, organizational affiliations, and volunteer activities. He currently serves as a member of the Board of Trustees of the National Urban League, board member and past Board Chair of the Urban League of Detroit and Southeast Michigan, Vice Moderator of the Pleasant Grove Baptist District Association, board member and Secretary of Detroit Community Health Connection, board and executive committee member of the Eastside Community Network, member of the committee advisory committee of Meridian Health, and board member and nomination committee chair of the Detroit Public Schools Foundation. He has also served in other organizations, including the City of Detroit Workforce Development Board, Black Family Development, Inc., Mack Alive. Wavne State University Human Investigation Committee, and the Eight Mile Boulevard Association, to name a few. He is a proud member of the Alpha Phi Alpha Fraternity, Inc., and a life member of the Detroit Branch NAACP and the University of Michigan Alumni Association.

I congratulate Rev., and First Lady Lindsey, on three decades of service to all.

Mr. CLEAVER. Madam Speaker, it is my distinct honor to rise on behalf of Missouri's Fifth Congressional District, Kansas City, Missouri, and more specifically the Northland, to celebrate the lasting legacy of Jay B. Dillingham. A true local icon, one cannot tell the story of Kansas City without telling the story of Mr. Dillingham. Born on March 8, 1910, Mr. Dillingham served the Greater Kan-

sas City area and the States of Missouri and Kansas until his passing on August 13, 2007.

In 1935. Mr. Dillingham received his master's degree from the Kansas City School of Law, which would later become the University of Missouri-Kansas City. Nevertheless, soon after graduating, he was recruited to work at the Kansas City Stockyards and never practiced law. From 1948 through 1975. Mr. Dillingham served as president of the stockvards, one of Kansas City's greatest industries, where thousands of cattle, pigs, sheep, horses, and mules were auctioned in the West Bottoms each year. As president of the famed Kansas City Stockyards, a role he took on while only 38 years old, Mr. Dillingham helped turn the American Royal Livestock Show into a national institution. He once said about the stockyards: "There's nothing around here I haven't done . . . from shoveling manure to cleaning the sewers." In 1949, Mr. Dillingham founded the Golden Ox Steakhouse in the Kansas City Livestock Exchange Building, making it the city's oldest steakhouse and the birthplace of the Kansas City strip.

As part of his family's farming activities, Mr. Dillingham worked on 2.500 acres of beautiful Missouri River bottomland. He was also deeply engaged in developing lakes in the Kansas River basin along with Clay County's Smithville Lake. Following the Great Flood of 1951, he oversaw the cleanup and assisted in getting the town back to work. He was a member of the Missouri State Water Resource Board and assisted the U.S. Army Corps of Engineers in the construction of massive reservoirs throughout Missouri and Kansas. In Genesis 2:15, one of the first things God asked of us was to be good stewards of the land: "The LORD God then took the man and settled him in the garden of Eden, to cultivate and care for it." It is indisputable that Mr. Dillingham was a great steward of the land and gave most of his time on this earth looking after it.

Mr. Dillingham was the only person to ever serve as president of the Kansas City, Missouri and Kansas City, Kansas Chambers of Commerce. It's because of Mr. Dillingham's impactful work and public service that Governor Joe Teasdale and Governor Kit Bond appointed him as Chairman of the Missouri Department of Transportation's Missouri Highways and Transportation Commission from 1978 to 1983. It was in this position that he would be given the nickname of "Father of I-435". Interstate 670, running through both Missouri and Kansas, carries his name today. Indeed, Mr. Dillingham was a driving force behind Kansas City's growth, including the decision to locate the Kansas City International Airport in the Northland.

Mr. Dillingham, in addition to being a successful businessman and public servant, was also a generous philanthropist who donated land from the stockyards for worthy causes like the American Royal and the construction of Kemper Arena, now known as the Hy-Vee Arena. Many universities and organizations across Missouri and Kansas also bear awards in his name due to his astounding leadership.
