



Mr. FOSTER. Madam Speaker, I rise today to celebrate the legacy of Mr. Daniel D. Dolan, Sr. Mr. Dolan was a U.S. Navy veteran, serving his country during the Korean War, who went on to serve both in the Aurora, IL Fire Department and the U.S. Postal Service before starting his own business, Dolan & Murphy Real Estate in 1965. Dan loved selling and buying real estate throughout his career, especially land. His legacy development being Farnsworth International, which encompassed 450 acres of land on the North side of the I-88 and Farnsworth Avenue Cloverleaf Interchange in Aurora and is home to millions of square feet of Commercial and Industrial buildings (including Chicago Premium Outlet Mall) and is the largest Real Estate Tax base in Kane County, III. Dan was also very proud and instrumental in the extension of Indian Trail Road from Farnsworth Ave to the far eastern boundary of Aurora. Dolan and Murphy had just celebrated their 55th year in business when Dan passed on February 20, 2020.

Born and raised in Aurora, IL, Mr. Dolan believed strongly in giving back to his commu-

nity. He often did so through his business and life's passion, Dolan & Murphy Real Estate. Dolan & Murphy has sponsored little league baseball for over 50 years and fastpitch softball for over 35 years and Dan was inducted into the International Softball Congress Hall of Fame in August of 2016 for his long-time contribution as a sponsor. Dan believed that "what's good for Dolan & Murphy is good for Aurora" and worked hard to be charitable to the hometown he loved so deeply.

During an August 2021 House Armed Services Committee hearing, Chairman of the Joint Chiefs of Staff, Mark Milley and General Frank McKenzie, then the commander of the U.S. Central Command, both testified that they had recommended to Biden that he should leave a residual troop presence.

Additionally, in a closed Senate hearing, Operation Resolute Support Commander General Scott Miller testified that he opposed the Biden administration's decision to withdraw all U.S. forces, citing the threat posed by the Taliban.

The decision to withdraw U.S. forces from Afghanistan and abandon Americans regardless of the conditions on the ground, has been correctly identified by Senate Majority Leader MITCH MCCONNELL as "one of the worst foreign policy decisions in American history." While President Donald Trump went a step further saying, "This is the greatest embarrassment . . . in the history of our country."

Sadly, no response from the White House reveals admission of no 'letters.'

It is also important to ask where the American media is on this critical issue of the claimed Afghanistan letters?

Ultimately, this ill-advised decision not only resulted in the death of U.S. servicemembers, but put the reputation and credibility of the U.S. in question, all while leaving the remaining American citizens in Afghanistan vulnerable.

BUILD BACK BETTER ACT

Mr. BLUMENAUER. Madam Speaker, I came to Congress with a mission to make the federal government a better partner to local communities to make them more livable, healthy, and economically secure.

Last week, Congress made unprecedented progress on fulfilling the fundamental premise of this mission. The House and Senate both passed the Inflation Reduction Act, a historic investment in our nation's health, climate, and economy, including several provisions I authored to combat the climate crisis. President Biden is expected to sign the legislation into law this afternoon.

The Inflation Reduction Act will save Americans \$288 billion on health care over the next ten years. Critically, it will allow Medicare to negotiate prescription drug prices, starting with the ten most expensive prescriptions. These negotiations will bring down costs for patients and taxpayers alike. When combined with new provisions capping Medicare beneficiaries' outof pocket costs at \$2,000 a year, the legislation will make an extraordinary difference in peoples' lives.

This package is the single largest investment in climate action in our nation's history. It will deliver \$385 billion in energy and climate investments, including for electric vehicles, solar and wind energy, pollution reduction, and support for the vulnerable communities most impacted by environmental degradation. Long term extensions to the production and investment tax credits, including direct pay and transferability provisions, are critical components in ending our dependence on fossil fuels. I am also pleased that the investment tax credit was expanded to include energy storage projects, a key piece of the puzzle in delivering renewable energy to households at any time of day.

Combatting the climate crisis also means investing in infrastructure that is sustainable and

efficient. Clean transportation incentives like an expanded electric vehicle credit for new and used vehicles, an expanded credit to charge e-bikes and e-scooters, and incentives to electrify commercial fleets will help accelerate the reduction of carbon emissions and fossil fuels in our day-to-day activities. Likewise, any construction projects in the 21st century must be made to meet the needs and goals of our communities. That's why I advocated for provisions in this package that make commercial buildings more energy efficient and sustainable.

While working families in our community and across the nation are struggling to pay for basic goods like gas, groceries, and rent, ultra-wealthy corporations are raking in record profits. Inflation is hitting Americans hard while many corporations aren't paying their fair share. This legislation will enact a corporate minimum tax of 15 percent. Currently, hundreds of the largest corporations in America pay substantially less, or nothing, in taxes. This provision ensures that large corporations will pay a minimum of 15 percent in taxes. The legislation also makes polluters pay by including my legislation reinstating the Superfund tax on crude oil.

It is no secret that the Internal Revenue Service (IRS) is outmatched. Decades of chronic underfunding have left the IRS understaffed and overburdened, allowing hundreds of billions of dollars in taxes owed to go uncollected. This legislation provides \$3.2 billion for taxpayer services and \$45.6 billion for enforcement, which the Congressional Budget Office estimates will raise more than \$200 billion in additional revenue for the federal government. By investing in the IRS, we can finally close the "tax gap" between what people owe and what they end up paying.

The Inflation Reduction Act represents more than the sum of these individual provisions, it is proof that our system works and that the United States has the capacity to solve our most pressing challenges in the years ahead.

Significantly, no other country in the world commits more forces to United Nations Peace-keeping.

Bangladesh has a population of over 170 million, with a per capita income higher than

its neighbors in South Asia. The United States is one of Bangladesh's most important trading partners, with approximately 19–20 percent of its exports destined for the United States. Also, bilateral trade between the United States and Bangladesh was over \$10 billion (U.S.) in 2021.

According to the United States Census Bureau, there are over 200,000 people of Bangladeshi Origin living in America. Promoting educational exchanges between Bangladesh and the United States benefits both nations, and with approximately 10,000 students from Bangladesh studying in the United States, the country places eighth in the World in this category.

The Congressional Bangladesh Caucus will promote continued good relations between the United States and Bangladesh. Caucus Members will receive periodic updates on our bilateral relationship, joint efforts to combat terrorism and promote human rights, as well as opportunities for high-level visits between the two countries, including with Ambassador M Shahidul Islam as we work to strengthen our relationship.

Ms. NORTON. Madam Speaker, today, I rise to introduce a fiscal year 2022 supplemental appropriations bill to provide \$50 million to the Federal Emergency Management Agency's Emergency Food and Shelter Program (EFSP) for humanitarian assistance for migrants. The funding would remain available until expended.

Since mid-April, the governors of Texas and Arizona have exploited and harmed approximately 4,500 vulnerable people fleeing desperate and dangerous situations in their home countries for political gain by busing them to the District of Columbia and New York.

In fiscal year 2022, Congress provided \$150 million to the EFSP for humanitarian assistance for migrants. As of July 21, 2022, approximately \$85 million of this funding remained available. However, the busing of migrants to D.C. and New York has increased funding requests and the EFSP may exhaust its funding.

Supplemental funding would ensure that the EFSP can continue to provide humanitarian assistance to migrants. I strongly urge my colleagues to support this bill.

Dr. John Shirley was born in Santa Ana, California on December 8, 1924. At 19 years old, after being drafted and rising quickly to the rank of Staff Sergeant, John was part of the Anzio breakout with the 3rd Infantry Division. After taking part in the invasion of Southern France, he was wounded by fragments of a shell from a German tank and taken prisoner. As he and other prisoners were being marched to the rear, a young German soldier bringing up the rear of the column got too close, and John turned around and slugged him, rendering him unconscious and allowing John to escape to Allied lines. John was awarded a battlefield commission to Second Lieutenant when he rejoined his unit after three months in the hospital recovering from his wounds.

Aside from his commission, John was awarded a Purple Heart, Silver Star, and two Bronze Stars with Oak Leaf Cluster and V for Valor devise. He earned the European Theater of Operation Medal with six campaign stars and a bronze arrowhead for the invasion of Southern France, as well as the French Fouragère de Guerre.

After the war, John attended the University of California at Davis Veterinary College, graduating in its first class. He set up the first veterinary clinic in Livermore, California and was knowns as "Doc Shirley" to the ranchers in

the area. John was considered one of the best veterinarians in the region, with the toughest cases referred to him by his peers.

John became active in the Livermore community, winning a seat on the Livermore City Council, where he served from 1958 until 1966. He served as Livermore's Mayor from 1963 until 1966.

He was a member of the Rotary Club and Veterans of Foreign Wars (VFW). He led and was instrumental in many projects to improve the quality of life for Livermore residents and served on the VFW Honor Guard, firing gun salutes into his late seventies. John served as president of the Livermore Valley Opera, and as a member of the Livermore Symphony Association.

As a member of the 3rd Infantry Division Veterans organization, he raised money for high school Junior ROTC programs in San Francisco and Oakland. He was also instrumental in creating the Veterans First program at Las Positas Community College to provide services to veterans returning to school.

John loved sports, and was an avid skier, hiker, tennis player, and golfer. He was also a skilled instrument-rated pilot, which led him to further public service on the Livermore Airport Commission. John said, "You can be a bad golfer, skier, or tennis player, but you have to be a good pilot."

On July 13, 2019, Livermore City Council honored John by naming the new council chamber after him: The John Shirley City Council Chamber. John's list of contributions and accomplishments are too long to list. He was the very embodiment of service to his community and to our great Nation. I invite my colleagues to join me in honoring the memory of this great American.
