Janssen has agreements with the Biomedical Advanced Research and Development Authority related to the research and development of a COVID-19 vaccine totaling approximately \$900 million. Janssen has an agreement with the U.S. Army Contracting Command and related agencies to demonstrate large-scale manufacturing and delivery of the company's COVID-19 vaccine candidate, under which the government will receive up to 100 million doses of the vaccine.

Janssen has entered into various agreements with foreign governmental entities, including advance purchase agreements and a clinical supply agreement, regarding the company's COVID-19 vaccine candidate.
