## A BILL

To amend the Public Health Service Act to authorize supplemental awards to health centers to establish community transformation hubs.

1 *Be it enacted by the Senate and House of Representa-*  
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 This Act may be cited as the “Health Center Commu-  
5 nity Transformation Hub Act”.

1 **SEC. 2. SUPPLEMENTAL AWARDS TO SUPPORT COMMUNITY**  
2 **TRANSFORMATION HUBS.**

3 Section 330 of the Public Health Service Act (42  
4 U.S.C. 254b) is amended—

5 (1) by redesignating subsection (r) as sub-  
6 section (s); and

7 (2) by inserting after subsection (q) the fol-  
8 lowing:

9 “(r) SUPPLEMENTAL AWARDS TO SUPPORT COMMU-  
10 NITY TRANSFORMATION.—

11 “(1) IN GENERAL.—The Secretary may award  
12 to a health center receiving a grant under another  
13 provision of this section, as a supplement to such  
14 grant, funds to implement a community trans-  
15 formation hub to address the social determinants of  
16 health faced by patients served by the health center.

17 “(2) COMMUNITY TRANSFORMATION HUB DE-  
18 FINED.—In this subsection, the term ‘community  
19 transformation hub’ means a network of community-  
20 based organizations capable of addressing primary  
21 social determinants of health, including—

22 “(A) access to transportation;

23 “(B) food security;

24 “(C) economic security;

25 “(D) education access and quality;

26 “(E) neighborhood safety;

1                   “(F) systemic racism; and

2                   “(G) health of the built environment.

3                   “(3) CONSIDERATION.—In making supple-  
4                   mental awards under this subsection, the Secretary  
5                   shall consider—

6                   “(A) whether the health center involved  
7                   has conducted an assessment of the social de-  
8                   terminants of health facing the health center’s  
9                   patient population; and

10                  “(B) whether the proposed community  
11                  transformation hub would sufficiently address  
12                  these determinants.

13                  “(4) PARTNERSHIPS.—The Secretary may allow  
14                  health centers receiving a supplemental award under  
15                  this subsection to carry out the activities supported  
16                  through the award in partnership with community-  
17                  based organizations through a contract, a subgrant,  
18                  or a memorandum of understanding.

19                  “(5) TECHNICAL ASSISTANCE.—The Secretary  
20                  may provide technical assistance to award recipients  
21                  under this subsection with respect to planning, de-  
22                  velopment, and operation of community trans-  
23                  formation hubs supported under this subsection.

24                  “(6) COORDINATION.—Not later than 1 year  
25                  after the date of enactment of this subsection, the

1 Secretary, acting through the Administrator of the  
2 Health Resources and Services Administration and  
3 the Administrator of the Centers for Medicare &  
4 Medicaid Services, shall issue guidance on sustaining  
5 community transformation hubs funded under this  
6 section after such funding terminates.”.
