Mr. SIMPSON introduced the following bill; which was referred to the Committee on Natural Resources

A BILL

To amend the Infrastructure Investment and Jobs Act to authorize the use of funds for certain additional Carey Act projects, and for other purposes.

1 *Be it enacted by the Senate and House of Representa-*
2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. ELIGIBILITY UNDER THE INFRASTRUCTURE IN-**
4 **VESTMENT AND JOBS ACT OF ADDITIONAL**
5 **CAREY ACT PROJECTS FOR CERTAIN FUNDS.**

6 Section 40904(b) of the Infrastructure Investment
7 and Jobs Act (43 U.S.C. 3204(b)) is amended—

8 (1) in paragraph (3), by redesignating subpara-
9 graphs (A) through (C) as clauses (i) through (iii),
10 respectively, and indenting appropriately;

1 (2) by redesignating paragraphs (1) through
2 (4) as subparagraphs (A) through (D), respectively,
3 and indenting appropriately;

4 (3) in the matter preceding subparagraph (A)
5 (as so redesignated), by striking “The Secretary”
6 and inserting the following:

7 “(1) IN GENERAL.—The Secretary”; and

8 (4) by adding at the end the following:

9 “(2) ADDITIONAL PROJECTS.—

10 “(A) IN GENERAL.—On making the af-
11 firmative determinations described in subpara-
12 graph (B), the Secretary shall use amounts
13 made available under section 40901(2)(B) to
14 fund the rehabilitation, reconstruction, or re-
15 placement of any dams that were developed
16 pursuant to, and continue to operate as dams
17 under, section 4 of the Act of August 18, 1894
18 (commonly known as the ‘Carey Act’) (43
19 U.S.C. 641; 28 Stat. 422, chapter 301).

20 “(B) DETERMINATIONS DESCRIBED.—The
21 determinations referred to in subparagraph (A)
22 are—

23 “(i) a determination by the Secretary
24 that any dams that meet the criteria de-
25 scribed in paragraph (1) have received the

1 necessary funding to complete rehabilita-
2 tion, reconstruction, or replacement activi-
3 ties under this subsection; and

4 “(ii) a determination by the Secretary
5 that amounts made available under section
6 40901(2)(B) remain available.”.
