# A BILL

To provide for the imposition of sanctions on members of the National Communist Party Congress of the People's Republic of China, and for other purposes.

1       *Be it enacted by the Senate and House of Representa-*  
2   *tives of the United States of America in Congress assembled,*

3   **SECTION 1. SHORT TITLE.**

4       *This Act may be cited as the “Sanctioning Tyrannical*  
5   *and Oppressive People within the Chinese Communist*  
6   *Party Act” or the “STOP CCP Act”.*

7   **SEC. 2. FINDINGS.**

8       *Congress finds the following:*

9              *(1) The Hong Kong National Security Law pro-*  
10   *mulgated on July 1, 2020—*

11              *(A) contravenes the Basic Law of the Hong*  
12   *Kong Special Administrative Region that pro-*  
13   *vides in Article 23 that the Legislative Council*  
14   *of Hong Kong shall enact legislation related to*  
15   *national security;*

16              *(B) violates the People’s Republic of China’s*  
17   *commitments under international law, as de-*  
18   *fined by the Joint Declaration; and*

19              *(C) causes severe and irreparable damage to*  
20   *the “one country, two systems” principle and*  
21   *further erodes global confidence in the People’s*  
22   *Republic of China’s commitment to international*  
23   *law.*

24              *(2) Repression of ethnic Muslim minorities in*  
25   *the Xinjiang Uyghur Autonomous Region of the Peo-*

1       *ple's Republic of China has been ongoing, and was  
2 formalized with the "Strike Hard Campaign against  
3 Violent Terrorism" that began in 2014.*

4           *(3) The mass internment of Uyghur and other  
5 Muslim ethnic minorities in the Xinjiang Uyghur  
6 Autonomous Region has been ongoing since April  
7 2017.*

8           *(4) The People's Republic of China has con-  
9 ducted a targeted and systemic population-control  
10 campaign against ethnic and religious minorities in  
11 the Xinjiang Uyghur Autonomous Region by impos-  
12 ing and implementing coercive population-control  
13 practices, including selectively enforcing birth quotas,  
14 targeting minority women who are in noncompliance  
15 with birth quotas, and subjecting women to coercive  
16 measures such as forced birth control, forced steriliza-  
17 tion, and forced abortion.*

18           *(5) On October 6, 2020, 39 countries delivered a  
19 cross-regional joint statement to the United States  
20 Mission to the United Nations on the human rights  
21 abuses on Uyghurs and other minorities for forced  
22 birth control including sterilization.*

23           *(6) On January 19, 2021, the Department of  
24 State determined that the People's Republic of China  
25 committed crimes against humanity and genocide*

1       *against Uyghurs and other ethnic and religious mi-*  
2       *nority groups in the Xinjiang Uyghur Autonomous*  
3       *Region, citing forced sterilizations, forced abortions,*  
4       *coerced marriages, and separation of Uyghur children*  
5       *from their families.*

6           *(7) The Department of State's 2020 Country Re-*  
7       *ports on Human Rights Practices affirmed the geno-*  
8       *cide determination and noted coercive population*  
9       *control measures inflicted on ethnic and religious mi-*  
10       *nority women in China, including forced injections*  
11       *with "drugs that cause temporary or permanent end*  
12       *to their menstrual cycles and fertility".*

13          *(8) The United States ratified the United Na-*  
14       *tions Convention on the Prevention and Punishment*  
15       *of Genocide in 1988, recognizing that "imposing*  
16       *measures intended to prevent births within the group"*  
17       *with intent to destroy a group in whole or part is an*  
18       *act that constitutes genocide.*

19          *(9) Taiwan is a free and prosperous democracy*  
20       *of nearly 24,000,000 people and an important con-*  
21       *tributor to peace and stability around the world.*

22          *(10) Section 2(b) of the Taiwan Relations Act*  
23       *(Public Law 96-8; 22 U.S.C. 3301(b)) states that it*  
24       *is the policy of the United States—*

- 1                             (A) “to preserve and promote extensive,  
2                             close, and friendly commercial, cultural, and  
3                             other relations between the people of the United  
4                             States and the people on Taiwan, as well as the  
5                             people on the China mainland and all other peo-  
6                             ples of the Western Pacific area”;
- 7                             (B) “to declare that peace and stability in  
8                             the area are in the political, security, and eco-  
9                             nomic interests of the United States, and are  
10                             matters of international concern”;
- 11                             (C) “to make clear that the United States  
12                             decision to establish diplomatic relations with  
13                             the People’s Republic of China rests upon the ex-  
14                             pectation that the future of Taiwan will be deter-  
15                             mined by peaceful means”;
- 16                             (D) “to consider any effort to determine the  
17                             future of Taiwan by other than peaceful means,  
18                             including by boycotts or embargoes, a threat to  
19                             the peace and security of the Western Pacific  
20                             area and of grave concern to the United States”;
- 21                             (E) “to provide Taiwan with arms of a de-  
22                             fensive character”; and
- 23                             (F) “to maintain the capacity of the United  
24                             States to resist any resort to force or other forms  
25                             of coercion that would jeopardize the security, or

1           *the social or economic system, of the people on*  
2           *Taiwan”.*

3           *(11) Since the election of President Tsai Ing-wen*  
4           *as President of Taiwan in 2016, the Government of*  
5           *the People’s Republic of China has intensified its ef-*  
6           *forts to pressure Taiwan through diplomatic isolation*  
7           *and military provocations.*

8           *(12) The rapid modernization of the People’s*  
9           *Liberation Army and recent military maneuvers in*  
10          *and around the Taiwan Strait illustrate a clear*  
11          *threat to Taiwan’s security.*

12 **SEC. 3. SENSE OF CONGRESS.**

13          *It is the sense of Congress that members of the Chinese*  
14          *Communist Party, led by General Secretary Xi Jinping,*  
15          *are responsible for violations of Hong Kong’s autonomy, in-*  
16          *creased aggression against the people of Taiwan, numerous*  
17          *human rights violations against the people of Hong Kong*  
18          *and the people of Taiwan, and acts of repression and geno-*  
19          *cide against Uyghur Muslims in the Xinjiang Uyghur Au-*  
20          *tonomous Region.*

1   **SEC. 4. IMPOSITION OF SANCTIONS ON MEMBERS OF THE**  
2                   **CENTRAL COMMITTEE OF THE CHINESE COM-**  
3                   **MUNIST PARTY.**

4       (a) *IN GENERAL.—Not later than 30 days after the*  
5   *date of the enactment of this Act, the President shall impose*  
6   *the sanctions described in subsection (c) with respect to—*

7                   (1) *each person who is a member of the Central*  
8   *Committee of the Chinese Communist Party that the*  
9   *President determines engages in the conduct described*  
10   *in subsection (b);*

11                  (2) *each person who is a member of any suc-*  
12   *cessor organization of the Central Committee of the*  
13   *Chinese Communist Party that the President deter-*  
14   *mines engages in the conduct described in subsection*  
15   *(b), in the event that the Central Committee is dis-*  
16   *solved; and*

17                  (3) *each person who is an adult family member,*  
18   *including a spouse or an adult family member of the*  
19   *spouse, of a person described in paragraph (1) or*  
20   *paragraph (2).*

21       (b) *SANCTIONABLE CONDUCT.—A person engages in*  
22   *the conduct described by this subsection if the person plays*  
23   *a significant role in the development or implementation of*  
24   *government policies or laws that the President determines*  
25   *appear designed to—*

26                  (1) *violate the autonomy of Hong Kong;*

1                   (2) harass, intimidate, or result in increased ag-  
2 gression towards the people of Taiwan; or  
3                   (3) contribute to political oppression or violation  
4 of human rights of individuals or societal groups  
5 within the People's Republic of China, including  
6 Uyghur Muslims.

7                   (c) SANCTIONS DESCRIBED.—

8                   (1) IN GENERAL.—The sanctions described in  
9 this subsection are the following:

10                  (A) BLOCKING OF PROPERTY.—The Presi-  
11 dent shall exercise all of the powers granted to  
12 the President under the International Emergency  
13 Economic Powers Act (50 U.S.C. 1701 et seq.) to  
14 the extent necessary to block and prohibit all  
15 transactions in property and interests in prop-  
16 erty of the person if such property and interests  
17 in property are in the United States, come with-  
18 in the United States, or are or come within the  
19 possession or control of a United States person.

20                  (B) ALIENS INELIGIBLE FOR VISAS, ADMIS-  
21 SION, OR PAROLE.—

22                  (i) VISAS, ADMISSION, OR PAROLE.—  
23 An alien who the Secretary of State or the  
24 Secretary of Homeland Security (or a des-  
25 ignee of one of such Secretaries) knows, or

1           *has reason to believe, is described in sub-*  
2           *section (a) is—*

3                 *(I) inadmissible to the United*  
4                 *States;*

5                 *(II) ineligible to receive a visa or*  
6                 *other documentation to enter the*  
7                 *United States; and*

8                 *(III) otherwise ineligible to be ad-*  
9                 *mitted or paroled into the United*  
10                 *States or to receive any other benefit*  
11                 *under the Immigration and Nation-*  
12                 *ality Act (8 U.S.C. 1101 et seq.).*

13                 *(ii) CURRENT VISAS REVOKED.—*

14                 *(I) IN GENERAL.—The issuing*  
15                 *consular officer, the Secretary of State,*  
16                 *or the Secretary of Homeland Security*  
17                 *(or a designee of one of such Secre-*  
18                 *taries) shall, in accordance with sec-*  
19                 *tion 221(i) of the Immigration and*  
20                 *Nationality Act (8 U.S.C. 1201(i)), re-*  
21                 *voke any visa or other entry docu-*  
22                 *mentation issued to an alien described*  
23                 *in clause (i) regardless of when the*  
24                 *visa or other entry documentation is*  
25                 *issued.*

(II) EFFECT OF REVOCATION.—A revocation under subclause (I) shall take effect immediately and shall automatically cancel any other valid visa or entry documentation that is in the alien's possession.

## 7 (2) EXCEPTIONS.—

(B) EXCEPTION FOR INTELLIGENCE, LAW ENFORCEMENT, AND NATIONAL SECURITY ACTIVITIES.—Sanctions under paragraph (1) shall not apply to any authorized intelligence, law enforcement, or national security activities of the United States.

1       (d) *PENALTIES.*—*The penalties provided for in sub-*  
2 *sections (b) and (c) of section 206 of the International*  
3 *Emergency Economic Powers Act (50 U.S.C. 1705) shall*  
4 *apply to a person that violates, attempts to violate, con-*  
5 *spires to violate, or causes a violation of regulations pro-*  
6 *mulgated to carry out this section or the sanctions imposed*  
7 *pursuant to this section to the same extent that such pen-*  
8 *alties apply to a person that commits an unlawful act de-*  
9 *scribed in section 206(a) of that Act.*

10     (e) *IMPLEMENTATION AUTHORITY.*—*The President*  
11 *may exercise all authorities provided to the President under*  
12 *sections 203 and 205 of the International Emergency Eco-*  
13 *nomic Powers Act (50 U.S.C. 1702 and 1704) for purposes*  
14 *of carrying out this section.*

15     (f) *REGULATORY AUTHORITY.*—*The President shall,*  
16 *not later than 30 days after the date of the enactment of*  
17 *this Act, promulgate regulations as necessary for the imple-*  
18 *mentation of this section.*

19     (g) *WAIVER.*—*The President may, for one or more pe-*  
20 *riods of not more than 60 days each, waive the application*  
21 *of sanctions or restrictions imposed with respect to a foreign*  
22 *person under this section if the President certifies to the*  
23 *appropriate congressional committees, not later than 15*  
24 *days before such waiver takes effect, that the waiver is vital*  
25 *to the national security interests of the United States.*

1       (h) TERMINATION.—The President may terminate any  
2 sanctions imposed under subsection (a) not fewer than 15  
3 days after the date on which the President provides a writ-  
4 ten certification to the appropriate congressional commit-  
5 tees, and concurrently publishes on a publicly available  
6 website of the Federal Government, that—

7                 (1) the People's Republic of China and the Chi-  
8 nese Communist Party have—

9                         (A) ceased the genocide of the Uyghur Mus-  
10 lim population, including verifiably shutting  
11 down all internment camps of Uyghurs and end-  
12 ing the practice of facilitating or supporting  
13 Uyghur forced labor and forced sterilization;

14                         (B) ceased all forms of threats, military ex-  
15 ercises, and aggression toward Taiwan, includ-  
16 ing through verifiably, and for at least a period  
17 of one year, having not conducted any breach of  
18 Taiwan's air space, territorial waters, or land  
19 mass, by any military or intelligence personnel  
20 associated with the People's Republic of China or  
21 the Chinese Communist Party, or any agency or  
22 instrumentality thereof;

23                         (C) ceased the undermining of the auton-  
24 omy of Hong Kong, including through respecting  
25 the terms of the Sino-British Joint Declaration,

1           *and reversing all steps taken to interfere with the  
2           democratic process and governance of Hong  
3           Kong; and*

4           *(D) ceased efforts to steal the intellectual  
5           property of United States persons; or  
6           (2) the sanctioned person has—*

7           *(A) affirmatively renounced membership in  
8           the Chinese Communist Party; and*

9           *(B) taken affirmative steps to denounce or  
10          remediate the conduct forming the basis for im-  
11          position of the sanction.*

12        *(i) SUNSET OF WAIVER AND LICENSE AUTHORITY  
13 TIES.—The President's authority to issue waivers or li-  
14 censes with respect to sanctions required by subsection (a),  
15 including pursuant to sections 203 and 205 of the Inter-  
16 national Emergency Economic Powers Act (50 U.S.C. 1702  
17 and 1704), shall terminate on the date that is 2 years after  
18 the date of the enactment of this Act.*

19        *(j) APPROPRIATE CONGRESSIONAL COMMITTEES DEFINITION.—In this section, the term “appropriate congressional committees” means—*

22           *(1) the Committee on Foreign Affairs and the  
23           Committee on Financial Services of the House of Rep-  
24           resentatives; and*

1                   *(2) the Committee on Foreign Relations and the*  
2                   *Committee on Banking, Housing, and Urban Affairs*  
3                   *of the Senate.*
