A BILL

To amend the Hudson River Valley National Heritage Area Act of 1996 (Public Law 104–333; 54 U.S.C. 320101 note) to include all of Saratoga and Washington Counties in the boundaries of the Hudson River Valley National Heritage Area.

 2 *tives of the United States of America in Congress assembled,*

3 **SECTION 1. SHORT TITLE.**

4 *This Act may be cited as the “Maurice D. Hinchey*
 5 *Hudson River Valley National Heritage Area Enhancement*
 6 *Act”.*

7 **SEC. 2. DEFINITIONS.**

8 *In this Act:*

9 (1) *SECRETARY.*—*The term “Secretary” means*
 10 *the Secretary of the Interior.*

11 (2) *STATE.*—*The term “State” means the State*
 12 *of New York.*

13 (3) *STUDY AREA.*—*The term “study area” means*
 14 *Saratoga and Washington Counties in the State.*

15 **SEC. 3. HUDSON RIVER VALLEY NATIONAL HERITAGE AREA**
 16 **STUDY.**

17 *The Secretary, in consultation with State and local*
 18 *historic preservation officers, State and local historical soci-*
 19 *eties, State and local tourism offices, and other appropriate*
 20 *organizations and governmental agencies, shall carry out,*
 21 *in accordance with section 120103(a) of title 54, United*
 22 *States Code, a study to assess the suitability and feasibility*
 23 *of designating the study area as part of the Maurice D.*
 24 *Hinchey Hudson River Valley National Heritage Area es-*
 25 *tablished under the Hudson River Valley National Heritage*
